Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Compas, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Compas, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Communications Media, Inc. adopted the Communications Media, Inc. 401(k) Profit Sharing Plan effective January 1, 1996, subsequently renamed Compas 401(k) Profit Sharing Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan is a defined contribution multiple employer plan covering all eligible full-time and part-time employees of Compas, Inc. and Communications Media, Inc., the participating employers, as defined in the Plan document.

Contributions

Each year, participants may contribute from 1% to 100% of their annual base income, or a fixed dollar amount, up to the Internal Revenue Code's annual contribution limitations. Participants can make pre-tax or Roth contributions. Employees are automatically enrolled in the Plan at 3% after becoming eligible; an opt-out provision is available. Each participating employer may make a matching contribution, at its discretion and determined on a yearly basis, as defined. Each participating employer may also contribute a discretionary amount, which is allocated among each of its employee-participants based on each participant's compensation and classification group, as defined. The Company elected a discretionary matching contribution of 50% of an eligible employee's deferred salary reduction up to a maximum salary reduction amount equal to 6% of compensation during the Plan year. Participants may also contribute amounts representing distributions from other qualified plans.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer matching contributions, allocations of profit sharing contributions and plan income. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, qualified non-elective contributions and any rollover contributions and earnings thereon. Vesting in employer contributions and earnings thereon is based on years of credited service. A participant is 100% cliff vested, after three years of credited service or upon Normal Retirement Age, as defined.

Note 1: Description of Plan (Continued)

Forfeitures

Forfeitures of non-vested employer contributions may be used to reduce future employer contributions and to offset plan expenses. At December 31, 2024 and 2023, the Plan had \$500 and \$10,568, respectively, available for future use. During the year ended December 31, 2024, \$8,972 of forfeitures were used to pay for administrative expenses and \$9,373 of forfeitures were used to reduce the employer contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and a maximum equal to the lesser of 50% of their vested account balance or \$50,000. A maximum of two loans can be outstanding at any time. Loans must be repaid within a period not to exceed five years. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%.

Payment of Benefits

Upon termination of employment or termination due to death, disability or retirement, a participant (or participant's beneficiary in the event of death) could elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum payment or a direct rollover to another qualified retirement plan. Participants can also take an in-service withdrawal.

Plan Expenses

The Plan's administrative expenses are generally paid by the Company. Expenses paid by the Company are excluded from the financial statements. Certain administrative expenses incurred by the Custodian may be paid from the Plan's assets. Certain expenses incurred on loans, distributions for participants, and accounts for terminated participants are paid by the participant. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

Note 2: Summary of Significant Accounting Policies

The summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Notes to Financial Statements

Note 2: Summary of Significant Accounting Policies (Continued)

Basis of Accounting and Use of Estimates

The financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States (GAAP) requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net realized and unrealized gains and losses on investments are reported in the statement of changes in net assets available for benefits as net appreciation or depreciation in the fair value of investments. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus accrued interest. Interest is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Subsequent Events

The Plan has evaluated subsequent events through August 4, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

Accounting standards provide a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Note 3: Fair Value Measurements (Continued)

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund - Reliance Trust Company Stable Value Fund: Valued at fair value by determining the Plan's pro rata portion of the market value of the securities in the underlying separate accounts.

Note 4: Information Prepared and Certified by Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants, for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus Trust Company, the Custodian of the Plan.

Note 5: Party-in-Interest Transactions

Certain plan investments are managed by Ascensus Trust Company ("Ascensus"). Ascensus is the Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Kathmere Capital Management provides investment advisory services to the Plan, which qualify as party-in-interest transactions. Fees paid directly to Kathmere Capital Management for investment advisory services amounted to \$32,108 for the year ended December 31, 2024.

Note 5: Party-in-Interest Transactions (Continued)

The Vanguard Group, Inc. provides recordkeeping services, which also qualify as party-in-interest transactions. Direct fees paid by the Plan to Vanguard for recordkeeping services amounted to \$22,452 for the year ended December 31, 2024.

Participant loans also qualify as party-in-interest transactions which are exempt from the prohibited transactions rules of ERISA.

Note 6: Plan Termination

Although the Company has not expressed any intent to do so, the Company, and each participating employer, has the right under the Plan to discontinue its contributions at any time and to terminate its participation in the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their share of employer contributions and earnings thereon.

Note 7: Tax Status

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The plan administrator is not aware of any significant uncertain tax positions taken by the Plan.

Note 8: Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
