Independent Auditors' Report

To the Participants and Plan Administrator of
Transitions of Western Illinois, Inc. 403(b) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Transitions of Western Illinois, Inc. 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Transitions of Western Illinois, Inc. 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Notes to Financial Statements

1. Description of Plan

The following description of the Transitions of Western Illinois, Inc. 403(b) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Transitions of Western Illinois, Inc., except production employees, clients, and trainees. Employees are eligible to make elective deferrals upon the date their employment begins. Employees are eligible for employer matching and discretionary contributions after completing one year of service and reaching age eighteen. The Plan is subject to the provisions of ERISA.

Contributions

Each year, participants may contribute up to 100% of compensation, as defined in the Plan, by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified or 403(b) plans (rollover). Matching contributions are equal to 100% of each participant's salary deferral up to 4% of base pay (excluding bonuses, final vacation payout, sick overage pay, gain share, incentive pay, and taxable life insurance premiums paid on behalf of an employee). The Organization may also make a discretionary matching contribution to eligible participants. For the plan years ended December 31, 2024 and 2023, the Organization elected not to make a discretionary contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Organization's matching contributions and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings on the contributions. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is as follows:

Investment Options

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Organization's contributions into any of the offered investment options.

1. **Description of Plan** (continued)

Policy Loans

Under the plan document in effect through February 13, 2019, participants could borrow amounts directly from the Plan custodian (VALIC) using their participant accounts as collateral for the loan. Funds used as collateral were placed in a separate investment account. Policy loans are not treated as distributions from the Plan and are not considered Plan assets. Therefore, policy loans are not reported on the statements of net assets available for benefits. Loans more than forty-five days past due result in a taxable deemed distribution of the collateral. No policy loans have been issued after February 13, 2019 as a result of the change in plan custodian. VALIC continues to hold funds as collateral for outstanding policy loans. At December 31, 2024 and 2023, amounts held as collateral for policy loans which had not been deemed distributed totaled \$196 and \$193, respectively.

Notes Receivable from Participants

Under the current plan document, participants may borrow from their employee contributions and rollover contributions with interest charged at a rate equal to the "prime rate" plus 1%, which remains in effect for the duration of the loan. Loan terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence. The minimum loan is \$1,000 and the maximum loan is the lesser of \$50,000 or 50% of the participant's vested account balance in the Plan. The loans are secured by the balance in the participants' accounts. Principal and interest are paid ratably through ACH deduction from the participant's personal bank account. Participants may only have two loans outstanding at any time.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In addition, hardship withdrawals are allowed.

Forfeited Accounts

Forfeitures of the Company's contributions will reduce future contributions of the same type. Forfeited non-vested accounts totaled \$273 and \$254 at December 31, 2024 and 2023.

Plan Administration

During the year ended December 31, 2019, asset custodian and record keeper duties were transferred from The Variable Annuity Life Insurance Company (VALIC) to Lincoln Financial Group. VALIC continues to hold certain fixed account balances and loan collateral funds.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments are stated at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain of the Plan's administrative expenses are paid by the Organization. Other expenses such as adviser and recordkeeping fees are paid from plan assets and deducted from participant accounts in accordance with the plan document.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by The Variable Annuity Life Insurance Company and Lincoln Financial Group Trust Company (the custodians of the Plan). This information has not been audited by the Plan's independent auditors. The certified information at December 31, 2024 and 2023 and for the years then ended includes:

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Guaranteed Investment Contract with Insurance Company

The Plan holds traditional investment contracts. The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The value of the traditional investment contracts at December 31, 2024 and 2023 was \$1,056,509 and \$1,147,856, respectively.

5. **Guaranteed Investment Contract with Insurance Company** (continued)

With traditional investment contracts, the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers. The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 4% on the VALIC contract and 1% on the Lincoln Financial Group contract. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

6. **Plan Termination**

Although it has not expressed the intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. **Tax Status**

The Organization has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to change in value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and statements of changes in net assets available for benefits.

9. Related-Party Transactions and Party in Interest Transactions

Certain plan investments are fixed interest accounts managed by the custodians. Therefore, these transactions qualify as party in interest transactions. Fees paid by the plan to the custodians for administration services at December 31, 2024 and 2023 totaled \$32,468 and \$26,227, respectively.

Policy loans, for purposes of Form 5500, are treated the same as participant loans and presented on a separate line. However, these loans are between VALIC and the participant rather than the plan and the participant. Participant account funds are held as loan collateral and escrow and are plan assets until deemed distributed. These funds are invested in a fixed investment to protect the collateral and thus are presented in the financial statements as fixed interest investments.
