Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Oxford Healthcare Management, Inc. 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Oxford Healthcare Management, Inc. 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

NOTES TO THE FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of Oxford Healthcare Management, Inc. 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document and the summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) retirement plan available to all employees of Oxford Healthcare Management, Inc., Alcorn County LTC, LLC, Hattiesburg Health and Rehab Center, LLC, Kemper County LTC, Inc., Newton County LTC, LLC, Washington County LTC, Inc., Scott County LTC, Inc and Smith County LTC, LLC. (collectively, the “Company”) who are twenty-one years of age or older and have one year of service, as defined by the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to defer on a pre-tax basis any percentage of their annual eligible compensation subject to Internal Revenue Service (IRS) limitations. Participants over the age of fifty (50) before the end of the Plan year are eligible to make catch-up contributions. Participants may make tax deferred voluntary contributions or Roth (non tax-deferred) voluntary contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company may make discretionary matching contributions to the Plan in amounts determined annually by the Board of Directors. For the year ended December 31, 2024, the Company matched fifty percent (50%) of the first six (6%) of eligible compensation that a participant contributed to the Plan. The Plan also allows the Company to make discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions made for 2024.

Participant Accounts and Investment Options

The Plan allows participants to direct varying portions of their contributions and account balances among different investment options offered by Voya, which includes a fully benefit-responsive investment contract, mutual funds, and pooled separate accounts.

Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions, plan earnings, and administrative expenses. Allocations are based upon the participant’s eligible compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Payment of Benefits

Benefits are paid upon the attainment of normal retirement age 65 or upon termination of service, death, or disability. Benefits are paid in lump sums. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship, as defined by the plan document, or upon the attainment of age 59½.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at rate at 1% above the prime rate. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are vested immediately in their deferral contributions plus earnings and losses thereon. Participants vest in the Company's discretionary matching and profit-sharing contributions, if any, and related earnings or losses based upon years of service as follows:

Forfeitures

If an employee terminates before his or her discretionary matching and profit-sharing contribution accounts have become fully vested, such unvested portion of the account is forfeited. Participant forfeitures may be first used to pay administrative expenses of the plan and then may be used to reduce the Company's contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$15,691 and \$11,746, respectively. Forfeitures used to reduce the Company's contributions totaled \$7,270 for the year ended December 31, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Recordkeeping and other administrative fees are charged to participant accounts and are included in administrative expenses. Investment-related expenses are included in the net appreciation (depreciation) of fair value of investments. Additional fees are charged to participants based on their use of certain plan features.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan are reported on the accrual basis of accounting.

Investments are stated at fair market value (except for the fully benefit-responsive investment contract which is reported at contract value), as defined by generally accepted accounting principles. See Note 3 for disclosure of fair value measurement.

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Accordingly, actual results may differ from those estimates.

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Benefits are recorded when paid.

Date of Management's Review

The plan sponsor evaluated its December 31, 2024 financial statements for subsequent events through October 7, 2025, the date the financial statements were available to be issued. The plan sponsor is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

NOTE 3 – FAIR VALUE MEASUREMENTS

Generally accepted accounting principles establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023, except as noted below.

Pooled separate accounts: Valued at the number of accumulation units held by the Plan multiplied by the accumulation unit value (AUV). The AUV is first established when a new fund starts and is then determined daily based on the net asset value of shares of the underlying fund, the fund's dividends and the Contract's separate account charges.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value of investments in the pooled separate accounts has been estimated using the NAV of the investments. The pooled separate accounts are redeemed on a daily basis and do not have any redemption restrictions. Additionally, there were no unfunded commitments.

NOTE 4 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

Effective March 1, 2022, the Plan executed a fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer guarantees principal and a guaranteed minimum interest rate (“GMIR”) for the life of the contract. The account may credit interest at a current rate that may be higher than the GMIR, and the current rate may be changed at any time, except that it will not apply a decrease to the current rate following a rate change initiated solely prior to the last day of the three-month period measured from the first day of the month in which such change was effective. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for this investment. Contract value, as reported to the Plan by Voya Retirement Insurance and Annuity Company, represents contribution made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent upon the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events would limit the Plan’s ability to transact at contract value with Plan participants are probable of occurring.

NOTE 5 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amount reported in the statements of net assets available for benefits.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts and plan assets will be used solely to provide benefits for participants.

NOTE 7 – FEDERAL INCOME TAX STATUS

The IRS issued an opinion letter dated June 30, 2020 stating that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with CODA, which the Plan adopted on March 1, 2022, is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Company has not applied for a determination letter from the IRC regarding the qualification of the Plan as it applied to the Company; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with requirements of the IRC. Therefore, they believe that the Plan should qualify for tax-exempt status as of the financial statement date. The plan administrator believes that the Plan has not generated any taxable income and no federal or state income tax returns have been filed. Federal and state taxing authorities could request an examination of the financial records of the Plan to ascertain if any such taxable income exists, but no such examination has occurred or is pending.

NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company, the asset custodian as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. In addition, plan expenses that are paid directly by the plan sponsor also qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing rather than a direct payment. These transactions are exempt from the prohibited transactions provision of ERISA and the Internal Revenue Code. Certain fees paid directly to Voya Retirement Insurance and Annuity Company totaled \$26,103 in 2024 and \$27,805 in 2023. The Company pays directly any other fees related to the Plan's operations.

NOTE 9 – INFORMATION CERTIFIED BY ASSET CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, the asset custodian, have certified that the following data included in the accompanying financial statements and supplemental information is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments as shown in the schedule of assets (held at end of year) as of December 31, 2024.
- Notes receivable from participants as of December 31, 2024 and 2023.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental information.
