INDEPENDENT AUDITORS' REPORT

To the Trustees of
Synergy Enterprises 401(k) Employee Stock Ownership Plan

Opinion

We have audited the accompanying financial statements of Synergy Enterprises 401(k) Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Such information is the responsibility of plan management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023

1. DESCRIPTION OF PLAN

The following description of the Synergy Enterprises (the “Company”) 401(k) Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company except for leased employees, nonresident aliens who received no earned income as defined in the Internal Revenue Code (“IRC”), or employees who were members of a collective bargaining unit which has bargained separately for other retirement benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan is administered by certain officers (the “Trustees”) of the Company. Plan assets are invested in a trust fund which is administered under the terms of a trust agreement executed by the Trustees and the Company. There shall be one or more individual Trustees as determined from time to time by the Company.

The Plan acquired 193,235.53 shares of the Company’s common stock by issuing notes to former stockholders (the “Sellers”). The borrowings are to be repaid over a period of six to twelve and a half years with fully tax-deductible company contributions to the Plan. As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the IRC. In 2024, this resulted in 2,893.42 shares being released and allocated for the Plan. See Note 5 for further discussion.

The borrowings are collateralized by the unallocated shares of common stock and are guaranteed by the Company. The Sellers have no rights against shares of common stock once they are allocated to the participants. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to the accounts of participants with vested and non-vested rights in allocated stock (“allocated”) and stock not yet allocated to participants (“unallocated”).

Plan Amendments

Effective January 1, 2024, participants who terminate employment on the last day of the applicable period are considered employed for the purposes of satisfying the last day requirement. For the year ended December 31, 2023, the service hours and last day employment requirements were waived for participants who terminated employment due to attainment of Normal Retirement Age.

Effective January 1, 2024, the Plan was amended to revise the distribution provisions for ESOP and other plan accounts. Terminated participants (other than due to retirement, disability, or death) may now elect to begin distribution of their vested ESOP account no earlier than three months after termination, regardless of whether ESOP loans have been repaid. All ESOP distributions are now paid in cash only. For ESOP account balances invested in employer stock, distributions will be made in substantially equal annual (or more frequent) installments over:

- 5 years for balances over \$35,000 and under \$250,000,
- 7 years for balances of \$250,000 to under \$500,000, and
- 9 years for balances of \$500,000 or more.

The minimum account balance threshold for installment payouts was increased to \$35,000.

Effective July 1, 2024, the Plan was further amended to eliminate the minimum service requirement for elective deferrals and to remove all age restrictions for participation in elective deferrals, employer matching contributions, and profit-sharing contributions.

Eligibility

Employees of the Company are eligible to participate in the Plan after one year of service, providing they worked at least 1,000 hours of service during such Plan year. Eligible plan participants may begin making contributions as of the first day of January or July after meeting these requirements. Employees may begin making elective deferrals immediately with no minimum service requirement.

Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loans. See Note 5 for further discussion.

Each year, participants may contribute up to 75 percent of eligible compensation, as defined in the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may elect to make discretionary matching contributions and non-elective contributions to the Plan. The Company's non-elective contributions are allocated to participants based on compensation. For the year ended December 31, 2024, the Company made discretionary matching contributions of \$260,284 and non-elective contributions of \$756,578. Contributions are subject to IRS limitations.

Payment of Benefits

Distributions over \$5,000 on account of death, disability, or retirement are made in lump sum not later than the close of the Plan year following the event. Distributions over \$5,000 for other separations from service will be distributed in a lump sum payment. Participants' accounts other than the accounts invested in Company common stock will be distributed no earlier than three months following termination of employment. Participants' accounts invested in Company common stock will be distributed in accordance with the plan document, beginning no earlier than three months following termination of employment. A participant whose vested balance is less than \$5,000 is subject to mandatory cash out provisions as defined in the plan document.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate is set at one percent above the prime rate, as defined. Principal and interest are paid ratably through semi-monthly payroll deductions.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares of common stock allocated to his or her account and is notified by the Trustees prior to the time that such rights are to be exercised. The Trustees are not permitted to vote any allocated shares for which instructions have not been given by a participant. The Trustees are required, however, to vote any unallocated shares on behalf of the collective best interests of plan participants and beneficiaries.

Vesting

Participants are vested immediately in their elective and rollover contributions and plan earnings thereon. Vesting on the Company's discretionary matching and non-elective contributions is based on years of continuous service. After two years of service, participants vest 20 percent per year of service and are 100 percent vested after six years of service.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustees from the unallocated account and forfeitures of terminated participants' non-vested accounts. Each participants' account is also credited with allocations of the Company's contributions, participant contributions, and plan earnings and losses, and charged with withdrawals and expenses. The participants' benefit is equal to the vested balance of the participants' account.

Diversifications

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in the Company's common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

Put Option

Under federal income tax regulations, the Company's common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy shares of stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Forfeitures

The Plan requires forfeitures to be used to reduce employer contributions, allocate to plan participants, or pay plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts total \$23,303 and \$20,031, respectively. For the year ended December 31, 2024, forfeitures allocated to participants total \$5,088.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and became allocated generally in the period in which debt service is actually paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation in fair value of investments includes gain and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefits paid to participants and other administrative fees are charged directly to the participant's account and are included in administrative fees. Investment related expenses are included in net appreciation in fair value of investments.

Concentrations of Credit Risk

The Plan maintains cash in money market funds at a single financial institution. Accounts at the institution are insured by the Federal Deposit Insurance Corporation up to \$250,000. As of December 31, 2024 and 2023, there were no amounts at risk.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

Money market: Money market securities consist of funds held in bank deposit sweep programs through a brokerage account, valued at cost, which approximates fair value.

Company common stock: Valued at fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparable, and estimated fair value of company assets and liabilities. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution.

Registered investment companies: Investments in mutual funds are valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Life insurance contracts: Investments in insurance contracts are valued at surrender (discontinuance) value, which approximates fair value, because of their immediate availability or near-term maturities and are expected to approximate cost.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the uses of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. LOANS PAYABLE

The Plan has entered into multiple term loan agreements with the "Sellers. The proceeds of the loans were used to purchase Company common stock. Unallocated shares of common stock are collateral for the loans. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares times the ratio of the current year payments, divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 2,893.42 shares being released and allocated for the plan year ended December 31, 2024.

The agreements provide for the loans to be repaid over six to twelve and half years. The fair value of the loans payable as of December 31, 2024 and 2023, was \$166,256 and \$345,082, respectively, determined by using interest rates currently available for issuance of debt with similar terms, maturity dates, and nonperformance risk. The loans bear fixed rates of interest ranging from 3.87 percent to 4.00 percent. The scheduled amortization of the loans for the next five years and thereafter is as follows:

6. PLAN TERMINATION

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Although the Company has not expressed any intent to terminate the Plan, it may do so at any time. If the Plan is terminated, the Trustees shall distribute all property then constituting the trust assets, less any amount constituting charges against the trust assets, including any outstanding loans and expenses, in such a manner and at such time as may be directed by the Trustees. The participants in the plan would become 100 percent vested in their employer contribution upon plan termination.

7. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. These are related party and party in interest transactions which are exempt from the prohibited transaction rules. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

The Trustees have granted the Plan's investment advisor, Taylor Stephens, Inc., discretion of investment and reinvestment of Plan funds. The custodian, Fidelity Brokerage Services, LLC, holds the Plan's investment assets and executes investment transactions. The third-party administrator, Pension Planning Consultants, provides administrative and compliance services to the Plan. Fees incurred by the Plan for the investment management services, administrative and compliance, and custodial services are included in net appreciation in fair value of investments and administrative expenses.

The Plan is subject to an annual audit and appraisal in order to remain in compliance with ERISA regulations. HM&M Group, LLC is the plan auditor and George Valuation Advisors is the plan appraiser and, therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Fees incurred by the Plan for the audit and appraisal are included in net appreciation in fair value of investments and administrative expenses.

8. TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, plan management and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require that plan management evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks as well as valuation assumptions based on earnings and cash flows. Due to the level of risk associated with certain investment securities and to uncertainties inherent to the estimations and assumptions process, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

10. SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued and determined there no items to disclose.
