We have performed audits of the financial statements of Railworks Corporation Incentive Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). 1. Description of the Plan

The following brief description of RailWorks Corporation Incentive Plan (the Plan) is provided only for general information purposes. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of RailWorks Corporation (the Company) who have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participants may enter the Plan immediately upon meeting the eligibility requirements discussed above.

Fidelity Management Trust Company (Fidelity) is the trustee of the Plan and holds the Plan's investment assets and executes investment transactions.

Participant Contributions

Participants may contribute up to 75% of their pretax annual compensation to the Plan up to the maximum allowable under Internal Revenue Code (IRC) Section 402(g). Effective December 31, 2009, all eligible employees, unless affirmatively electing otherwise, are automatically enrolled in the Plan for the higher of the participant's selection or 3% of their compensation. In addition, each participant, having automatic enrollment contributions made on his or her behalf, shall have the deferral increased annually by 1%, limited to 10% of compensation. Participants may opt out of the automatic contribution and elect to make lower or higher deferral contributions up to the maximum allowable amount. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer Contributions

The Plan includes a qualified automatic contribution arrangement. For the year ended December 31, 2024, all participants receive a match equals to 100% of their first 2% of deferrals and 50% of the next of their 4% of deferrals. For the year ended December 31, 2023, the match equals to 100% of their first 1% of deferrals and 50% of their next 5% of deferrals. Starting in 2024, the Plan also adds a discretionary match at 50% of 2% of employee's deferrals.

The Plan also includes a non-elective discretionary employer contribution. This contribution is allocated to participant accounts based on the ratio of each eligible participant's compensation to total eligible compensation for the period. The Company did not make a non-elective discretionary contribution for the years ended December 31, 2024 and 2023.

For the Plan years ended December 31, 2024 and 2023, the Company made a matching contribution in the amount of \$4,174,727 and \$2,965,287, respectively.

Participant Accounts

Each participant's account is credited with the participant's own contributions, an allocation of any Company contributions, and an allocation of the Plan's earnings. Allocation of Company contributions is based on compensation and the amount of each participant's contributions. The

Plan's earnings are allocated based on the participant's earnings, balances of participant accounts, and specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrolling in the Plan, a participant may direct the investment of his or her account into any of the investment options offered by the Plan. Participants may change their investment options daily.

Notes Receivable from Participants

The Plan allows participants to borrow from their individual accounts in the Plan. These loans are limited to the lesser of \$50,000 or 50% of the participant's vested account balance with a minimum loan of \$1,000. Loans are repaid through payroll deductions over periods of up to five years. Loans for the purchase of a principal residence may be repaid over ten years. The interest rate is determined by the Plan administrator based on prevailing market conditions and is fixed over the life of the loan.

During 2024 and 2023, distributions totaling \$51,716 and \$14,800, respectively, were used to satisfy Plan loan defaults, which have been included in benefits paid to participants and beneficiaries in the accompanying statements of changes in net assets available for benefits.

Vesting

Participants are immediately vested in their rollover contributions and employee pre-tax contributions, plus actual earnings thereon. Vesting in the remainder of their accounts plus actual earnings thereon is based on years of continuous service. The match contribution is vested 20% after one year of service, and upon completion of two years of service, it is 100% vested. The discretionary match contributions is vested 25% after one year of service, and upon completion of four years of service, it is 100% vested. The non-elective discretionary employer contribution is 100% vested after five years of credited service, starting at 20% after one year, with an additional 20% for each year of service thereafter.

Forfeited Accounts

Forfeitures are used to reduce future employer contributions or pay administrative expenses. During the years ended December 31, 2024 and 2023, forfeiture amounts used to reduce the employer matching contributions or pay administrative expenses were \$226,091 and \$129,645, respectively. At December 31, 2024 and 2023, there were unallocated forfeitures of \$2,912 and \$97,126, respectively.

Payment of Benefits

Upon retirement, death, disability, or termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. Provided the balance is greater than \$5,000, participants may elect payment in the form of a lump-sum distribution, installment distribution, or a combination of the lump-sum and installment distributions. If the value is greater than \$1,000 but less than \$5,000, an automatic Individual Retirement Account (IRA) rollover of the vested account balance will be made; if the value is less than \$1,000, a lump-sum distribution will be made to the participant, unless otherwise directed.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, as further discussed in Note 5. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Transaction fees, such as distribution, withdrawal, and investment buying or selling fees, are paid by the Plan and charged directly to the participants. Investment fees are presented net of investment gains and losses on the statements of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and the disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in their accounts.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1), and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

The Plan had no financial assets that were measured at fair value on a nonrecurring basis or Plan liabilities recorded at fair value at December 31, 2024 or 2023.

Mutual Funds - These assets are valued at the unadjusted quoted market price, which represents the net asset value (NAV) of shares held by the Plan at year-end.

Common/Collective Trust - Unit value is calculated based on the net assets of the underlying securities of the common/collective trust. The NAV, as provided by Fidelity, is used as a practical expedient to estimate fair value. The underlying securities in the common/collective trust include various debt securities and securities that are listed on national securities exchanges and valued on the basis of year-end closing prices. The investments in the common/collective trust are redeemable at NAV on a daily basis. Qualifying participant-directed withdrawals are permitted such as (i) death, disability, retirement, termination from employment, divorce, hardship or, other permitted or mandatory in-service withdrawal, or for the issuance of a participant loan if such benefits are to be paid from the Plan's assets funding the benefit, or (ii) for the purpose of transferring assets to a Non-Competing Investment Option made available within the Plan. There are no unfunded commitments.

6. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Fidelity. Participant loan and distribution processing fees are paid to Fidelity by participants. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

7. Tax Status

The Plan sponsor adopted the Volume Submitter Profit Sharing Plan with Cash or Deferred Arrangement (CODA). Accordingly, the Plan is permitted to rely on the Fidelity opinion letter. The Internal Revenue Service (IRS) has determined and informed Fidelity, by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the IRC. Plans that adopt prototype documents are no longer required to file for an individual determination letter. Although the Plan has been amended from the original prototype document, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

Effective June 1, 2025, the Plan has been amended to include reimbursements or other expense allowances, fringe benefits, moving expense and differential wages as eligible compensation for employee deferral contributions.

Subsequent events have been evaluated through October 9, 2025, the date the financial statements were available to be issued. There were no other subsequent events requiring adjustments or additional disclosure to the financial statements.
