## **Independent Auditor's Report**

To the Board of Trustees  
Resource Systems Group, Inc. Employee Stock Ownership Plan

### **Opinion**

We have audited the financial statements of the Resource Systems Group, Inc. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal-control-related matters that we identified during the audit.

## **Other Matter - Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule, Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from, and relates directly to, the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note 1. Description of Plan

The following brief description of the Resource Systems Group, Inc. Employee Stock Ownership Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General:** Resource Systems Group, Inc. (the Company or the Plan Sponsor) established the Resource Systems Group, Inc. Employee Stock Ownership Plan (the Plan) effective September 1, 1989 and amended effective January 1, 2021. The Plan operates in relevant part as an Employee Stock Ownership Plan (ESOP); is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC); and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by the Company.

Employees of the Company are eligible to participate in the Plan after six months of service and the completion of 1,000 hours of service during the Plan year. Participants must be employed on the last day of a Plan year to be eligible for an allocation of Company contributions for such year.

**Contributions:** Contributions to the Plan are determined by the Company's board of directors. Contributions may be made in cash or shares of the Resource Systems Group, Inc. common stock, as determined by the board of directors. Contributions and eligible compensation are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with allocations of (a) the Company's contributions, (b) Plan earnings or losses, and (c) any forfeitures. Allocations of Company contributions and forfeitures are based on the participant's eligible compensation relative to total eligible compensation, as defined. Plan earnings or losses are allocated based on the participant's balance, before the allocation of contributions and forfeitures, relative to the total account balances. Once a participant has completed 10 years of service and reached age 55, he or she will have the right to direct 25% of the investment portion of his or her account attributable to Company stock. This diversification option continues for five years, and in the sixth year, a participant may diversify 50% of the investment portion of his or her account attributable to Company stock.

**Forfeitures:** Forfeitures allocated to participants were \$54 in cash and 89 shares of common stock in 2024.

**Vesting:** Vesting in each participant's account is based on years of service. Participants who entered the Plan on or after January 1, 2022 are 100% vested after three years of credited service. Active participants in the Plan as of December 31, 2021 are 20% vested after two years and 100% vested after three years of credited service. Prior to December 31, 2021, participants were 20% vested after two years of credited service, increasing 20% per year, with 100% vesting after six years of credited service. Participants automatically become fully vested upon disability, death, normal retirement at age 65, or early retirement at age 55 (if hired prior to January 1, 2015) while employed by the Company.

**Payment of benefits:** No distributions from the Plan will be made until a participant retires, becomes disabled, dies (in which case payment shall be made to his or her beneficiary or, if none, his or her legal representative), or otherwise terminates employment with the Company. Distributions are made in substantially equal annual installments over a period of three years. Hardship withdrawals may be requested in certain circumstances as defined by the Plan. If a participant's vested account balance is \$10,000 or less, the participant will receive a lump-sum distribution by the end of the following Plan year subsequent to termination. If the vested account balance is more than \$10,000, the participant will receive three annual installments commencing in the following Plan year subsequent to termination.

**Voting rights:** Each participant is entitled to exercise voting rights, as defined by the Plan, attributable to the shares allocated to his or her account.

**Put option:** Under federal income tax regulations, Company common stock that is held by the Plan and not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Termination:** The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the Plan will become 100% vested and will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) using the accrual basis of accounting.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the valuation advisors and trustees. See Note 3 for a discussion of fair value measurements.

Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Expenses of the Plan:** Administrative expenses of the Plan shall be payable from the Plan at the direction of the Plan Administrator. The Company shall have the option, but not the obligation, to pay any such expenses, in whole or in part, and, by doing so, to relieve the Plan from the obligation of bearing such expenses. Administrative expenses of the Plan are currently paid by the Company.

**Payment of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and uncertainties:** Plan investments consist of Company common stock, which is exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with the investment in Company common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of Company common stock will occur in the near term, and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Subsequent events:** Plan management has evaluated subsequent events through October 12, 2025, the date the financial statements were available to be issued.

#### Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

**Level 1:** Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

**Level 2:** Observable market-based inputs or observable inputs that are corroborated by market data.

**Level 3:** Unobservable inputs for assets or liabilities that are not corroborated by market data.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no significant changes in the methodology used in the current or prior year.

**Common stock:** Valued based on an annual independent valuation, which is a Level 3 investment.

#### Note 4. Concentration of Credit Risk

The Plan currently has substantially all of its assets invested in the common stock of the Plan Sponsor.

#### Note 5. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company, by a letter dated December 16, 2015, that the Plan and the trust established under the Plan are tax-exempt under the appropriate sections of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan and the trust are operating in a manner that does not jeopardize this tax status.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 6. Related-Party Transactions

ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. The Plan invests in Company common stock. The Company pays the Plan's administrative expenses, as described in Note 2.
