NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Parsons, Behle & Latimer Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was originally established in 1969 to provide retirement benefits for eligible employees of Parsons, Behle & Latimer, a professional corporation (“Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan is a defined contribution plan. Any employee of the Plan Sponsor is eligible to participate on the first day of the month coinciding with or next following the date on which the employee has completed two years of service with the Plan Sponsor with a minimum of 1,000 hours of service per year.

Administration of the Plan is performed by the Plan Sponsor. Fidelity Management Trust Company (“Fidelity”) serves as the current trustee and custodian of the Plan. Fidelity Workplace Services, LLC is the third-party Plan recordkeeper.

Employer Contributions

The Plan Sponsor determines the level of contribution to the Plan based on the following factors: the Plan Sponsor’s profit for the year and the total compensation paid to all participants. Each year the Plan Sponsor determines the amount to contribute to the Plan. This contribution is discretionary. Any contribution amount not received by the Plan at year end is shown as a receivable.

Participant Accounts

Each participant’s account is credited with allocations of (a) the Plan Sponsor’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

A participant is immediately vested in Plan Sponsor contributions plus earnings thereon.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum payment or annuity-based payments equal to the value of their vested account balance. For termination of service, effective January 1, 2024, a participant with a vested account balance of \$7,000 or less is required to receive a lump-sum distribution of their vested interest. Those participants with balances in excess of \$7,000 may elect to defer the receipt of this vested account balance until age 62.

Administrative Expenses

Commissions and investment related expenses are deducted proportionately from participants’ accounts and are included in net appreciation of fair value of investments. Certain administrative expenses are paid directly by the Plan Sponsor and are excluded from these financial statements, other than expenses incurred by participants for distributions or who elect to trade securities within the brokerage option account. These expenses are deducted from the participants account at the time the expense is incurred and reported as an administrative expense in the financial statements.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits to participants are recorded upon distribution.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan has adopted Financial Accounting Standards Board Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements*, for all financial assets and liabilities disclosed at fair value in the financial statements on a recurring basis. ASC 820 provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology, including the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Registered investment companies - valued at the account's daily net asset value ("NAV") of shares held by the Plan at year end as reported by the fund. Registered investment companies are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV.

Brokerage account - a participant brokerage account allows an investor to buy or sell investments such as stocks, bonds and mutual funds. The fair value of the brokerage account is the aggregation of the fair value of the underlying assets, all of which are actively traded. The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - FIDELITY BROKERAGE OPTION

The Fidelity Brokerage Option ("FBO") is an investment service provided by Fidelity that provide participants with an expanded number of investment options. Participants who participate in the FBO can direct their assets into stocks listed on the major United States exchanges, bonds and other fund income investments, exchange traded funds, and mutual funds from various fund companies. Any underlying investments held in the FBO category (i.e., registered investment companies) represent a variety of different investment

options that must be purchased through the FBO service. These registered investment companies are valued at the NAV of the securities held in the funds and, therefore, have been included with the investments measured at NAV in the fair value table above. Any investments in the FBO that trade on an active market (i.e., stock, government securities, corporate debt instruments, etc.) are leveled within the fair value hierarchy as Level 1 investments.

NOTE E - RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the Plan trustee, therefore, these transactions qualify as party-in-interest transactions.

The Plan Sponsor has been designated as the Plan administrator. Certain administrative expenses, including audit and legal fees, were paid by the Plan administrator in 2024.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE G - TAX STATUS

The Plan adopted the Fidelity Non-Standardized Pre-Approved Profit Sharing Plan ("Pre-approved Plan") as amended, effective March 9, 2021. The Pre-approved Plan obtained an opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, regarding its acceptability under Section 401 of the Internal Revenue Code ("IRC"). The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
