NOTE 1 - DESCRIPTION OF THE TRUST

The Southwest Marine Welfare Trust (the "Trust") is a multi-employer benefit plan providing medical, surgical, hospital, dental, vision, life insurance and accidental death and dismemberment (AD&D) benefits to eligible participants, beneficiaries and their dependents. The Trust covers employees of companies that are signatory to applicable collective bargaining agreements and make contributions to the Trust to fund benefits. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The disbursements of the funds are under joint control of employer and union trustees.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accounts of the Trust are maintained on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Employer Contributions

Employer contributions as reported are contributions made by employers on behalf of employees for hours worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for estimated uncollectible accounts.

The contribution rate effective September 1, 2022 is \$1,800 per active member, per work month.

D. Employer Payroll Compliance Program

Employer remittance reports were accepted as submitted, without examination or verification of the employers' payroll records. The Trust's system of internal control provides for examination of employer records under a separate payroll compliance program.

E. Cash and Cash Equivalents

Cash and cash equivalents include a checking and brokerage cash account.

F. Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

F. Fair Value Measurements (Continued)

Level 1 – Inputs are quoted prices for identical instruments in an active market.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Level 2 investments consist of certificates of deposit valued using third party pricing vendors.

G. Tax-Exempt Status

No provision for federal or state income tax is made. The Trust has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Trust and recognize a tax liability if the Trust has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Trust is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 - ADMINISTRATION

Benefit Programs Administration provides administrative services for a monthly fee of \$1,850. Effective July 2024, the fee increased to \$1,905 per month.

NOTE 4 - PRIORITIES UPON TERMINATION

Except as may be otherwise provided by law, in the event of termination, the agreement and declaration of trust provides that any and all monies remaining in the Trust after payment of all expenses and obligations of the Trust shall be expended and used for the continuance of purposes of the Trust, until such monies are exhausted.

NOTE 6 - ESTIMATED OBLIGATION FOR FUTURE BENEFITS

Estimated future benefits based on participants' accumulated eligibility is based upon the number of equivalent eligibility months in the hour bank at December 31, multiplied by the estimated monthly per capita cost. The estimate was based on 3 months of eligibility at a rate of \$1,484.95 at December 31, 2024 and 68 months of eligibility at a rate of \$1,528.30 at December 31, 2023.

NOTE 7 - RISKS AND UNCERTAINTIES

Trust investments are exposed to various risks such as interest rates, market fluctuations and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

NOTE 8 - SUBSEQUENT EVENTS

The Board of Trustees has evaluated subsequent events through October 3, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
