Basis for Opinion

Note 1 – Plan Description and Basis of Presentation

The following description of the Hazard Construction Company Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was adopted in 2016 and is a defined benefit 401(k) profit sharing plan covering all eligible employees of Hazard Construction Company (the “Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Hazard Construction Company is the Plan’s sponsor and serves as Plan administrator.

Eligibility – Employees of the Company are eligible to participate in the Plan upon reaching age 18 and after completing one month of service. Participants, once eligible, may begin deferring a portion of their compensation into the Plan on the first day of the month following the satisfaction of eligibility requirements. For employer prevailing wage contributions, employees are eligible to participate upon hire.

Contributions – Participants – Participants can contribute up to 100% of their eligible salaries in 2024, not to exceed \$23,000. Participants ages 50 or older may elect to defer additional amounts (“catch-up” contributions) to the Plan. The maximum catch-up contribution that could be made in 2024 was \$7,500. The additional amount can be deferred regardless of any other limitations on the amounts that can be contributed to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“rollover”).

Employer – The Company may make a discretionary matching contribution, subject to certain Internal Revenue Service limitations. Employees working on a prevailing wage contract receive contributions that help satisfy the fringe benefit requirements or prevailing wage law. Employee receives an allocation based upon eligible compensation as defined in the Plan Agreement. During the year ended December 31, 2024, the Company made discretionary matching contributions and prevailing wage contributions of approximately \$277,000 and \$1,565,000, respectively.

The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless affirmatively elect not to participate in the Plan.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, prevailing wage contributions, and allocations of the Company’s contributions and plan earnings, and is charged with an allocation of administrative expense. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions and related investment activity thereon. Additionally, participants are 100% vested in the prevailing wage contributions made by the Company. Participants vest in Company’s matching contributions in annual ratable installments of 20% after the first year of service until fully vested after five years of service. Participants are fully vested in the event of death, disability, or attaining normal or early retirement age (age 65 and 55, respectively).

Note 1 – Plan Description and Basis of Presentation (Continued)

Forfeitures – If a participant terminates prior to vesting 100% in the employer contributions, the forfeited balance will be used to reduce future employer contributions or administrative expenses. For the year ended December 31, 2024, employer contributions were reduced from forfeited non-vested accounts by \$570. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$23,068 and \$11,207, respectively.

Payment of Benefits – The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, disability, death, financial hardship, or termination of employment. In-service distributions are also available to those participants who incurred a financial hardship as defined in the Plan agreement or are age 59 1/2 or older. Participants who qualify for retirement benefits and withdrawals will receive their benefits as a lump sum in cash, installment payments, or partial distributions. The benefit to which a participant is entitled is the benefit that can be provided solely from the participant's vested account balance. Participants who separate from service and have vested account balances of \$5,000 or less are subject to an administrative lump sum distribution.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan repayment terms shall be no greater than five years (or such longer period as permitted by law) except when loan proceeds are used for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at variable rates. At December 31, 2024, all outstanding loans had an interest rate ranging from 5.25% to 10.50%. Principal and interest are paid over the term of the loan through payroll deductions.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of the fair value of investments.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements are prepared on the modified basis of accounting, whereby the financial statements reflect only cash receipts and disbursements. Therefore, receivables and payables which would be recognized under the accounting principles generally accepted in the United States of America and which may be material in amount are not recognized in the accompanying financial statements.

Use of Estimates – The preparation of financial statements in accordance with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results may differ from those estimates.

Note 2 – Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value. The Plan’s trustees, Empower Trust Company, LLC and MassMutual, certifies the fair value of all investments. If available, quoted market prices are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion on the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits – Benefits are recorded when paid.

Risk and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 3 – Information Certified by the Trustees

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and MassMutual (the trustees of the Plan).

Note 4 – Fair Value Measurements

The accounting standards regarding fair value measurements define fair value, establish a framework for measuring fair value, and provide for enhanced disclosures about fair value measurements. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

Level 1 Valuation is based upon quoted prices in active markets for identical securities.

Level 2 Valuation is based upon other observable inputs (including quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.).

Level 3 Valuation is based upon unobservable inputs significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds

These are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts

These investments are privately managed accounts valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. As the investments can be redeemed at NAV as of the measurement date, the administrator of the fund believes the investments have a "Readily Determinable Fair Value".

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Guaranteed Investment Contract

In November 2015, the Plan entered into a fully benefit responsive investment contract (“FBRIC”) with MassMutual. MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the FBRIC criteria and is therefore reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5 – Related Party Transactions

Certain Plan investments are managed by Empower and MassMutual. Empower and MassMutual are the trustees of the Plan and, therefore, transactions with these entities qualify as exempt party-in-interest transactions. Transactions involving participant loans also qualify as party-in-interest transactions.

Note 6 – Plan Termination

Although the Company has expressed no intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, amounts allocated to a participant's account shall immediately become fully vested.

Note 7 – Tax Status

The Plan has adopted the volume submitter profit sharing plan. The Plan obtained its latest opinion letter from the Internal Revenue Service dated November 14, 2022, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
