### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pacific Healthcare Group LLC 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge and belief.

### Opinion

## 1. Description of Plan

The following description of the Pacific Healthcare Group LLC 401(k) Retirement Savings Plan (the Plan), formerly known as Ito Healthcare Group 401(k) Retirement Savings Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### a. General

The Plan is a defined contribution plan created on September 1, 2014 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan provides retirement benefits to eligible employees of PC Care Corp., Pediahealth Corp., OCF Partners, and Community Case Management Corp. (CCMC) (collectively, the Company). Effective January 1, 2022, Malama Adult Day Care, LLC was removed as a participating covered company.

On March 23, 2022, PC Care Corp., Pediahealth Corp., OCF Partners, and Malama Adult Day Care, LLC entered into an agreement with an unrelated third-party to sell its properties and equipment. The sale was completed on February 1, 2023, at which time sponsorship of the Plan was transferred to Pacific Healthcare Group LLC and the name of the Plan was changed to Pacific Healthcare Group LLC 401(k) Retirement Savings Plan. Effective February 1, 2023, Pacific Healthcare Group LLC was appointed as trustee of the Plan. Further, effective February 1, 2023, PC Care Corp., Pediahealth Corp., OCF Partners, and CCMC were removed as participating covered companies and PSH Pearl City LLC, PSH KM LLC, PSH Oahu LLC, and Pacific Healthcare Group LLC were approved as participating covered companies under the Plan.

In March 2023, CCMC entered into a spin-off agreement with an unrelated third-party in which all active CCMC employees were transferred out of the Plan and into the Altres 401(k) Retirement Plan.

The Plan's custodian is Transamerica Life Insurance Company (Transamerica).

### b. Eligibility

Employees become eligible for participation on January 1 or July 1 following the attainment of age 21 and completion of one year of service during which at least 1,000 hours of service were performed. Employees who meet these eligibility requirements are also eligible for discretionary matching contributions.

### c. Contributions

Participants may elect to defer up to 100 percent of their annual compensation, subject to certain limitations defined by the Internal Revenue Code (the Code). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may make matching contributions at the discretion of the Administrative Committee (the Committee). During 2024, the Company made a discretionary matching contribution of 25 percent of the first five percent of compensation contributed to the Plan. Employer matching contributions are calculated and paid each pay period.

The Company may make discretionary profit-sharing contributions. No profit-sharing contributions were approved for the year ended December 31, 2024.

### d. Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's matching contribution, and an allocation of plan earnings and expenses. Earnings and expenses from the Plan's investments are allocated to participants' accounts in proportion to the balances of such accounts, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### e. Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. A participant is 100 percent vested in the Company's discretionary matching contributions, plus actual earnings thereon, after two years of credited service, as defined, or upon death, permanent disability or attainment of normal retirement age, as defined.

### f. Notes Receivable from Participants

Participants may borrow from their accounts the lesser of 50 percent of their vested interest or \$50,000. Loans are secured by the balance in the participant's account, bear interest at rates ranging from 4.25 to 9.50 percent as of December 31, 2024, and are to be repaid over a reasonable period of time not to exceed five years, unless used to acquire a primary residence. Participant loans are due at various dates through July 2029. Principal and interest are paid ratably at least quarterly through payroll deductions.

### g. Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum distribution equal to the value of his or her vested account.

### h. Forfeitures

Upon termination of employment, participants forfeit their nonvested balances. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions or pay the expenses of the Plan. There were no significant unallocated forfeiture account balances as of December 31, 2024 and 2023.

## 2. Summary of Significant Accounting Policies

### a. Basis of Accounting

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### b. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### c. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan.

### d. Management's Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### e. Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Employer contributions are based on the same compensation.

### f. Payment of Benefits

Benefits paid to participants are recorded upon distribution.

### g. Administrative Expenses

Expenses incurred in the administration of the Plan are paid by the Plan or the Plan's sponsor, as provided in the Plan document.

### h. Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued, and it was determined that all subsequent events had been properly accounted for.

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate to the best of their knowledge and belief by Transamerica, a qualified institution.

For the year ended December 31, 2024, Transamerica also certified to the completeness and accuracy of net investment income of \$1,420,896 and interest on notes receivable from participants of \$18,631, related to the aforementioned assets.

### 4. Fair Value Measurements

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; and inputs that are derived principally from or can be corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* valued using the net asset value (NAV) of units held by the Plan at year end as provided by Transamerica. The NAV is based on the fair value of the underlying investments. The NAV is not a public-quoted price in an active market. As of December 31, 2024 and 2023, there are no unfunded commitments related to the pooled separate accounts. Also, the pooled separate accounts may be redeemed on a daily basis with no redemption restrictions.

*Group Annuity Contract:* contract value is the relevant measurement attribute for that portion of the net assets available for benefits because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract. The investment contract is an unallocated group annuity contract issued by Transamerica. Interest is credited to the deposits on a daily basis with no set maturity. As such, fair value is contract value less any adjustment with respect to the creditworthiness of the issuer (see Note 5).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no restrictions on transfers out of the funds.

## 5. Group Annuity Contract

The Plan invests in the Stable Value Core Option with Transamerica. Deposits made to the Stable Value Core Option are deposited in Transamerica's general account. Payment obligations under the Stable Value Core Option represent an insurance claim supported by all the general assets. Guarantees of principal are based on the claims paying ability of Transamerica and not the value of the securities within the insurer's general account. The credit rating of the insurer at December 31, 2024 was A1 as reported by Moody's Investors Service. Expenses related to the Stable Value Core Option are calculated by Transamerica and incorporated in the Stable Value Core Option crediting rate.

Under the group annuity contract that supports this product, participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance at contract value within reasonable time frames. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract is effected directly between the Plan and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Given these provisions, the Plan considers this contract to be benefit responsive.

The average yield earned by the Plan and credited to participants was 1.58% and 1.18% for the years ended December 31, 2024 and 2023, respectively. No adjustment is required to mediate between the average earnings credited to the Plan and the average earnings credited to the participants. The same crediting interest rate is applied to the entire contract value and is reviewed on at least a semi-annual basis for resetting. The factors considered in establishing the crediting interest rate include current economic and market conditions, the general interest rate environment and both actual and expected experience of a reference portfolio within the general account. There is no guaranteed minimum interest rate.

Only an event causing liquidity constraints at the custodian could limit the ability of the Plan to transact at contract value. There are no events that allow the issuer to terminate the contract and which require the Plan sponsor to settle at an amount different than contract value.

## 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants affected by the termination shall become fully vested.

## 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## 8. Tax Status

The non-standardized pre-approved profit sharing plan adopted by the Company received a favorable tax opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan Administrator and tax counsel believe that the Plan is currently designed and being operated in compliance with the qualification requirements of the Code and that the Plan continues to be tax-exempt. Hawaii income tax law conforms to the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Plan years from December 31, 2021 are open for examination for federal tax purposes; however, there are currently no audits in progress for any tax periods. Administration errors, if any, which are insignificant or operational in nature are handled by the Plan Administrator in accordance with applicable IRS correction policies.
