INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator, Management, and the 401(k) Committee
ATRO Companies Profit Sharing/401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ATRO Companies Profit Sharing/401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the ATRO Companies Profit Sharing/401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan with profit sharing provisions, designed to provide retirement benefits for eligible employees of Astronics Corporation and its subsidiaries (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Board of Directors is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

Effective January 1, 2023, the Peco, Inc. 401(k) Profit Sharing Plan was merged into the Plan. The total fair value of the net assets transferred into the Plan as a result of this merger was \$14,566,866.

Eligibility: All non-excludable employees of the Company are eligible to become contributing participants in the Plan immediately upon hire. All non-excludable employees of the Company are also eligible for the employer matching contributions, employer profit sharing contributions and employer nonelective safe harbor contributions immediately upon hire.

Contributions: Each year, participants may contribute up to 100% of pretax or after-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions to any of the Plan's investment fund options offered by the Plan, other than Company stock which is purchased with employer contributions only. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan in the month following the period a participant meets the eligibility requirements under the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan also allows for automatic increase of deferrals every July 1st, of 1% of up to a maximum of 10%. Contributions are subject to certain IRS limitations.

The Company provides safe harbor non-elective contributions for all eligible employees equal to 3% of the employee's compensation for the plan year (the "safe harbor contribution"). Employees receive the contribution either in cash or invested in the company stock fund. Safe harbor non-elective contributions were \$5,523,278 for the year ending December 31, 2024 (\$5,106,591 - 2023).

The Plan allowed for a discretionary employer profit sharing contribution to be determined by the Company annually. For the year ended December 31, 2024, the Plan provided a discretionary contribution of 2% of the employee's compensation. Employer profit-sharing contributions for the year ended December 31, 2024 amounted to \$3,397,504. There were no employer profit sharing contributions for the year ended December 31, 2023.

Rollover Contributions: Participants may contribute in amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts: Each participant's account is credited with the participant's contributions and Company matching contribution, as well as allocations of the Company's profit-sharing contribution, forfeitures, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are 100% vested in all contributions immediately upon entering the plan.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at and bear interest at rates that are commensurate with local prevailing interest rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Upon retirement, death, permanent disability, or termination of employment, participants' interest in the Plan is distributed to them or their designated beneficiaries under various alternatives in accordance with the Plan. Account balances in excess of \$1,000 but less than or equal to \$5,000 may be rolled into an individual retirement account provided the participant does not timely elect another form of distribution. Hardship withdrawals for immediate and heavy financial needs, as defined in the Plan, are available to participants while currently employed. Under certain circumstances, participants may also take allowable in-service withdrawals.

Forfeited Accounts: Forfeited accounts may be used to pay administrative expenses for the Plan or to reduce future employer contributions. During the year ended December 31, 2024, the Plan used forfeitures in the amount of \$258,913 (\$297,158 – 2023) to reduce future employer contributions and administrative expenses.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded in the loan balance account when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments: Benefit payments are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are not included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: These financial statements have not been updated for subsequent events occurring after September 23, 2025, which is the date these financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of Registered Investment Companies: These investments are public investment vehicles valued using the Net Asset Value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Company Stock: The Company's stock is valued at the closing price reported by the active market on which the security is traded. The Company's stock is classified within Level 1 of the valuation hierarchy.

Money Market Fund: These investments are public investment vehicles that attempt to maintain a NAV of \$1 per share. The money market funds are classified within Level 2 of the valuation hierarchy.

NOTE 4. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of registered investment companies, company stock fund, and money market fund managed by an affiliate of Vanguard Fiduciary Trust Company ("VFTC"). VFTC acts as trustee for only those investments as defined by the Plan. Transactions such as interest income from notes receivable, and investment gains qualify as allowable party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are also considered party-in-interest and included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than as a direct payment. The Company pays directly any other fees related to the Plan's operations.

NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6. TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by VFTC. The prototype plan has received an opinion letter from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
