NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the MedStar Health, Inc. Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants receive the Summary Plan Description. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Employees are eligible to participate for salary reduction purposes and rollover contribution purposes on their date of hire with a participating employer. For purposes of the employer discretionary matching contribution and employer discretionary contribution, an employee becomes eligible on the first day of the month coincident with or next following attainment of age 21 and completion of one year of service. Employees who are covered under a collective bargaining agreement are not eligible employees unless the collective bargaining agreement or the Plan provides for participation in the Plan.

Contributions

Participants may contribute up to 75% of their pretax annual eligible compensation, subject to amounts permitted under the Internal Revenue Code (IRC).

Under the Plan's employer discretionary match, the Plan sponsor's Board of Directors determines each year whether or not to make a contribution. An employee who makes salary reduction contributions is eligible to receive an employer discretionary match equal to 50% of his/her salary reduction contributions, up to a maximum of 6% of eligible compensation. The employee must have completed 1,000 hours of service during the plan year and must be employed on the last day of the plan year to be eligible for the employer discretionary match. There was an employer discretionary match for the 2024 plan year of \$60,516,724.

Under the Plan's employer discretionary contribution, the Plan Sponsor's Board of Directors determines each year whether or not to make a contribution. An employer discretionary contribution shall not be more than 2% of each participant's eligible compensation for each participant who is credited with at least 1,000 hours of service during the plan year and is employed on the last day of the plan year. For those participants with 11 or more years of credited service the employer discretionary contribution shall not be more than 3%. There were no employer discretionary contributions for the 2024 plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) employer's contributions and (b) plan earnings based on each employee's investments, and it is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the vested portion of the participant's account. Participants are immediately vested in their contributions and actual earnings thereon. Participants become 100% vested in all employer contributions and earnings thereon after three years of service or upon death, disability or retirement at or after normal retirement age (age 65).

Forfeitures

Non-vested accounts for terminated participants are forfeited according to the Plan provisions. Forfeitures under the Plan may be used to pay plan expenses or used to reduce future employer contributions. At December 31, 2024 and 2023, there was \$434,716 and \$571,717, respectively, in the forfeiture account. In 2024, employer contributions were reduced by \$500,342 from forfeited non-vested accounts.

Benefit Payments

Participants or their beneficiaries are eligible for distributions upon retirement, termination, disability, or death. Forms of distribution include lump sum, annuity, or monthly installments over a fixed period of 5, 10, or 15 years. Participants may also make in-service withdrawals if she/he has attained age 59½ or if she/he requests a hardship withdrawal. Terminated participants may also defer payment of Required Minimum Distributions until age 73.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested participant account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the vested participant account balance and bear interest at a rate commensurate with current rates charged by local commercial lenders. Loan repayments are made through payroll deductions and are applied to participant accounts. A participant may only have one outstanding loan at a time.

Self-Directed Brokerage Account Fees

The Self-Directed Brokerage account option allows a participant to establish a brokerage account, which provides the opportunity to select from various mutual funds. There is a \$50 annual account fee charged to participants for any open Self-Directed Brokerage accounts, deducted from the participant's core account balance. The investment options available through Brokerage account have associated fees.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Plan Management, Investment Valuation and Income Recognition

Effective April 1, 2022, Great-West Life & Annuity Insurance Company (GWLA), formerly known as Great-West, the parent company of Empower Retirement, LLC (Empower) acquired the full-service retirement business of Prudential Financial, Inc. In connection with the transaction, GWLA acquired all shares of Prudential Retirement Insurance and Annuity Company, which is no longer affiliated with Prudential Financial, Inc. The acquisition resulted in a transfer of assets and a brief blackout period.

Effective March 31, 2023, Prudential merged into Empower. This merger did not have a material impact to plan participants and had no impact on the financial statements. Following an initial transition period, Empower became the custodian and recordkeeper of the Plan. Empower Trust Company, LLC and Empower Annuity Insurance Company are the Plan's custodians.

The Plan's investments are stated at fair value, except for fully benefit responsive investment contracts (Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in mutual funds are based on quoted market information. Securities traded on national securities exchanges are valued at the last reported sales price on the last business day of the plan year. Investments traded in the over-the-counter market and listed securities for which no sale was reported on that date are valued at the average of the last reported bid and asked prices.

Net appreciation in fair value of investments is reflected in the statements of changes in net assets available for benefits and includes gains and losses on investments bought and sold as well as held during the period. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Administrative Expenses

Administrative expenses associated with the Plan are allocated to and paid by the plan participants. The allocation is based on each participating employer's number of plan participants at the time of the quarterly allocation. Total administrative expenses were \$1,302,000 for the year ended December 31, 2024.

Use of Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY CUSTODIANS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, the Plan Administrator has obtained certifications from Prudential Bank & Trust, FSB, and Empower Trust Company, LLC that all information relating to the Plan's investments and related investment income is complete and accurate.

Information related to the investments at fair and contract value in the trust managed by the trustee, net investment income, notes receivable from participants and related interest income, and all information in the supplemental schedule is presented in reliance solely upon the certifications. The Plan's investments are summarized in Note 4.

NOTE 4 - FAIR VALUE MEASUREMENT OF INVESTMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes methods used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 - Quoted prices in active markets for identical assets or liabilities at the measurement date.
- Level 2 - Observable inputs other than quoted prices for the asset, either directly or indirectly observable, that reflect assumptions market participants would use to price the asset based on market data obtained from sources independent of the Plan.
- Level 3 - Unobservable inputs that reflect the Plan's own assumptions about the assumptions market participants would use to price an asset based on the best information available in the circumstances.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Investments whose fair value has been estimated using NAV, or equivalent, as a practical expedient are stated separately, if applicable.

The following table presents the Plan's assets at fair value, which are classified as Level 1, as of December 31, 2024 and 2023.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan has traditional fully benefit-responsive investment contracts (FBRIC) issued by Principal and Prudential. Investments, at contract value, at December 31, 2024 and 2023 were as follows:

Principal and Prudential maintain the Plan contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fully benefit-responsive investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The issuers provide a fixed return on principal over a specified period of time backed by assets in the issuers' general accounts. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal and Prudential, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuers' ability to meet its financial obligations. The issuers' ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuers. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of any of the investment contracts. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events might allow the issuers to terminate the investment contracts with the Plan and settle at amounts different from respective contract values. Such events include (1) a breach of material obligation under the investment contracts and (2) a material misrepresentation.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Plan invested in an FBRIC managed by Prudential Global Investment Management (PGIM). The self-directed brokerage accounts have funds managed by PGIM. Prudential was the custodian of the Plan until October 2023. Empower became the custodian of the Plan beginning in October 2023; therefore, these transactions, in addition to notes receivable, qualify as party-in-interest transactions.

Principal is the custodian of the MedStar GIBC, therefore the MedStar GIBC qualifies as a party-in-interest transaction.

NOTE 7 - TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken by the Plan.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, the participants will become 100% vested in their accounts.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Medstar and what the plaintiff has identified as the "MedStar Health Retirement Savings Plan Committee" were named as defendants in a purported class action lawsuit filed on July 6, 2020 in the U.S. District Court for Maryland. MedStar, the Board of Directors of MedStar Health, Inc., and the Pension and Benefits Committee were also named as defendants in a second purported class action lawsuit filed in the U.S. District Court for Maryland on August 4, 2020. Both complaints alleged that the defendants breached their ERISA fiduciary duties by selecting and retaining high-cost and underperforming investments in the MedStar Health, Inc. Retirement Savings Plan instead of other available and more prudent alternative investments and were consolidated into one case. Final settlement was approved by the Court on September 5, 2024, and all claims have since been paid.

NOTE 10 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued and determined that there were no other items to disclose.
