### **Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The San Diego UNITE - HERE Health Fund (the "Plan") is a multiemployer welfare benefit plan that provides hospital-medical, vision, prescription, life, death and accidental death and dismemberment benefits to active employees and their dependents, and dental care to active employees; and makes available hospital-medical, prescription and dental care benefits to retired employees and their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Active employees of participating employers on whose behalf the employer is required to contribute to the Plan are eligible for those benefits specified in their collective bargaining agreements. Dependents of eligible active employees are also eligible to receive benefits. Retired employees covered under the Plan eligibility rules for retired employees and their dependents are eligible for limited benefits under the Plan on a self-pay basis.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements are maintained on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the management to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**C. Contributions**

Employer contributions as reported are contributions made by employers on behalf of employees for hours worked during the year. Employer contributions for non-bargaining unit employees are paid in accordance with applicable participation agreements. Employer contributions receivable is based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

**D. Payroll Compliance Program**

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' payroll records under a separate payroll compliance program.

**E. Eligibility**

A participant whose employer contributes based on hourly contributions becomes eligible on the first day of the third month following three consecutive months in which he or she has at least 270 hours reported and paid by a contributing employer.

**E. Eligibility (Continued)**

A participant whose employer contributes based on monthly contributions becomes eligible on the first day of the second month following the first monthly contribution paid by a contributing employer.

An eligible retiree is 55 years of age or older, has been eligible for health benefits under the Plan for 12 of the 24 months immediately preceding the date of retirement, and has been approved to receive benefits from the San Diego UNITE - HERE Pension Fund or has qualified as an eligible participant under the Plan for a total of 120 months and was eligible for health benefits under the Plan for at least one year immediately prior to the date of retirement.

Eligible retirees may obtain benefits through self-payment of a monthly contribution. The contribution has been calculated to cover the cost of providing benefits for these retirees. Rates vary depending on which benefits the retiree chooses and the age of the retiree. For the years ended December 31, 2024 and 2023, there were no retirees and one retiree participating in the Plan, respectively.

**F. Benefits**

Benefit obligations are segregated on the statements of benefit obligations based on estimates at the end of the year of unpaid premiums for coverage during the year (Premiums Payable); claims incurred during the year, reported but unpaid (Claims Payable); claims incurred during the year but not reported nor paid (Estimated Claims Incurred But Not Reported); future benefit costs expected to be incurred based on participants' accumulated eligibility credits (Estimated Future Benefits Based on Participants' Accumulated Eligibility); and accumulated bank hour eligibility.

**G. Accumulated Bank Hour Eligibility**

A participant whose employer contributes on an hourly basis is allowed to accumulate a maximum of ninety (90) hours to provide for future eligibility. A participant who has less than ninety (90) hours reported in a given month may draw on his or her hour bank to maintain eligibility for that month. If a participant's employment terminates, coverage will end on the last day of the month following the month in which employment is terminated and his or her hour bank will be forfeited.

**H. Tax-Exempt Status**

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i. The Plan has since been amended. The Plan administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority.

**H. Tax-Exempt Status (Continued)**

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**I. Investment Valuation and Income Recognition**

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Realized and unrealized appreciation or depreciation in the fair value of investments is reported as net appreciation of investments. Form 5500 reporting, realized and unrealized gains and losses are computed based on investments' market values as of the beginning of the year.

**J. Plan Termination**

Upon the termination of the Plan, the Plan shall pay all obligations of the Plan and apply the remaining assets in such manner as will best effectuate the purpose of the Plan.

**K. Risks and Uncertainties**

Benefit obligations are reported based on certain assumptions pertaining to health care inflation rates and participant demographics which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect the amounts reported in the financial statements.

**L. Fixed Assets**

Fixed assets are stated at cost. Depreciation and amortization are determined for related groups of assets by the straight-line method, based on their estimated useful lives. Estimated useful lives of the assets range from 3 to 30 years. Minor renewals or replacements and maintenance repairs are expensed. Major improvements are capitalized.

**M. Administrative Fees**

BeneSys, Inc. provides administrative services to the Plan for a monthly fee of \$53,906.

The Plan maintains cash accounts at Union Bank. Cash balances are insured by the Federal Deposit Insurance Corporation up to \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan did not incur any losses on the uninsured balances.
