## Independent Auditor's Report

To the Trustees of

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of LifeCare Assurance Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of January 10, 2025, and December 31, 2024, and the related statement of changes in net assets available for benefits for the period ended January 10, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of LifeCare Assurance Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 10, 2025, and December 31, 2024, and for the period ended January 10, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

As further disclosed in Note 1 to the accompanying financial statements, the Plan transitioned to a pooled employer plan (“PEP”) structure during the reporting period. Effective January 10, 2025, all participant accounts and balances were transferred into the PEP.

## 1. Description of the Plan

The following description of LifeCare Assurance Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### *General*

The Plan was established on January 1, 1996 to provide voluntary retirement benefits and tax-deferred savings opportunities to eligible employees, as defined in the Plan, of LifeCare Assurance Company (the "Company" and "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Certain administrative functions are performed by officers and employees of the Company. The assets of the Plan are held in a trust by Empower Trust Company ("Trustee"). Empower Annuity Insurance Company of America is the Plan's record-keeper.

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement 2.0 Act ("Secure 2.0 Act") was passed by Congress. The Secure 2.0 Act contains numerous provisions that impact employee benefit plans. Generally, the deadline for formally adopting any required plan amendments made pursuant to the Secure 2.0 Act is December 31, 2026; however, plans must be operated in accordance with the effective dates of each new provision. The Plan has administratively complied with and adopted all applicable provisions of the Secure 2.0 Act.

### *Transition to Pooled Employer Plan*

Effective November 1, 2024, the Plan Sponsor elected to transition the Plan into a pooled employer plan ("PEP") structure. The Plan is now participating in the PEP, which is administered by Standard Retirement Services, Inc. ("Standard"), a registered pooled plan provider. As a result of this transition, the Plan Sponsor is no longer the sole named fiduciary or plan administrator. Standard has assumed responsibility for the administrative functions and fiduciary oversight of the PEP, as defined in the governing plan documents.

As part of this transition, a blackout period was implemented beginning January 3, 2025, and ending January 27, 2025, during which participants were temporarily restricted from directing investment changes, transferring assets among investment options, initiating a loan and requesting a distribution.

As of January 10, 2025, all participant accounts and balances were transferred into the PEP. There were no changes to participant eligibility, vesting schedules, or investment options at the time of transition unless otherwise communicated to participants.

Outlined below is the description of the Plan prior to its transition to PEP.

### *Eligibility*

Employees of the Company are eligible to participate in the Plan after turning 18 and having completed three months of service. Participants may join the Plan on the first day of the Plan quarter upon meeting the eligibility requirements.

Under the terms of the Plan, eligible employees may elect to defer any amount of their annual compensation limited to a maximum annual amount specified by the Internal Revenue Service (“IRS”) (\$23,500 for employees under age 50 and \$31,000 for employees ages 50 and over in 2025). Deferrals may be made on a pre-tax and/or after-tax (Roth 401(k)) basis through salary deductions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Employer matching contributions are at the sole discretion of the Company. The Company may also make nonelective or discretionary contributions. There were no matching, non-elective or discretionary contributions for the period ended January 10, 2025.

### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution, including the earnings and losses on these contributions, and an allocation of the Company’s matching and profit-sharing contribution. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### *Investment Options*

The Plan provides a variety of investment options with differing risk and growth characteristics. Participants may change their investment allocations and/or transfer their account balances among the various funds at any time.

### *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as excess contributions owed to participants. As of January 10, 2025, the Plan had \$0 in excess contributions payable. As of December 31, 2024, the Plan had \$20,148 recorded as excess contributions payable.

### *Notes Receivable from Participants*

A participant is allowed to borrow a maximum of 50% of the vested account balance up to \$50,000. A participant may have no more than one loan outstanding at any one time. The minimum loan is \$1,000. Loans must be repaid within five years (unless the loan is for the purchase of a primary residence). All loans must be adequately secured and accrue interest at the current prime rate plus 2%. Principal and interest are paid ratably through payroll deductions. The unpaid balance of any loan is immediately payable upon termination of employment and maybe offset against the participant’s vested account.

## 1. Description of the Plan (Continued)

### *Vesting*

A participant is fully vested immediately as to voluntary contributions, rollovers and related earnings. Vesting in the Company's contributions plus earnings thereon is based on years of continuous service in accordance with the following schedule:

Participants also become fully vested in the Company's contributions at their normal retirement age of 65, upon retirement due to disability, upon death, and upon termination of the Plan.

### *Benefits*

Benefits under the Plan begin when a participant retires, becomes disabled, dies or ceases to be an employee, whichever applies. Normal retirement age is the later of age 65 or the fifth anniversary of participation in the Plan. Hardship withdrawals are permitted.

## 2. Summary of Significant Accounting Policies

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual basis of accounting.

### *Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

### *Payment of Benefits*

Generally, benefits are recorded when paid.

### *Forfeitures*

Forfeitures of terminated participants' non-vested accounts are applied to reduce Company contributions and pay Plan's expenses. In January 2025, as a result of the Plan's transfer to PEP, any available forfeitures were returned to the Company. Plan assets as of January 10, 2025, and December 31, 2024, included \$0 and \$15,794 of forfeited funds available for future use, respectively.

## 2. Summary of Significant Accounting Policies (Continued)

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Sponsor deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment adviser, custodian, and insurance company. In accordance with the Plan's policy of stating investment at fair value, net unrealized gains and losses for the year are included in the accompanying statement of changes in net assets available for benefits. Purchases and sales of securities are recorded on a trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gain and losses on investments bought and sold, as well as unrealized gains and losses on investments held during the year.

### *Expenses*

All expenses incurred in maintaining the Plan are paid using the Plan's assets, unless the Company, at its discretion, elects to pay certain expenses. These expenses include fees of the Plan's custodian and third-party administrators. The expenses of maintaining the Plan paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in the fair value of investments. Administrative expenses for the period ended January 10, 2025, were \$190.

## 3. Information Prepared and Certified by the Trustee

The Plan Sponsor has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, investments December 31, 2024, and investment income for the period ended January 10, 2025, that are disclosed in the accompanying financial statements, were obtained or derived from information supplied to the Plan Sponsor and certified as complete and accurate by the Trustee of the Plan.

## 4. Fair Value Measurements

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

## 4. Fair Value Measurements (Continued)

The Plan maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the following fair value measurement.

- Level 1: quoted prices in active markets for identical assets or liabilities;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following is a description of the valuation methodologies used for financial instruments measured at fair value:

- Pooled separate accounts: units held in pooled separate accounts are valued using net asset value ("NAV") as a practical expedient, provided by the administrator of the fund, based on the valuation of the underlying investments.

## 5. Investment Contracts with Insurance Company

The Plan offers the guaranteed long-term fund, which is a traditional fully benefit-responsive group annuity contract. Empower Annuity Insurance Company of America maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Certain events may allow for investments to settle at an amount different from contract value. The events include layoffs of Plan participants, early retirement windows, spin-offs, sale of a division, facility closings, full or partial Plan terminations and changes in laws or regulations. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investments contracts is also dependent on the third-party issuer's ability to meet its financial obligations.

## 5. Investment Contracts with Insurance Company (Continued)

The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that also would limit the ability of the Plan to transact at contract value with the participants.

## 6. Partial Plan Termination

During the plan year ended December 31, 2024, the Plan experienced a significant reduction in participating employees as a result of involuntary terminations due to the Company's restructuring. Based on an analysis of the number of participating employees terminated during the year, and in accordance with applicable IRS guidance, it was determined that a partial plan termination occurred.

As required by the IRS, all affected participants who were terminated during the period of the partial plan termination became 100% vested in their account balances, regardless of the Plan's vesting schedule. Management has reviewed the vesting of impacted participants and confirmed that all applicable account balances have been fully vested. As of December 31, 2024, \$2,648 of previously forfeited amounts were reinstated and paid out to terminated participants in accordance with plan provisions, and \$4,804 were pending to be reinstated and paid, which is shown as a partial plan termination liability on the face of the financial statements.

## 7. Related Party and Party-In-Interest Transactions

The Plan engages in transactions involving acquisition or disposition of units in funds managed by the record-keeper or the Trustee and its affiliates. These transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

The Plan allows participants to borrow from their vested balances. These transactions qualify as party-in-interest transactions and are exempt from prohibited transaction rules under ERISA.

## 8. Tax Status

The Plan adopted a prototype volume submitter profit sharing plan with cash or deferred arrangement that received tax exempt status from the IRS on June 30, 2020. Although the Plan has since been amended, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability or (asset) if the plan takes a position that is more likely than not to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefit and the statement of changes in net assets available for benefits.

## 11. Subsequent Events

Management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued. Other than items disclosed elsewhere in these financial statements, there were no other material subsequent events that required recognition or additional disclosures in these financial statements.
