**(1) Description of Plan**

The following description of the Jas. W. Glover Holding Company, Ltd. Profit-Sharing and 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan which covers substantially all employees of Jas. W. Glover Holding Company, Ltd. and subsidiaries (collectively known as the Company) who have completed the lesser of six months of service (during which time the employee performs at least 500 hours of service) or one year of service (during which time the employee performs at least 1,000 hours of service). Employees of the Company that are credited with an hour of service on a Davis-Bacon project are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

***Administration of Plan Assets***

In addition to the Company administering the Plan, Empower Trust Company, LLC (Empower), the custodian holds investment assets and executes investment transactions. All expenses incurred in the administration of the Plan are paid by the Plan to the extent not paid by the Company.

***Contributions***

Eligible participants may make pre-tax elective deferral or roth-elective deferral contributions to the Plan from a minimum of 1% to a maximum of 100% of compensation, up to a maximum allowable under the Internal Revenue Code (IRC). Such contributions are non-forfeitable and are credited to the individual account of the participant. Participants who attain age 50 before the close of the year are allowed to make additional pre-tax catch-up contributions to the Plan, not to exceed the amount allowable under current income tax regulations, which amounted to \$7,500 in 2024. Additionally, participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a common/collective trust fund as investment options for participants.

The Company makes a Davis-Bacon contribution on behalf of each participant for each hour worked on a Davis-Bacon project during the Plan year. The Company also makes a safe-harbor profit-sharing contribution to the Plan in the amount of three percent of compensation for the Plan year. In addition, the Company may make matching contributions and may also make a discretionary profit-sharing contribution to the Plan from its earnings and profits.

Notes to Financial Statements

***Participant Accounts***

Each participant's account is credited with the participant's contributions, safe-harbor and employer matching contributions, and allocations of (a) the Company's discretionary profit-sharing contribution, if any, and (b) plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their account balances attributed to their salary deferrals, rollover contributions, Davis-Bacon, safe-harbor, and matching contributions, plus actual earnings or losses thereon. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts plus actual earnings or losses thereon is based on years of continuous service.

***Payment of Benefits***

Upon termination of service, retirement, permanent disability, or death, a participant may elect to receive either a lump-sum distribution or transfer the account to another plan. However, if a participant's vested interest in his or her account is \$5,000 or less, the participant's vested interest may be distributed in a lump sum as soon as practicable after termination of employment. Benefit payments made upon termination are based on the value of the participant's vested interest in his or her account. Additionally, under certain circumstances of financial hardship, a participant is allowed to withdraw funds from the Plan.

***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions set forth in ERISA. In the event of termination of the Plan, the rights of all employees to benefits accrued to the date of such termination are fully vested and non-forfeitable.

**(2) Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in the accordance with accounting principles generally accepted in the United States of America (GAAP).

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the Plan Custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. See Note 4 for discussion of fair value measurements.

Realized and unrealized appreciation (depreciation) in the fair value of investments is based on the difference between the fair value of assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

***Payment of Benefits***

Benefits are recorded when paid.

**(3) Information Certified by the Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value presented in the statements of net assets available for benefits at December 31, 2024 and 2023, except assets held in the suspense account (see Note 7).
- Investment income including net appreciation in fair value of investments and dividend and interest income, for the year ended December 31, 2024, presented in the statement of changes in net assets available for benefits, except investment income earned from assets held in the suspense account.
- All information presented in the supplemental schedule of assets (held at end of year) as of December 31, 2024, except assets held in the suspense account.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

**(4) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the accounting guidance are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds.* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund.* The fund seeks high current income with liquidity and stability of principal. The carrying amount of the fund is equivalent to its fair value due to the short-term nature of the fund.

*Common/collective trust fund.* The primary investment objective of the fund is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments while maintaining sufficient liquidity. The fair value of this fund is valued at NAV as reported by the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investment held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The collective trust provides for daily redemptions by the Plan at reported NAV per share, with no advance notification requirement. There are no unfunded commitments associated with this fund.

The preceding measurements described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

**(5) Tax Status**

The Plan is based on the non-standardized pre-approved profit sharing plan with CODA sponsored by Cades Schutte A LLLP LLP (Cades Schutte). The Internal Revenue Service (IRS) informed Cades Schutte by a letter dated June 30, 2020, that the non-standardized pre-approved profit sharing plan with CODA upon which the Plan is based is designed in accordance with the provisions of the IRC. The Plan has subsequently been amended; however, in the opinion of the plan administrator, the Plan is currently being operated in compliance with the applicable requirements of the IRC and thus qualifies the Plan for tax-exempt status.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(6) Related Party Transactions and Party-in-Interest Transactions**

Empower is the recordkeeper and custodian of the Plan. Therefore, transactions between Empower and the Plan qualify as party-in-interest transactions. Total administrative expenses incurred by the Plan to Empower amounted to approximately \$30,000 for the year ended December 31, 2024.

**(7) Transfer of Funds from the Defined Benefit Plan**

In connection with the 2024 termination of the Jas. W. Glover Holding Company, Ltd. Defined Benefit Pension Plan (the defined benefit plan), the Plan is intended to serve as a qualified replacement plan within the meaning of section 4980(d) of the IRC. As such, the Plan established a suspense account and the plan sponsor transferred \$1,630,543 of reversionary excess defined benefit plan assets into the suspense account. Monies available in the suspense account will be allocated to participant accounts to fund safe harbor contributions ratably over seven years. During 2025, \$232,983 from the suspense account was used to fund 2024 safe harbor contributions.

**(8) Subsequent Events**

The Plan's management has evaluated subsequent events through September 24, 2025, the date at which the accompanying financial statements were available to be issued, and determined there are no other items to disclose.
