Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tanner LLC Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1. PLAN DESCRIPTION

The following description of Tanner LLC Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Tanner LLC (the Employer or Company) who are at least 21 years of age. Employees may begin participation in salary deferral contributions upon satisfying the age requirement. Participation in Company safe harbor and profit sharing contributions can begin at the beginning of the next month after an employee completes three months of service. The Plan excludes employees who are covered by collective bargaining agreements, leased employees, and nonresident aliens.

The Plan is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). Additionally, the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts and Contributions: Participants may contribute elective contributions, either as salary deferrals or as Roth contributions, up to an amount not to exceed the maximum allowed by the IRC. The maximum participant deferral limit was \$23,000 and \$22,500 for the years 2024 and 2023, respectively. Catch-up contributions of \$7,500 was available to participants who had attained age 50 or older for both years, and had not exceeded the contribution limit for the Plan year.

The Plan includes provisions for Employer Safe Harbor matching contributions. For the years ended December 31, 2024 and 2023, the Company made Safe Harbor matching contributions equal to 3% of compensation on behalf of each eligible participant.

The Company may also make annual discretionary profit sharing contributions to the Plan, which are to be allocated to participants who have completed three months of service requirement noted above. The Company made a discretionary profit sharing contribution to the Plan of 2% of the participants' eligible compensation for the years ended December 31, 2024 and 2023.

Participant Accounts: Each participant's account is credited or charged with the participant's contributions, Company contributions, an allocation of earnings or losses resulting from the participant's investments and an allocation of the participant's share of Plan expenses.

Vesting: Participants are immediately vested in their voluntary and Company Safe Harbor contributions and earnings thereon, but the vesting in Company profit sharing contributions and earnings thereon is a cliff vesting after three years of service.

Benefit Payments: Distributions of a participant's account can be made upon termination of service, death, disability, or retirement. Distributions are made in a lump-sum payment or in partial withdrawals for account balances exceeding \$5,000. If a participant's vested account balance is less than \$5,000, the account balance will be distributed without the participant's consent. An in-service distribution can be made to participants who have attained the age of 59-1/2, upon disability or when experiencing financial hardship.

NOTE 1. PLAN DESCRIPTION (Continued)

Administrative Expenses: Expenses incurred for administering the Plan may be paid from Plan assets if not paid by the Company. Administrative expenses paid from Plan assets include recordkeeping, investment advisory and contract administration fees and charges associated with investment transactions and benefit payments.

Notes Receivable from Participants: The Plan does not permit loans to participants.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of Investments: Investments are reported at fair value except for the fully benefit-responsive investment in the guaranteed investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded at the ex-dividend date. Amounts invested may earn interest and dividends, which in turn are reinvested. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes realized and unrealized gains and losses on investments sold or held during the year, net of fund investment expenses.

Benefit Payments: Benefits are recorded when paid.

NOTE 3. CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the financial information included in the Plan's 2024 and 2023 financial statements as it relates to investment assets, investment transactions, investment income, and the schedule of assets (held at end of year) have been derived from information certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company (collectively, Principal), the custodians of the Plan, in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under the ERISA.

NOTE 4. GUARANTEED INVESTMENT CONTRACT

The Plan invests in the Principal Fixed Income Guaranteed Option (PFIGO), a fully benefit-responsive guaranteed investment contract. PFIGO, a group annuity contract, is backed by the assets of the general account of Principal Life Insurance Company (Principal Life). Principal Life, the guaranteed investment contract issuer, is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Principal Life which may not be less than the guaranteed minimum interest rate under the contract. The crediting rate is reviewed and reset semiannually at December 1st and June 1st. The crediting rate for the year ended December 31, 2024 was at 1.55%. The crediting rate for the year ended December 31, 2023 was in the range of 4.05% to 4.65%.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Benefit payments are made at contract value (no termination or surrender charges) for Plan benefit events and investment transfers initiated by Plan participants. An employer initiated liquidation or transfer of assets is subject to a 12-month advance notice or 5% surcharge as the employer chooses. Thus, this contract is considered fully benefit-responsive and is reported in the financial statements at contract value which approximates fair value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants will become 100% vested in their accounts.

NOTE 6. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan, through the Volume Submitter program, by letter dated June 30, 2020, that the Plan, as then designed, was in compliance with applicable requirements of the IRC. The Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6. INCOME TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

NOTE 7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with parties who perform services or have fiduciary responsibilities to the Plan. Certain Plan investments are shares of mutual funds and collective investment trusts managed by subsidiaries of Principal Financial Group. Principal Trust Company and Principal Life Insurance Company, members of Principal Financial Group, are the custodians and contract administrators. These transactions qualify as party-in-interest transactions to which statutory exemptions apply.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities through mutual funds and collective investment trusts, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9. FAIR VALUE MEASUREMENTS

Fair value is determined based on assumptions that a market participant would use in pricing an asset or liability. Measurements of fair value are classified within a hierarchy based upon valuation inputs that give the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are as follows:

- Level 1* Observable quoted prices in active markets for identical assets and liabilities.
- Level 2* Observable quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.
- Level 3* Model-based techniques that use at least one significant assumption not observable in the market. These unobservable assumptions reflect estimates of assumptions that market participants would use in pricing the asset or liability. Valuation techniques include use of option pricing models, discounted cash flow models and similar techniques.

The following methods and assumptions were used to estimate the fair value of each class of assets that are recognized at fair value.

Mutual Funds: Valued using quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

Collective Investment Funds: Valued at their respective NAV as reported by Principal. The NAV is used as a practical expedient to estimate fair value. The collective investment funds consist of a group of collective investment funds with asset allocation objectives designed for targeted retirement dates. The funds invest in institutional class mutual funds and are valued daily based on quoted market prices of the underlying mutual funds.

The following table sets forth, by level within the fair value hierarchy, the Plan's investments at fair value based on summarized investment categories. There were no changes in methodologies during the years ended December 31, 2024 and 2023.



