INDEPENDENT AUDITOR'S REPORT

Opinion

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the J.H. Walker, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 1, 1993 for the benefit of eligible employees of J.H. Walker, Inc.(the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was amended and restated effective January 1, 2024 to be in compliance with current legislative and regulatory changes. The name of the Plan is now J. H. Walker, Inc. 401(k) Plan. The restated Plan allowed a smaller plan to merge and therefore received \$442,325 of net assets.

Loren D. Stark Company, Inc. is the Plan's prototype sponsor.

Administration

The Plan is administered by the Company. The Company has the power to carry out the provisions of the Plan including the power to interpret Plan provisions, decide on questions of eligibility and direct the disbursements of funds in accordance with the provisions of the Plan. The Company may appoint any person to perform the duties of the Administrator. The primary responsibility of the Administrator is to administer the Plan for the exclusive benefit of the participants, subject to the specific terms of the Plan. The administrative expenses may be paid out of the Plan unless paid by the Company. The Company appoints the Custodian of the Plan.

Eligibility

Employees of the Company must have attained the age of 21, have performed one year of service for the Company and work a minimum of 1,000 hours to be eligible to participate.

Contributions

Participants may elect to contribute an amount up to 100% of eligible pre-tax compensation, not to exceed the limits of the Internal Revenue Code (IRC). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make profit sharing contributions at its discretion which will be allocated among all eligible employees based upon compensation. Federal law limits the total annual amount that may be contributed to a participant's account.

Notes Receivable from Participants

Participants who transfer loan balances from the merged plan will be permitted to continue loan repayments under the previous loan terms. No new loans will be permitted.

Vesting

Participants are immediately vested 100% in their voluntary contributions and actual earnings thereon. Vesting in Company contributions and earnings are as follows:

Years of service before age 18 and below 1,000 hours are not counted towards vesting.

Payment of Benefits

Benefits are payable to participants or their beneficiaries in the event of retirement, disability, death or termination of service and are valued in accordance with the terms of the Plan. Financial hardship withdrawals are not available to participants.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company contributions and the participant account earnings. The Company profit sharing contributions are allocated based on participant compensation. Participant earnings and expenses are based on account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Forfeitures with respect to terminated participants may be used to pay plan expenses, with remaining forfeitures being allocated to remaining participants based upon compensation. Forfeitures of \$14,097 and \$24,953 were allocated to participants for the years ended December 31, 2024 and 2023, respectively.

Investment Options

Investment decisions for the Plan are made by the Plan Administrator and its investment advisors. Effective October 1, 2024, participant direct investments will be permitted for all accounts.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their respective account balances, net of any termination fees, if any.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reflected in the accompanying financial statements at fair value based on quoted market prices at year-end. The Plan has not invested in any fully benefit-responsive investments which would be required to be valued at contract value. Net investment income reflects the impact of changes in fair value as well as purchases and sales of investments during the year. Purchases and sales of securities are recorded on a trade-date basis.

Benefit Payments

Deductions related to benefits paid to participants are expensed when paid; accrual of benefits payable liabilities result when participants fail to deposit the respective payments in a timely manner.

Federal Income Taxes

The Trust established under this Plan is qualified under the Internal Revenue Code ("Code") as exempt from federal income taxes; the prototype plan adopted by the Company has received a favorable determination letter from the Internal Revenue Service dated November 30, 2020. U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan Administrator and Management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and are not aware of any tax positions that would have a significant impact on the Plan's financial position. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

As permitted by the Code, a participant is not subject to federal income tax on contributions made by the Company or on any income of the Plan until a distribution is made to the participant.

New Accounting Pronouncements

The Company considers the applicability and impact of all accounting standards updates (ASU's) issued by the Financial Accounting Standards Board (FASB). Most ASU's were assessed and determined to be either not applicable or are expected to have minimal impact on the financial position and results of operations of the Company.

NOTE 3 – FAIR VALUE MEASUREMENTS

As described in the Financial Accounting Standards Board (FASB) Accounting Standards Codification Topic 820 (ASC 820), *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quotes prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. In determining fair value, the Plan uses two different approaches, (the market approach and the cost approach), depending on the nature of the asset or liability. The market approach uses prices and other relevant data based on market transactions involving identical or comparable assets or liabilities. The cost approach is the amount that would be currently required to replace an asset or liability and indicates the cost to the Plan to acquire a substitute asset. The following is a description of the valuation methodologies used for assets or liabilities measured at fair value.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual Funds:

Valued at the net asset value (NAV) of shares held by the Plan at the end of the reporting period. These values are reported by each respective fund daily and are deemed to be actively traded, (Market Approach).

Investments in money market funds are valued at amortized cost which approximates fair value, (Cost Approach).

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. NOTE 4 – CONCENTRATION OF CREDIT RISK

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Concentration of credit risk with respect to the Plan's investments is reduced as a result of diversity of the underlying portfolio.

NOTE 5 – NONDISCRIMINATION TESTING COMPLIANCE

The Plan is in compliance with the nondiscrimination testing required by the Internal Revenue Service and Department of Labor for the 2024 and 2023 plan years.

NOTE 6 – TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are shares of mutual funds managed by the Custodian, and as such, these transactions qualify as party-in-interest transactions as defined by ERISA.

As described in Note 1, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan has notes receivable from participants at December 31, 2024. As a result, these receivables and all transactions relating to these receivables qualify as party-in-interest transactions. All these transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. There have been no known prohibited transactions with parties-in-interest.

Fees paid during the years for investment, accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services.
