INDEPENDENT AUDITOR'S REPORT

To the Trustees
International Association of Fire Fighters Employee 401 (k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of International Association of Fire Fighters Employee 401 (k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

Basis for Opinion

Responsibilities of Management for the Financial Statements


Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The International Association of Fire Fighters Employee 401(k) Plan (the Plan) was established on November 1, 1997. The Plan's sponsor is the International Association of Fire Fighters (IAFF), a labor union. The Plan is a defined contribution plan under section 401(k) of the Internal Revenue Code. The Plan is subjected to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan covers substantially all full time U.S. employees of IAFF, IAFF-Financial Corporation and E-18 Media, LLC., (collectively, IAFF). Employees who are age eighteen or older immediately after being hired by IAFF are eligible to participate in the Plan.

Contributions - Each year, participants may elect to contribute their pretax annual compensation not exceeding the maximum allowed by law. IAFF may elect, at its sole discretion, to make a matching contribution for each participant that has made 401(k) contributions. Under this provision, IAFF may match a designated percentage of a participant's total elected 401(k) contribution.

During the year ended December 31, 2024, IAFF made a matching contribution of 100% on the first 2% of salary deferrals. Employees must defer salary to receive a matching contribution.

The maximum allowable annual contributions to a participant's account during the year ended December 31, 2024 was no more than the lesser of the Internal Revenue Service (IRS) contribution limits or 100% of a participant's annual compensation.

Participant Directed Investment Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the IAFF's contribution, if any, and (b) Plan earnings, and charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Vesting - Participants are immediately vested in their salary deferral and catch-up contributions plus actual earnings thereon. Vesting in the IAFF's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

For vesting purposes, employees must be paid or entitled to pay from IAFF during the 12-month period beginning with the employees' date of hire and each anniversary of the employees' date of hire to be considered with a year of service.

Notes Receivable from Participants - Effective October 1, 2015, the Plan was amended to allow eligible participants to receive loans. Participants may borrow from their individual accounts a minimum of \$1,000 and up to a maximum amount of any loan permitted under the Plan, which is the lesser of 50% of the participant's vested Nationwide Trust Company (Nationwide) account balance or \$50,000 less the highest outstanding loan balance during the preceding one-year period. The loans are secured by the balance in the participant's account and bear interest at a rate which is determined by the Plan administrator by reviewing the interest rate charged for similar types of loans by other lenders. Principal and interest payments are to be repaid on the basis of substantially level amortization over the term of the loan with payments made through salary reduction each pay period.

Plan Administration - The assets of the Plan were held in trust by Nationwide Trust Company, the trustees.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Investment Valuation and Income Recognition - The Plan's investments are recognized at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recognized on a trade-date basis. Interest and dividend income is recognized on an accrual basis. Net appreciation in fair value of investments includes the Plan's gain or losses on investments bought and sold, as well as held during the year.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Options - Contributions to the Plan are invested as directed by the participant in various mutual funds and a fully benefit-responsive guaranteed investment contract. Participants must evaluate their own investment goals and objectives. Poor investment performance by the investments selected by the participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf.

Distributions - Distributions are made upon termination of employment, financial hardship, retirement, or death, as provided for under the Plan agreement. Participants may also choose to leave their account open until mandatory distributions are needed after they have been terminated or have retired.

Payment of Benefits - Benefits are recorded when paid.

Forfeitures - Forfeited non-vested accounts can be used to pay the Plan's administrative expenses or to reduce future employer matching contributions. At December 31, 2024, the forfeited accounts totaled \$3,240.

Estimates - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

NOTE 3. TAX STATUS

The Internal Revenue Service (IRS) has advised, in a letter dated March 31, 2014, that the Plan is a qualified Plan under Section 401(a) of the Internal Revenue Code (IRC) and is, therefore, exempt from federal income taxes under Section 501(a) of the IRC. Although the Plan has been amended since receiving the determination letter, there is no requirement to request an updated determination letter after a plan amendment if the operations of the Plan are consistent with those disclosed in the original application for exemption. The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.



NOTE 4. INFORMATION CERTIFIED BY TRUSTEE

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974 (ERISA). Accordingly, Nationwide Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023; the supplemental Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024; and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

NOTE 5. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodology used at December 31, 2024 and 2023.

Mutual funds and money market funds: Funds are traded in active markets on national and international securities exchanges and are valued at closing prices on the last business day of each period.

NOTE 6. GROUP ANNUITY CONTRACT

The Plan participates in a contract with Nationwide via an investment in the Nationwide Fixed Select Contract. The account is credited with earnings at a fixed interest rate on the underlying investments and is charged for plan withdrawals. As described in Note 2, because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by Nationwide, represents contributions made under the contract plus earnings, less plan withdrawals, and administrative expenses. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rate in the Nationwide Fixed Select Contract was 2.32% for each of the years ended December 31, 2024 and 2023.



NOTE 6. GROUP ANNUITY CONTRACT (CONTINUED)

Such interest rates are reviewed and reset on a quarterly basis. The Plan's balance in the group annuity contract as of December 31, 2024 and 2023 is as follows:

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on Nationwide's ability to meet its financial obligations. Nationwide's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with Nationwide. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal incomes taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material representation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

NOTE 7. RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds held by Nationwide Trust Company and managed by Nationwide affiliates. Nationwide is the custodian as defined by the Plan. In addition, IAFF, as Plan sponsor, pays certain administrative costs on behalf of the Plan that are not included in these financial statements. The IAFF does not expect to be repaid for these expenses. The Plan also directly paid fees to an affiliate of Nationwide for administrative services. The Plan paid \$99,701 and \$55,588 for administrative services during the years ended December 31, 2024 and 2023, respectively. These transactions all qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.



NOTE 8. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect. However, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to IAFF. In the event of termination of the Plan or a partial termination of the Plan or a complete discontinuance of contributions, the affected participants accounts shall become 100% vested and shall not thereafter be subject to forfeiture.

NOTE 9. SIGNIFICANT UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that the values of investment securities could be different at the reporting date and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
