We have performed audits of the financial statements of Gestamp North America 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Plan Description

The following description of Gestamp North America 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees, as defined in the plan document, of Gestamp Alabama, LLC; Gestamp North America; Gestamp Chattanooga, LLC; Gestamp West Virginia, LLC; Gestamp South Carolina, LLC; Gestamp Mason, LLC; Edscha Automotive of Michigan, Inc.; Gestamp Chattanooga II; Gestamp AutoTech, Inc.; Gestamp Washtenaw LLC; and Edscha North America Technologies (collectively, the "Company"). All eligible employees, as defined by the plan document, can participate in the Plan on the first day of the month after the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Contributions to the Plan are invested as directed by the participants from available investment alternatives. The Plan permits participants to contribute up to a maximum of 80 percent of eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Eligible compensation includes bonuses, commissions, and severance pay, as defined in the plan document. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for 401(k) matching contributions equal to 100 percent of the participant's first 3 percent of eligible employee compensation and 50 percent of the next 2 percent of eligible contributions. The Plan also allows for employer discretionary contributions; however, no discretionary contributions were made during the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the employer matching contribution, and a proportionate share of the Plan's earnings and expenses. The allocation of plan earnings and expenses to participants' accounts is based on participants' proportionate share of funds in each of the investment accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary, employer matching, and rollover contributions and any income or loss thereon. Participants vest in discretionary employer contributions at a rate of 25 percent after one year of service, 50 percent after two years of service, 75 percent after three years of service, and 100 percent after four years of service.

#### **Participant Notes Receivable**

Participants may borrow from their accounts in total a minimum of \$1,000 up to a maximum of \$50,000. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 5.25 percent to 10.50 percent, which are commensurate with local prevailing rates determined by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

#### **Hardship Withdrawals**

Participants may request, with the Company's approval, that all or a portion of their accounts be distributed in the case of severe financial hardship subject to IRS guidelines, as defined in the plan document. Only a participant's deferral portion of his or her account is eligible for hardship withdrawal.

### Note 1 - Plan Description (Continued)

#### ***Payment of Benefits***

Distributions are payable upon retirement, death, disability, attaining age 59½, or termination of employment in the form of a lump-sum amount or equal installment payments equal to the vested balance of a participant's account. Account balances less than \$5,000 are paid in a single lump sum upon termination.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the trustee shall distribute all assets in the Plan to the participants in proportion to their respective account balances. Upon termination of the Plan, participants become 100 percent vested in employer contributions.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust) or its affiliates. Principal Trust is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future employer contributions or to pay administrative expenses of the Plan.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 9, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and the supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

***Mutual Funds***

Mutual funds are valued at quoted prices reported in active markets.

**Note 4 - Fair Value Measurements (Continued)**

***Common/Collective Trust Funds***

The common/collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

***Pooled Separate Accounts***

The pooled separate accounts are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' net underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

***Guaranteed Interest Contracts***

The guaranteed interest contracts are not considered benefit responsive and are presented at fair value. Fair value is the amount paid when funds are withdrawn prior to their maturity. Fair value approximates the contract value of the contracts.
