### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities of Management for the Financial Statements***

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental schedule Schedule H, Line 4a: Schedule of Delinquent Participant Contributions for the period from January 1, 2024 through December 1, 2024 (Plan Merger Date), is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1 – Description of the Plan

The following description of the Snooze 401(k) Plan (the “Plan”) provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan’s provisions.

**General.** The Plan is a defined contribution plan, which went into effect January 1, 2019, that is generally available to all employees of Snooze HoldCo dba Snooze, an A.M. Eatery (the “Company”, “Employer”, “Plan Sponsor”, or “Plan administrator”). The Plan excludes collectively bargained employees, nonresident aliens, independent contractors, and reclassified employees. There are no age or service requirements for elective deferral contributions, therefore, employees are eligible to make elective deferral contributions on their date of hire. Employees become eligible to receive Employer contributions on the first day of the Plan year quarter coinciding with or next following the date a participant completes one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

**Transfers.** Effective December 1, 2024, the Plan Sponsor revolved to merge the Plan into the Your 401(k) Plan. All assets and liabilities of the Plan became the assets and liabilities of the Your 401(k) Plan as of the effective date of the merger. In connection with the merger, Plan net assets of \$3,021,121 were transferred from the Plan into the Your 401(k) Plan.

**Contributions.** The following types of contributions are allowable under the Plan:

- Elective Deferral Contributions – Participants may contribute a percentage of their pre-tax compensation, as defined in the Plan document, subject to limitations. Participants may also contribute a percentage of their after tax compensation and designate it as a Roth deferral contribution. A participant’s total contributions cannot exceed \$23,000 (\$30,500 if age 50 or older) in calendar year 2024.
- Discretionary Employer Matching Contributions – The Employer may make matching contributions each payroll period based on a discretionary percentage of an eligible participant’s elective deferral contributions. During 2024, the Employer did not make a discretionary Employer matching contribution.
- Discretionary Employer Contributions – The Employer may make an additional discretionary contribution to eligible participants who are employed by the Employer on the last day of the Plan year. This contribution is integrated with a percentage of the Social Security Taxable wage base and is allocated to each eligible participant’s account in the ratio which each participant’s compensation and excess compensation, as defined, bears to the compensation plus excess compensation of all eligible participants. During 2024, the Employer did not make a discretionary Employer contribution.
- Rollover Contributions – Amounts distributed to participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan’s investment funds at the direction of the participants. The total annual additions to a participant’s account may not exceed the lesser of \$69,000 or 100% of the participant’s compensation.

**Investment Options.** Prior to the Plan merger effective December 1, 2024 (see Note 1), participants had the option to direct their investments into various common collective trusts, pooled separate accounts, and registered investment companies.

### Note 1 – Description of the Plan (continued)

**Participant Accounts.** Each participant's account is increased and/or decreased, as applicable, with the participant's contributions (elective deferrals and rollovers, if any) and an allocation of (a) the Employer's contribution (discretionary matching and discretionary, if any), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting.** Participants are immediately vested in their elective deferral contributions, rollover contributions, and related earnings thereon. Discretionary Employer matching and discretionary Employer contributions made to a participant's account vest according to the following schedule:

Furthermore, employed participants become 100% vested in their discretionary Employer matching and discretionary Employer contribution accounts upon the following events:

- Participant's death;
- Participant becomes disabled as defined under the Plan;
- Participant reaches his/her normal retirement date; or
- Termination or partial termination of the Plan.

**Forfeitures.** When certain terminations of participation in the Plan occur, the non-vested portion represents a forfeiture. Forfeitures are used to pay Plan expenses, used to reduce Employer contributions, or are reallocated to eligible participants as an additional Employer contribution. There were no unutilized forfeitures in the forfeitures account as of December 1, 2024 and December 31, 2023.

**Notes Receivable from Participants.** Participants had the option to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 or (ii) 50% of their vested account balance. Loan terms range from 1 month up to a maximum of 5 years. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest based on similar loans from commercial lending institutions as determined by the Plan administrator at the time the loan is granted. Principal and interest payments are paid ratably through payroll deductions.

**Payment of Benefits.** Benefits to participants or beneficiaries are generally payable as a lump-sum equal to the value of their vested account balance upon retirement, termination of employment, death or disability. Participant may also elect a rollover distribution of their vested account balance into another qualified plan or Individual Retirement Account. Additionally, participants may elect in-service withdrawals of their rollover contributions account, upon attainment of age 59 ½, for a qualified reservist distribution, or upon incurring a financial hardship, as defined, if certain criteria are met.

### Note 2 – Summary of Significant Accounting Policies

**Basis of Accounting and Use of Estimates.** The financial statements of the Plan are prepared using the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions.** Participant contributions are recognized in the period in which participant contributions are withheld from compensation.

**Excess Contributions Payable.** Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Code ("IRC") are recorded as a liability and corresponding expense. The Plan distributes the excess contributions to applicable participants after the Plan's year end.

**Benefit Payments.** Benefits are recorded when paid.

**Expenses.** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Also included in administrative expenses are contract administrator, recordkeeping, and other fees. Certain investment related expenses are included in net appreciation in fair value of investments.

### Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 1, 2024 and December 31, 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Pooled Separate Accounts ("PSAs") and Common Collective Trusts ("CCTs") are valued at the net asset value ("NAV") of units held by the Plan at year end. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the PSAs and CCTs less their liabilities. This practical expedient is not used when it is determined to be probable that the PSAs or CCTs will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.
- Registered investment companies are valued at the quoted NAV of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The SV Fund is designed for long-term retirement investing. An Equity Wash requires that transfers must be directed to a non-competing investment option under the Plan for 90 days before such transferred amounts may be directed to any other competing investment option. Competing investment options include other guaranteed investment options, and cash account, money market, other short-term fixed income investment options with an average duration of less than two years, or investment options where the principal amount is guaranteed to Plan participants.

No withdrawal shall be made before the Valuation Date that is 12 months after the date the Trustee receives proper notice of withdrawal from the Participating Trust. Withdrawals to which this restriction applies include, but are not limited to, any whole or partial withdrawal of the assets of a Participating Trust that is initiated by the employer or sponsor of the Participating Trust, including without limitation, the termination of the Participating Trust, the withdrawal of its assets from the Fund, or certain communications designed to instigate redemptions as described in the SV Fund disclosure document. The Trustee may choose to disburse withdrawals as of a Valuation Date earlier than the valuation date provided if the Trustee determines, in its discretion, that the withdrawal is not detrimental to the best interest of the SV Fund and plans participating therein.

### Note 4 – Certified Information

- Interest income on notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2024 through December 1, 2024; and

### Note 5 – Tax Status

The Plan Sponsor has adopted a Principal Life Insurance Company Non-Standardized Pre-Approved Profit Sharing Plan (“pre-approved plan”). The pre-approved plan received an opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code (“IRC”). Although the pre-approved plan and the Plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related Trust is tax exempt as of December 1, 2024 and December 31, 2023. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 1, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Certain Plan investments were units of pooled separate accounts and common collective trusts offered by Principal Life Insurance Company ("Principal Life") and Principal Global Investors Trust Company ("Principal Global"). As Principal Life, Principal Global, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company were the custodians of the Plan, these transactions qualify as party-in-interest transactions. Additionally, the Plan maintained notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

### Note 8 – Nonexempt Prohibited Transactions

During 2024 and 2023 the Company had nonexempt prohibited transactions related to participant contributions and loan repayments not remitted to the trust in a timely manner as listed in the aggregate on Schedule H, Line 4a: Schedule of Delinquent Participant Contributions. The Company intends to correct these late contributions by remitting any remaining principal amounts and lost earnings into the Plan's trust as soon as administratively feasible.

### Note 9 – Concentrations, Risks, and Uncertainties

As of December 31, 2023, there were four investments, which individually represented more than 10% of net assets available for Plan benefits.
