## **Independent Auditor's Report**

To the Plan Administrator and Participants  
Philadelphia Country Club 401(k) Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Philadelphia Country Club 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

**Note 1 - Description of Plan**

General

The following description of the Philadelphia Country Club 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

On July 23, 1997, Philadelphia Country Club (the “Club”) adopted the Plan as of January 1, 1997 and subsequently amended and restated the Plan. The Plan is a defined contribution Plan covering all employees of the Club who are age twenty-one or older and have completed six months of service within the calendar year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Club’s Board of Governors oversees governance of the Plan. The Club’s Human Resources Committee determines the appropriateness of the Plan’s investments, monitors investment performance, and reports to the Plan’s Board of Governors.

Contributions

Upon eligibility, participants may contribute up to ninety percent of pre-tax compensation as defined in the Plan document. Participants may also rollover amounts representing distributions from other qualified defined contribution plans. The Club may contribute a discretionary match percentage of the employee’s deferrals to the Plan. Additional amounts may be contributed at the option of the Club’s Board of Governors. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

Investment options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any investment offered by the Plan.

Participant accounts

Each participant’s account is credited with (a) the participant’s contribution and allocations of (b) the Club’s contribution and (c) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their pre-tax contributions plus actual earnings thereon. Vesting in the Club's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A service year consists of 1,000 hours. A participant is vested in employer contributions, as follows:

Participant loans

Participants are not permitted to borrow from their accounts.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account, either as a lump-sum or in substantially equal installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Minimum required distributions for participants also apply per Internal Revenue Service regulations.

Forfeited accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures are used to reduce employer contributions. For the year ended December 31, 2024, \$9,442 was used to reduce Plan expenses.

**Note 2 - Summary of significant accounting policies**

Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting with the exception of benefit payments which are treated on a cash basis.

Investment valuation and income recognition

The Plan's investments are reported at fair value:

*Registered investment companies (mutual funds).* The Plan's investments in mutual funds are stated at fair value, based on the quoted market prices of the underlying securities within each fund.

*Common/collective trusts.* The value of the common/collective trusts is determined at the close of each business day based on the fair value of the respective investments. The value of each account is expressed in "units". The "unit value" is the dollar value of one unit and is determined at the close of each business day by dividing the total fair value of each account by the total number of units in the account. The value of each participant's account on any date is determined by multiplying the number of units held by the "unit value" at the close of the business day.

Management fees and operating expenses charged to the Plan for investments are deducted from the individual investments and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair value measurements

For assets measured at fair value on a recurring basis, accounting standards require quantitative disclosure about the fair value measurement separately for each major class of assets. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are as follows:

- Level 1 – Unadjusted quoted prices in active markets for identical assets.
- Level 2 – Quoted prices for identical assets in markets that are not active, quoted prices for similar assets in active markets, inputs other than quoted market prices, and inputs derived principally from observable market data.
- Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Contributions

Contributions from participants are recorded as they are withheld from the participants' wages. Contributions from the Club are recorded as earned.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from these estimates.

Administrative expenses

The Plan's administrative expenses may be paid by the Club, but if not by the Club when due, shall be paid from the Plan.

Risks and uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, credit and liquidity risks. Due to the level of risk associated with these investments, it is reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits as of December 31, 2024. The investments are not insured or protected by the Pension Benefit Guaranty Corporation, or any other governmental agency, accordingly, the Plan is subject to the normal investment risks associated with mutual funds and common/collective trusts.

Subsequent events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 1, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Information certified by the Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, the supplemental schedule, Schedule H – Part IV – Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Note 5 - Party-in-interest transactions**

In addition, certain investment and administrative fees related to the Plan were paid by the Plan or by the Plan Sponsor and qualify for the party-in-interest exemption, as defined by ERISA. Personnel and facilities of the Plan Sponsor have been used by the Plan at no charge to the Plan.

**Note 6 - Plan termination**

Although it has not expressed any intent to do so, the Club has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**Note 7 - Tax status**

The Internal Revenue Service has determined and informed the Plan that the Plan is designed, in accordance with applicable sections of the IRC. Although the Plan has been amended/restated since receiving the determination, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified.
