## **Independent Auditor's Report**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Joyce Koons Honda Buick GMC 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. PLAN DESCRIPTION

The following description of Joyce Koons Honda Buick GMC 401(k) Plan and Trust (the Plan) provides only general information. Additional information regarding the Plan's provisions is contained in the plan document.

#### *General*

The Plan, adopted in 1984, is a defined contribution 401(k) plan for the benefit of the employees of Koons of Manassas, Inc. d/b/a Joyce Koons Honda Buick GMC (the Company). Employees age eighteen or older are eligible to participate in the Plan at the first of the month following three months of continuous service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to contribute to the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Their deferral percentage automatically increases by 1% each year until it reaches a maximum of 10% of compensation. The Plan also allows participants to make after-tax Roth contributions subject to certain limitations determined by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The plan sponsor may make discretionary matching contributions at the election of the plan sponsor's board of directors. The plan sponsor's discretionary matching contributions will not exceed \$700 per participant and are allocated based on the participant's eligible compensation during the plan year. The plan sponsor may also make discretionary profit-sharing contributions at the election of the plan sponsor's board of directors. Participants must have completed 1,000 hours of service and be employed on the last day of the plan year to receive discretionary profit-sharing contributions. Employer matching and profit-sharing contributions are subject to certain limitations under the IRC. The plan sponsor made discretionary matching contributions totaling \$49,122 for the year ended December 31, 2024. The plan sponsor did not make any discretionary profit-sharing contributions for the year ended December 31, 2024.

#### *Participants' Accounts*

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and plan earnings. Allocations are based on participants' earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. PLAN DESCRIPTION (CONTINUED)

#### *Vesting*

Each participant is immediately vested in his or her voluntary contributions, plus earnings thereon. Vesting in the remainder of the participant's account balance is determined by years of service. A participant shall have a vested interest of 100 percent after six years of service. A participant becomes fully vested upon reaching normal retirement age, age 65, or in the case of death or disability.

#### *Notes Receivable from Participants*

Participants may borrow from their vested account balances up to a maximum equal to the lesser of \$50,000 or 50% of their total vested account balances. There is also a minimum loan amount of \$1,000. Loan terms range from one to five years. If the loan is for the purchase of a principal residence, the plan administrator may permit a longer repayment term. Each loan is secured by a pledge of 50% of the participant's vested account balance and bears interest at prime plus one percentage point at the time funds are borrowed. Principal and interest are paid ratably through weekly payroll deductions. Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024, interest rates on outstanding notes ranged from 4.25% to 9.50%.

#### *Benefit Payments*

On termination of service due to death, disability, retirement, or on account of financial hardship, as defined in the IRC, a participant's benefits are payable in the form of a lump sum, installment payments, or a life annuity equal in value to the vested balance in his or her account.

If a participant leaves the Plan and forfeits all or part of his or her accrued benefit and is reemployed within five years, the accrued benefit is restored when the participant is reemployed. If the participant receives a distribution of his or her vested benefit upon termination, the distribution must be repaid for restoration to occur. The restoration is derived first from forfeitures and then from income in the year of restoration.

#### *Forfeited Accounts*

Forfeited balances of terminated participants' non-vested accounts are used to pay plan expenses. If there are still forfeitures remaining after the expenses are paid, they are used to reduce future Company's contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,827 and \$2,294, respectively. During 2024, \$35,682 of these accounts were used to reduce the employer contributions.

#### *Administrative Expenses*

Certain administrative expenses are paid by the Plan and are allocated proportionately to participant account balances. The Company absorbs other costs related to managing the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The Plan maintains its books and presents its financial statements under the accrual method of accounting in accordance with generally accepted accounting principles in the United States of America.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

Investments of the Plan are stated at fair value. Shares of registered investment companies (mutual funds) are valued at quoted market prices which represent the net asset values of shares held by the Plan at year end. Units of the common/collective trusts investments are valued based on net asset value per share provided by the manager of the fund. Net appreciation (depreciation) includes the Plan's gains and losses in investments bought and sold as well as held during the year.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest is accrued when earned.

*Benefit Payments*

Benefits are recorded when paid.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified that the information related to investments included in the accompanying financial statements and supplementary schedule are complete and accurate.

**4. FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs to the valuation methodology are unadjusted quoted prices for similar assets in active or inactive markets and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

*Registered Investment Companies:* The fair value of the shares of mutual funds owned by the Plan is based on quoted market price values on the last business day of the plan year.

*Common/Collective Trusts:* The fair value of common/collective trust funds is based on net asset value (NAV) on the last business day of the plan year provided by the entity holding the trust funds. The NAV of the common collective trusts is used as a practical expedient to estimate fair value and is determined by the trustee based on the fair value of underlying assets in the trusts, less the liabilities. Investments in all common/collective trust funds can be redeemed immediately at the current net asset value. There are no withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2024 and 2023.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**9. RELATED PARTY TRANSACTIONS**

The Plan's investments are managed by Reliance Trust Company. Reliance Trust Company is the trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**10. TAX STATUS**

The Plan has adopted a volume submitter plan (VSP) which received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the VSP is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan sponsor and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe the Plan is qualified and the related trust is tax-exempt.

***Uncertain Tax Positions***

The Plan meets the requirements of the IRC and ERISA to qualify as exempt from federal income taxes.

The accounting standard on accounting for uncertainty in income taxes addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return should be recorded in the financial statements.

Under that guidance, the Plan may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained on examination by taxing authorities based on the technical merits of the position. For the Plan, a tax position is the Plan's tax-exempt status under the provisions of the IRC and ERISA.

The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50% likelihood of being realized upon ultimate settlement. There were no unrecognized tax benefits identified or recorded as liabilities for the year ended December 31, 2024.

*Uncertain Tax Positions (Continued)*

The Plan's policy would be to recognize interest and penalties, if any, on tax positions related to its unrecognized tax benefits in income tax expense in the financial statements. No interest and penalties were assessed or recorded during the year ended December 31, 2024.

**11. CONTINGENCIES**

The Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) was signed into law on March 27, 2020, and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act) was signed into law December 29, 2019. These laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions.

Effective April 17, 2020, certain provisions were implemented under the CARES Act. The Plan will be formerly amended for the CARES Act and the SECURE Act provisions elected in accordance with applicable law and IRS guidance. Under Notice 2022-33 and Notice 2022-45, the IRS has extended the deadline for retirement plans to adopt the amendments required by the SECURE Act and the CARES Act until December 31, 2025.

**12. SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through September 10, 2025, the date on which the financial statements were available to be issued.
