## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of the  
Appen AI, Inc. Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Appen AI, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier ("qualified institution") in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

### 1. Description of Plan

The following description of the Appen AI, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan was adopted by Appen AI, Inc. (the “Company,” “Plan Administrator,” and “Plan Sponsor”) on January 1, 2003 and was most recently amended and restated effective July 1, 2023. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the Internal Revenue Code (“IRC”). All employees of the Company, except union employees and nonresident aliens, are eligible to participate in the Plan providing they are at least age 21 and have completed six months of service. Certain classes of employees, as defined by the Plan document, are excluded from participating in the Plan. Participants may enter the Plan on the first day of the calendar quarter following date of hire.

#### **Plan Administration**

The Company is the Administrator of the Plan. As Plan Administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan (including the authority and responsibility to invest, manage, and control the assets of the Plan specifically allocated to the trustee). Reliance Trust Company is the appointed trustee of the Plan in 2024 and 2023, and acted at the direction of the Plan Administrator. ADP Retirement Services is the third party administrator and record-keeper of the Plan.

#### **Contributions**

Participants may contribute up to the maximum amount allowed by law of their pre-tax annual eligible compensation up to the limits imposed by Section 402(g) of the IRC. The Plan allows for Roth 401(k) contributions, which are included in the participants’ gross income at the time deferred. The Plan allows participants who have attained age 50 before the end of the Plan year to make catch-up contributions. For the year ended December 31, 2024, the Company made a safe harbor matching contribution, of 100% of employees deferrals that do not exceed 3% of eligible compensation, plus 50% of employees deferrals that do not exceed 5% of eligible compensation. The 401(k) safe harbor match amounted to \$527,196 for the year ended December 31, 2024.

The Plan Sponsor may also make discretionary matching employer contributions based on a discretionary percentage of a participant’s compensation or a discretionary dollar amount as determined by the Plan Sponsor. The Plan also allows for non-elective profit-sharing contributions at the discretion of the Plan Sponsor. Participants must be employed at the end of the Plan year in order to receive any qualified non-elective profit-sharing contributions. For the year ended December 31, 2024, the Company did not make or approve any discretionary matching employer or non-elective profit-sharing contributions.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, any employer contributions, Plan earnings or losses, and rollovers from other qualified plans. Plan earnings or losses are allocated based upon each participant’s account balance. Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

#### ***Vesting***

Participant contributions, rollovers, and net earnings on these contributions are fully vested when made or earned.

Safe harbor contributions, discretionary employer matching contributions, and non-elective profit-sharing contributions, as well as all earnings on these contributions, are fully vested when made or earned.

Prior to January 31, 2023, discretionary employer matching contributions and non-elective profit-sharing contributions, if any, as well as all earnings on these contributions, vest 20% per year after the second year of service and are fully vested after six years.

In April 2024, the Company underwent some restructuring that resulted in some participants being terminated, which triggered a partial Plan termination. Participants who were terminated as a result of the restructuring became 100% vested.

#### ***Forfeitures***

Forfeitures that occur during a Plan year may be used to pay administrative expenses and to reduce future employer contributions. As of December 31, 2024 and 2023, the forfeiture account totaled \$1,862 and \$1,805, respectively. For the year ended December 31, 2024, no forfeitures were used.

#### ***Notes Receivable from Participants***

Participants are allowed to borrow from their account up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms shall be no more than five years, except for loans used to purchase a primary residence, which may be longer than five years. Loans shall bear a reasonable rate of interest, commensurate with what would be charged by a lending institution providing similar loans, as determined by the Plan Administrator at the time the loan originates. Payments on loans shall be repaid through automatic deductions through regular payroll. Interest rates on loans ranged from 4.25% to 9.50% per annum as of December 31, 2024.

#### ***Payments of Benefits***

When participants leave the Company upon retirement or for any other reason, those participants (or their beneficiaries) may receive their benefits in a single lump sum amount equal to the value of the participant's vested interest in their accounts.

The Plan allows for in-service withdrawals at age 59½ and for certain heavy financial needs (hardship), as defined by the Plan document.

In order to receive distributions, participants (or their beneficiaries) are required to file the appropriate forms with the Plan Administrator. Account values will be determined as of the day the distribution is made.

Distributions under the Plan shall generally be made as soon as possible after the date of retirement, death or termination of employment. The participant may elect, at the time, to have all or a portion paid directly to an eligible retirement plan specified by the participant. The Plan allows for automatic lump-sum distributions of participant vested account balances that do not exceed \$1,000. In the event of a mandatory distribution greater than \$1,000 but less than \$5,000, for which the participant does not elect to have such a distribution directly, the Plan Administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan Administrator. On September 19, 2023, the Plan Administrator approved to adopt the SECURE Act 2.0 for mandatory distribution of \$7,000, which became effective after December 31, 2024.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct their contributions in percentage increments into a series of mutual funds and a common/collective trust offered by the Plan. Participants may change their investment options as of the first day of each month.

#### ***SECURE Act 2.0***

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since the provisions of SECURE Act 2.0 include both required and optional elements, applicable provisions will be evaluated and implemented in accordance with accompanying regulations and guidance, and the Plan will be amended as required. Certain provisions became effective for 2024, these changes had no material impact to the Plan's financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, disclosure of contingent assets and liabilities, and changes in net assets available for benefits. Actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

All investments are recorded at fair value based upon active market values determined by investment advisors as required under ERISA regulations. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 4 for discussion of fair value.

#### ***Investment Valuation and Income Recognition***

Investments in securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the valuation period. In accordance with the policy of stating investments at fair value, net realized and unrealized appreciation for the year are reflected in the statement of changes in net assets available for benefits. Purchases and sales of securities are reflected on a trade date basis. Interest is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### *Payment of Benefits*

Benefit payments are recorded when paid.

#### *Information Certified by the Trustee*

### 4. Fair Value Measurements

Accounting standards for fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under these accounting standards are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual term), the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### 5. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by the trustee of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

The Plan has a revenue sharing account provided by Reliance Trust Company. Fees incurred by the Plan for the investment management services are paid through revenue sharing, rather than a direct payment. Excess revenue sharing received is deposited into the Plan in a revenue credit account to offset future Plan expenses. As of December 31, 2024, the balance of the revenue credit account amounted to \$8. For the year ended December 31, 2024, \$50,360 was used to reduce advisor related fees.

### 6. Tax Status

The Plan has adopted a prototype plan document that has received an opinion letter from the Internal Revenue Service dated October 6, 2020. The Plan document has been amended since receiving that opinion letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC, and that the trust, which forms a part of the Plan, is exempt from income tax. Accordingly, no provision has been made for federal and state income taxes.

### 7. Plan Termination

The Company has established the Plan with the intention and expectation that the Plan will continue indefinitely. However, the Company reserves the right at any time to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in any non-vested employer contributions. Distributions will be made to participants as outlined in the Plan's provisions.

### 8. Risks and Uncertainties

The Plan provides for various investment securities, which are exposed to various risks such as interest rate, market fluctuation and credit risks. The fair value of investments and securities are sensitive to changes in economic conditions, delinquencies, and defaults, and may be adversely affected by shifts in the market perception of the issuers. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

As of December 31, 2024 and 2023, approximately 67% and 66%, respectively, of net assets were held in five funds.

### 9. Delinquent Participant Contributions

The Plan Sponsor failed to timely remit certain participant contributions in accordance with the Plan's policy and Department of Labor's regulations. The delinquent contributions aggregate to \$76,681, as listed in the Schedule H, Line 4a - Schedule of Delinquent Participant Contributions.
