INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and Management of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Cherryroad Technologies 401K Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Cherryroad Technologies 401K Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Cherryroad Technologies 401K Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about CherryRoad Technologies 401K Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE A – DESCRIPTION OF THE PLAN

The following description of CherryRoad Technologies 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all full-time employees of CherryRoad Technologies Inc. (the “Company”) and its’ wholly owned subsidiaries who are age twenty-one or older. Employees are eligible for employer contributions and elective deferral contributions immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended, (ERISA).

Contributions – Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. A list of investments, which includes eligible mutual funds and other corporate, and government securities is supplied to the participants who select their options upon enrollment into the Plan. The Plan includes an automatic enrollment process whereby all newly eligible employees are automatically enrolled in the Plan within 45 days of the hire date if the employee does not affirmatively opt out of the Plan. Automatically enrolled participants have their deferral rate set to 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company may make discretionary matching contributions to a participant’s account. During 2024 and 2023, the Company contributed 50% of the first 6% of total compensation that a participant contributed to the Plan. The matching Company contribution is invested in the various investments as directed by the employee’s election options. Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors and are invested in the various investments as directed by the employee’s election options. Contributions are subject to certain limitations.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) individual participant account earnings, and charged with a direct allocation of administrative expenses attributable to the individual participant’s investment options and allocated administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after four years of credited service.

Notes Receivable from Participants – Participants may borrow from their fund accounts. The minimum loan amount is \$1,000. The maximum loan amount is \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant’s account and bear interest at rates ranging from 7.25% to 9.50%. The loan interest rate is determined monthly and is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through semi-monthly payroll deductions.

Payment of Benefits – On termination of service due to death, disability or retirement, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Additionally, if an employee is terminated for reasons other than death, disability or retirement and their vested interest in their account does not exceed \$7,000, then a distribution will be made to the employee regardless of whether they consented to it.

Forfeiture Account – At December 31, 2024 and 2023, the forfeiture nonvested accounts totaled \$126,197 and \$29,845 respectively. The accounts will be used to reduce future employer contributions and administrative expenses. During 2024 and 2023, approximately \$0 and \$59,840 respectively, of forfeitures were applied to employer contributions.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Cash and cash equivalents are valued at cost which approximate fair value. See Note F for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest are recorded daily upon receipt and credited to the respective individual participant accounts. Revenue sharing commissions earned by the Plan are recorded daily upon receipt and credited to a separate holding account for utilizing as an offset to Plan administrative expenses. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been accrued as of December 31, 2024, and 2023. Delinquent notes are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan Sponsor absorbs significant administrative expenses such as auditing fees and bonding insurance. During the plan years ended December 31, 2024, and 2023, other significant administrative expenses for third party administrative and trustee fees and consulting fees were paid by the participants or with amounts held in the forfeiture nonvested accounts and the Plan's credit account. The Plan's credit account contains certain commission revenue allocable to the Plan as a result of normal trading activities and is used to offset administrative expenses. Other Plan expenses may be paid directly by the participants and are allocated among the participants' accounts proportionately based on the value of the participants' account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocation depends upon the nature of the expense.

NOTE C – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE E - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Observable inputs such as quoted prices in active markets.

Level 2 – Inputs other than quoted prices in active markets that are either directly or indirectly observable

Level 3 – Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Corporate stock, Exchange traded funds, Warrants - are valued based on quoted market prices reported on the active market on which the individual securities are traded.

Corporate Bonds and US Treasury Securities – are valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Mutual funds - are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Funds – the Fund is valued at net asset value (NAV) of units held in the Fund and not classified in the fair value hierarchy in accordance with ASC Subtopic 820-10. The NAV as provided by the Trustee is the fair value of the underlying investments which consists of fixed income securities held by the Fund less its liabilities. The fair value presented in the hierarchy tables are intended to permit reconciliation of the fair value hierarchy to the investments at fair value as presented in the Statements of Net Assets Available for Benefits.

NOTE F – RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500

Amounts allocated to withdrawing participants are recorded on the Schedule H of Form 5500 for benefit claims that have been processed and approved for payment prior to December 31, 2024 and 2023, but not yet paid as of that date. As of December 31, 2024, and 2023, there were no pending benefit claims unpaid by the Plan's year end.

NOTE G – TAX STATUS

For the period effective January 1, 2021, the Plan adopted a new prototype plan designed by ADP, LLC. The Internal Revenue Service Determination Letter issued to ADP, LLC, the Plan's administrator is effective as of October 6, 2020, for the Plan's prototype plan grants acceptable status under section 401 of the Internal Revenue Code for use by employer for the benefit of their employees. Although the Plan has been amended since adoption of the prototype plan, the Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRS and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE G – TAX STATUS - Continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I – PARTY IN INTEREST TRANSACTIONS

The Company uses a third party for the administration and record keeping of the plan. Additionally, a third-party Trustee is used to accept plan contributions and hold and manage the plan assets in trust for the participants. An investment advisor provides consulting services to the Company's Investment Committee related to performance monitoring and investment options of the Plan. The aforementioned third parties are parties-in-interest under ERISA.

NOTE J – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.
