INDEPENDENT AUDITORS' REPORT

To Mavis Tire Supply LLC 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mavis Tire Supply LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Mavis Tire Supply LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document, the summary plan description and other publications previously distributed to them for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Mavis Tire Supply LLC (the “Sponsor” or “Mavis”), Express Oil Change LLC, Brakes Plus Inc. and Town Fair Tire Centers, Inc. (“Participating Employers”), who are age eighteen or older and who have completed twelve months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan became effective January 1, 1995. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the management of the Sponsor.

Contributions

Participant Contributions:

If participants elect, they can contribute into their account on a pre-tax basis no less than 1% nor more than 90% of their annual compensation subject to Internal Revenue Code (“IRC”) limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation which is then increased by 1% at each anniversary of their eligibility date up to a maximum of 4%. Their contributions are invested in a designated balanced fund unless or until changed by the participant.

Employer Contributions:

Each year, the Sponsor contributes to the Plan an amount equal to 25% of the first 4% of each participant’s pre-tax contributions. Additional amounts may be contributed at the discretion of the Sponsor. No additional amounts were contributed for the year ended December 31, 2024.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Vesting

Participants are immediately vested in their own contributions plus earnings thereon. Vesting in each participant's employer matching account plus investment income earned thereon is based on years of service. A participant that reaches the early retirement date, as defined, becomes fully vested. If a participant becomes permanently disabled, or in the event of death, the participant becomes fully vested.

All participants who transferred in from the subsidiary of the Sponsor in connection with the asset transfers during the previous years, will carry-over their respective years of service from their former plan sponsor for purposes of vesting. In the event their prior plan's vesting schedule was more generous than the Mavis Plan's vesting, the prior schedule will be maintained for prior employer contributions. Vesting in future employer matching contributions is in accordance with the Mavis vesting schedule.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Sponsor's matching contribution, and (b) the participant's share of realized and unrealized gains (losses) on both Sponsor and employee contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, participants direct their contribution as well as employer contributions in investment accounts with common/collective trust funds, maintained by Reliance Trust Company ("Reliance", a subsidiary of State Street and Trust Company), and registered investment companies as identified in Note 3. Participants may change their investment options at any time.

Notes Receivable from Participants

The Plan makes loans to participants of amounts no less than \$500 that do not exceed the lesser of \$50,000 or 50% of the participant's vested individual account balance. Loan repayment terms range from one to five years, although a longer repayment period is allowed if loan proceeds are used for the purchase of a primary residence. Principal and interest are paid back to the Plan through weekly payroll deductions. At December 31, 2024 interest rates range from 4.25% to 9.50%.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits

Participants must receive their benefit in the form of a lump sum payment unless elected with their spouses' consent to receive installments over a certain period of time, not extending beyond the life expectancy of the participant or the joint life expectancy of the participant and the named beneficiary.

Participants who have attained age 59-1/2 may withdraw any portion of their vested account from the Plan. Participants who have not attained age 59-1/2 may only withdraw a portion of their employee contributions in the case of financial hardship as defined under the Plan.

In general, the payment of Plan benefits will be made as soon as practicable after the last day of the Plan year coinciding with the later of the date on which an employee attains retirement age or actually retires. Participants may however request the payment of benefits at any time after their termination of employment in which case payment will be made as soon as administratively feasible, provided the applicable consents are obtained.

Forfeited Accounts

Forfeitures of non-vested accounts are used to reduce employer contributions on a per pay period basis. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,767 and \$3,576, respectively. Also, in 2024, employer contributions were reduced by \$696,612 from forfeited non-vested accounts.

Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or partial termination of the Plan, participants' accounts shall be fully vested as of the date of such termination. The Sponsor determines the date and manner in which participants' accounts will be distributed in accordance with ERISA.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Sponsor without charge to the Plan.

NOTE 3 - CERTIFIED INVESTMENT INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

Effective January 1, 2025, the Plan changed its trustee from Reliance Trust Company to ADP Retirement Trust Services, LLC. ADP Retirement Trust Services, LLC and Reliance Trust Company entered into a sub-custodian agreement in which Reliance Trust Company will continue to be the custodian of the Plan's assets.

NOTE 4 - FAIR VALUE MEASUREMENTS (UNAUDITED)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan also utilizes a practical expedient to estimate the fair value of investments that have calculated net asset value (“NAV”) per share. Accordingly, the Plan estimates the fair value of an investment using the NAV of the investment (or its equivalent) without further adjustment unless the Plan determines that the NAV is deemed to be not reflective of fair value.

The three levels of the fair value hierarchy under the Financial Accounting Standards Board (“FASB”) ASC 820 - *Fair Value Measurement*, are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. In evaluating the level at which the Plan's investments have been classified, the Plan has assessed factors including, but not limited to price transparency, the ability to redeem at NAV at the year-end and the existence or absence of certain restrictions at year-end.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: Valued based on the NAV of the collective trust's/investment fund's underlying investments. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Generally, there are no restrictions on a participant's ability to redeem their investment in the common collective trust or collective investment fund. However, withdrawals prompted by certain events (e.g., termination of the managed income portfolio, changes in laws or regulations) may restrict a participant's ability to redeem the investment. The Plan Administrator does not believe that the occurrence of any such event is probable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require adjustment to or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of common/collective trust managed by Reliance, the trustee of the Plan. Accordingly, these transactions qualify as party in interest transactions.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
