NOTE A - DESCRIPTION OF PLAN

The following description of the Tanisha Systems Inc. (“The Company”) 401(k) (“The Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering all employees of the Company who are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute from 1% to 90% of pretax elective deferrals subject to annual limits announced by the Internal Revenue Service, or participants may make Roth Elective Deferrals as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may decide to also make a non-elective contribution to the Plan, although the Company is not required to do so. The non-elective contribution will be allocated to all employees eligible to participate in the Plan except certain higher-paid employees. Participants’ share of the non-elective contribution is in proportion to their eligible earnings compared to the eligible earnings of the other employees who will also share in the contribution. The nonelective contribution, if made, will be allocated as of the end of each Plan Year based on eligible earnings within the computation period. In addition, employees need to be employed on last day of the plan year and work 500 hours in the year to receive a non-elective contribution.

Top-Heavy Provisions - If the Plan becomes top-heavy under applicable Internal Revenue Service rules, the Plan would be required to provide for minimum contributions and top-heavy vesting. The minimum contribution is generally a contribution by the Company allocated to all non-Key Employees who are eligible Participants employed on the last day of the Plan Year equal to 3% of their eligible earnings (without regard to any exclusions from eligible earnings that the employer may have elected under the Plan) unless all key employees receive a contribution of less than 3% of their eligible earnings. The amount a participant contributes to the Plan as an Elective Deferral is not included in calculating the 3% minimum contribution which may be required but is included in determining the contribution made on behalf of key employees.

Participant Accounts - Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their Elective Deferral, Safe Harbor Matching, and Rollover (if any) contribution accounts.

Participants are vested in nonelective contributions and earnings thereon under the following vesting schedule:

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants can have up to 2 active loans at one time, only one of which may be a primary residence loan. The loans are secured by the balance in the participant's account and bear interest rate as published in The Wall Street Journal on the 14th of each month, plus 2%. Principal and interest are paid ratably through monthly payroll deductions.

Loans must be fully repaid through payroll deductions within 5 years unless the loan is used for the purchase of your primary residence. Loans used to purchase primary residence may be repaid within a period of no more than 30 years. Participants may prepay an outstanding loan in full, by certified check, at any time.

If participants terminate employment, any remaining payments are due immediately unless they are a party in interest. If they qualify as a party in interest they may continue to repay their loan after termination of Employment. If they do not repay the loan, the outstanding loan balance will be included in their gross income for federal income tax purposes as if it were distributed to them. If they die with an outstanding loan balance, their death will cause their loan to be in default, and their outstanding loan balance will be regarded as if it were distributed to them.

If participants enter into a period of military leave, their loan repayments will be suspended for the duration of their leave. If they enter into a leave of absence without pay, or at a rate of pay (after employment and income tax withholding) that is less than their required loan installments, their loan repayment obligation will be suspended for up to one year (or until the date the final loan payment is due, if earlier). If they do not resume repayments within any administrative grace period provided under the ADP Prototype Program after they return from a leave of absence (or when the suspension of their repayment obligation ends, if earlier, as explained in this paragraph), their loan will be in default and will be included in their gross income for federal income tax purposes as if it were distributed to them.

NOTE A - DESCRIPTION OF PLAN (Continued)

Distributions - Participant accounts are distributable, in full or as partial withdrawals, in the form of a lump sum payment or substantially equal installments of cash or in whole shares of Company securities as elected by the participant upon retirement, termination of employment, death, disability, financial hardship, attainment of age 59-1/2, or if a qualified reservist is called to active military duty. Participant account balances of less than \$5,000 are automatically distributed in a single lump sum. In addition, participant accounts can be rolled over into an individual retirement account ("IRA") or another qualified defined contribution plan. Participant distributions may not be deferred past April 1 of the calendar year following the year in which the participant attains age 72.

Forfeited Accounts - If participants terminate employment before becoming 100% vested in their account balance but do not take a distribution from the Plan, the non-vested portion of their account balance will be forfeited as of the date the participant has five consecutive Breaks in Service. These accounts will be used to reduce future employer contributions and reimbursement of professional fees.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the plan are prepared on the accrual basis of accounting.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes receivable from participants - Loans receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits - Benefits are recorded when paid except for any excess contributions payable to participants, which are recorded as they become payable.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties - The Plan provides for various investment options in a combination of different investment securities. The Plan's investments are exposed to various risks, including, but not limited to, interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are not reflected within the financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) of the fair value of investments.

Subsequent Events - Subsequent events were evaluated through, October 13, 2025, which is the date the financial statements were available to be issued.

NOTE C- INVESTMENT CERTIFICATION BY TRUSTEE

The following is a summary of the unaudited information regarding the Plan. The Plan administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Reliance Trust Company has certified the completeness and accuracy of all investments and related investment activity in the accompanying financial statements and in the supplemental schedule of assets (held at end of year) and the supplemental schedule of reportable transactions.

NOTE D - INVESTMENTS AND FAIR-VALUE MEASUREMENT

The Plan accounts for certain assets and liabilities at fair value. The hierarchy below lists three levels of fair value based on the extent to which inputs used in measuring fair value are observable in the market. The Plan categorizes each of our fair value measurements in one of these three levels based on the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 - Quoted prices available in active markets for identical investments as of the reporting date.

Level 2 - Observable inputs to the valuation methodology are other than Level 1 inputs, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies. Quoted prices for *similar* instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; and model-derived valuations the significant inputs for which are observable.

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability, and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Mutual funds/Money market fund: Valued at the net asset value of shares held by the Plan at year-end. Accordingly, the following table presents for each of these hierarchy levels, the Plan's financial assets that are measured at fair value on a recurring basis at December 31, 2024 and 2023:

NOTES TO FINANCIAL STATEMENTS****NOTE E – INVESTMENT IN FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (FBRIC) – STABLE VALUE FUND**

The Plan invests in the Invesco Stable Asset Fund (“ISAF”), a collective trust fund within the Invesco Stable Asset Trust (“ISAT”), which is classified as a fully benefit-responsive investment contract (FBRIC). These contracts are designed to provide capital preservation and a stable return over time, and are reported at contract value in accordance with FASB ASC 962-325-35-5 and ASU 2015-12.

Contract value is the relevant measurement for FBRICs because it is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The ISAF credits interest to participants and allows for withdrawals at contract value, subject to certain restrictions.

The ISAF invests in a diversified portfolio of fixed income securities and wraps these investments with contracts issued by highly rated financial institutions to provide book value accounting and liquidity. The crediting rate is determined periodically and reflects the performance of the underlying assets, adjusted for amortization of gains and losses over the duration of the portfolio. As of December 31, 2024 and 2023, the investment in ISAF was valued at \$580,464 and \$384,489, respectively, which approximates fair value due to the fully benefit-responsive nature of the contract. There were no events during the reporting period that would limit the ability of the Plan to transact at contract value with the ISAF.

The ISAF is not registered with the SEC and is valued using the net asset value (NAV) provided by the trustee, which is used as a practical expedient for fair value measurement under ASC 820.

NOTE F – EXCESS CONTRIBUTIONS PAYABLE

During the plan year, certain participants contributed amounts that exceeded the annual limits established by the Internal Revenue Code (IRC) Section 402(g) and/or failed nondiscrimination testing under IRC Sections 401(k) and 401(m). These excess contributions have been identified through the plan’s annual compliance testing procedures.

As of December 31, 2023, excess contributions totaling \$6,790 have been recorded as a liability under “Excess Contributions Payable.” These amounts were refunded to the affected participants in 2024, along with applicable earnings or losses, in accordance with IRS regulations.

The plan administrator has procedures in place to monitor contribution limits and ensure timely correction of any excess amounts. As of December 31, 2024, there were no excess contributions payable.

NOTE H – TAX STATUS

The Plan Sponsor entered into a non-standardized arrangement of the ADP, LLC, Non-Standardized Pre-Approved Profit-Sharing/Money Purchase/CODA. ADP, LLC has received an opinion letter from the Internal Revenue Service (“IRS”) which stated that the form of the non-standardized pre-approved profit-sharing plan and related trust was designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). It is the opinion of the Plan trustee and the Plan’s attorney that the Plan is in compliance with all applicable laws and regulations.

U.S. generally accepted accounting principles require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company, the participants, Reliance Trust Company, the trustee, ADP Retirement Services, the third-party plan administrator, and ADP the payroll service company, have all been identified as parties-in-interest. The Plan invests in shares of mutual funds, and a stable value fund managed by the trustee. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Participant loans also qualify as party-in-interest and related party transactions, which are exempt from the prohibited transaction rules. Certain administrative expenses of the Plan are paid by the Company and qualify as party-in-interest transactions. The Company has a Master Service Agreement with the Trustee. The Plan pays for the services of the trustee through net fees charged to the participants in the Plan.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
