## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. DESCRIPTION OF PLAN**

The following description of Walker Manufacturing Group LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Interested parties should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing and 401(k) plan covering eligible employees of Walker West LLC and Walker Midwest LLC, single member limited liability companies wholly owned by Walker Manufacturing Group LLC (the Company). Employees who have completed six months of service and attained age 21 are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for oversight of the Plan.

Contributions

The Plan is funded by voluntary traditional and Roth contributions of participants and discretionary matching and profit sharing contributions of the Company. Participants may contribute to the Plan, through regular payroll deductions, an amount subject to annual limitations imposed by the Internal Revenue Service. The limit is \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, up to \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan and may change their investment options at any time.

The Company may make discretionary matching and profit sharing contributions to the Plan. Matching contributions are equal to a percentage of each participant's elective deferral as determined by the Company each year. During the year ended December 31, 2024, the Company made discretionary matching contributions to the Plan totaling \$105,538, net of forfeitures. Matching contributions are allocated into the same investments and at the current investment percentages as selected by each participant.

Profit sharing contributions allocated to participants are equal to the percentage of each participant's compensation to the total compensation of all participants eligible to share in the Company's discretionary profit sharing contribution. To be eligible to share in the contribution, participants must complete 1,000 hours of service during the Plan year and be employed by the Company on the last day of the Plan year, except in the Plan year of the participant's death, disability, or termination after attaining normal retirement age or reaching the early retirement date, as defined in the Plan. During the year ended December 31, 2024, the Company elected to not make a discretionary profit sharing contribution to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as allocations of the Company's matching and profit sharing contributions and Plan earnings, allocated in direct proportion to their respective account balances based on the performance of the participant's investment selections. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of administrative expenses are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. DESCRIPTION OF PLAN (CONTINUED)**

Vesting

Participants are immediately fully vested in their contributions plus actual earnings thereon. The portion of each participant's accounts attributable to the Company's contributions becomes 20% vested after one year of service and continues to vest at the rate of 20% for each successive year until fully vested after five years of service.

Upon death, disability, or retirement, as defined in the Plan (attaining age 65 for normal retirement, or age 55 and completion of ten years of service for early retirement), while employed by the Company, participants become fully vested in their employer matching and profit sharing contributions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a single, lump-sum payment; a series of installment payments over a specified period of time; or a direct rollover distribution equal to the value of his or her vested account balance. In-service withdrawals are permitted upon attaining 59-1/2 years of age. Hardship withdrawals, as described in the Plan, are also permitted.

Participant Loans

Participants may borrow from their 401(k) accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Participants may have no more than two loans outstanding. The loans are secured by the balance in the participant's account, and bear interest at the prime rate, existing at the time the loan is funded, plus 1%. Principal and interest are paid through payroll deductions over a period not to exceed five years. Longer terms may be permitted if the loan is used for the purchase of the participant's primary residence.

Forfeitures

As of December 31, 2024 and 2023, unallocated plan assets resulting from forfeited nonvested accounts totaled \$4,955 and \$1,200, respectively. During 2024, forfeitures totaling \$16,831 were used to reduce the Company's contributions.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, the notes bear interest at rates ranging from 4.25% to 10.25%. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses as incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions

Contributions are recorded on the accrual basis.

Benefits Paid to Participants

Benefits paid to participants, including payments made to designated beneficiaries, are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

**3. CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, trustee of the Plan.

During 2024, the Plan's investments (including investments bought, sold, and held during the year) appreciated in value by \$612,356.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan pays administrative fees and expenses to Automatic Data Processing, Inc. (ADP), the Plan's third-party administrator. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. During 2024, the Plan made direct payments to ADP totaling \$18,173 for recordkeeping and administrative services. The Company pays substantially all other expenses related to the Plan's operations.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

**7. TAX STATUS**

Effective January 20, 2014, the Plan operates under the provisions of ADP's Prototype 401(k) and Profit Sharing Plan, as amended and restated. The IRS has determined and informed ADP by letter dated October 6, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Effective July 1, 2022, the Plan was amended and restated to bring it into compliance with the Pension Protection Act of 2006 and other legislative and regulatory changes.

The provisions of the Plan do not vary from the prototype plan. Accordingly, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and that the related trust is tax exempt.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
