Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Recorded Books Inc. 401(k) Savings Plan, an employee benefit plan subject to Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Recorded Books Inc. 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of Plan

General

Recorded Books, Inc. 401(k) Savings Plan (the Plan) is a defined contribution plan pursuant to the provisions of Section 401(k) of the Internal Revenue Code (the Code) established for employees of Recorded Books, Inc. (the Company or Plan Sponsor). Employees are eligible to participate in the Plan upon the attainment of twenty-one years of age. The Plan became effective on February 1, 2014, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following provides only general information about the Plan. A complete description of the Plan is contained in the Plan Document and the Adoption Agreement, which govern the operation of the Plan.

During May 2016, the Plan rolled its funds into an investment platform with Automatic Data Processing (ADP) that offers different investment options. Also during 2016, the Plan Sponsor acquired two companies, Tantor Media and Christian Audio. The employees of these companies were immediately eligible to participate in the Plan. Christian Audio ceased operations in May 2019. In 2021, the Plan acquired two companies, Graphic Audio and Potomac Talking Books, Inc. The employees of these companies were immediately eligible to participate in the Plan. In 2024, the Plan acquired Dreamscape Publishing. The employees of this company were immediately eligible to participate in the Plan and their assets were transferred into the Recorded Books, Inc. 401(k) Savings Plan.

During 2023, the Plan Sponsor was sold to new investors. This sale did not change the operations of the Plan Sponsor or the Plan.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, which became effective in 2023, 2024 and beyond.

Contributions

Participants may contribute up to 90% of their compensation (6% for highly compensated employees) not to exceed the limits of Code Sections 401(k), 402(g), 404 and 415 (\$23,000 and \$22,500 for 2024 and 2023). Participants who are age 50 or older may make additional catch up contributions up to the maximum amount allowed (\$7,500 in 2024 and 2023). The Company makes matching contributions equal to 50% of a participant's elective deferrals. The matching percentage is applied on up to 6% of a participant's eligible compensation. The Company may decide to make non-elective contributions to the Plan, although the Company is not required to do so. No non-elective contributions were made in 2024 or 2023. An employee who is eligible under the Plan must be employed for one year in order to receive an employer contribution. Employer matching contributions were \$440,549 and \$768,847 for the years ended December 31, 2024 and 2023, respectively. Participant deferral contributions were \$1,733,873 and \$2,681,309 and participant rollover contributions were \$1,211,601 and \$47,148 for the years ended December 31, 2024 and 2023, respectively.

Contributions (Concluded)

Each participant's account is credited with the participant's contributions and earnings on these contributions. Allocation of investment earnings is based on the specific investment and account balances and is allocated based on the proportion of each participant's account balance as it bears to all participant account balances in that particular investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are immediately vested in their salary deferral and rollover contributions. At December 31, 2024 and 2023, the vesting of employer matching contributions and non-elective contributions is as follows:

Forfeited Accounts

These amounts may be used to reduce Company contributions, pay Plan expenses or be reallocated to participants. During 2024 and 2023, respectively, \$25,991 and \$8,910 of forfeited nonvested accounts were used to reduce Company contributions. There were \$8,927 and \$10,013 of available forfeitures at December 31, 2024 and 2023, respectively.

Investment Elections

Participants may elect to have their contributions invested in various investment options offered by the Plan's trustee.

Benefit Payments

The Plan provides for benefit payments upon termination, death, disability, after obtaining age 59 ½ and after obtaining the normal retirement age of 65, based on the vested balance in the participant's account. Hardship withdrawals and participant loans are also permitted, if certain conditions are met, as outlined in the Plan Document. Benefit payments are recorded when paid. Amounts included in net assets available for plan benefits, which are allocated to accounts of terminated participants who have withdrawn from the Plan, were not significant as of December 31, 2024 or 2023.

Notes Receivable from Participants

Participants may borrow up to one-half of their vested accrued benefit with a maximum of \$50,000. The loans are secured by an assignment of a portion of the participant's vested account balance and bear interest at a reasonable rate which is commensurate with local prevailing rates as determined by the Plan administrator. Loans are generally repaid within five years. However, principal residence loans may allow for a longer repayment term.

Administrative Expenses

Certain costs of the Plan were paid by the Company, while other administrative costs of the Plan were paid from the assets of the Plan and allocated to the Plan's participants.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis in conformity with accounting principals generally accepted in the United States of America (U.S. GAAP).

Investments

The Plan's investments in registered investment companies are stated at fair value using quoted market prices. Investments in common/collective trusts are presented at net asset value as determined by Reliance Trust Company. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 3. Income Tax Status

The Plan has adopted a prototype plan designed by ADP. The prototype plan obtained its latest opinion letter on October 6, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 401 of the Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 3. Income Tax Status (Concluded)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize an adjustment to taxable income if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the taxing authorities. The Plan sponsor has analyzed the tax positions taken by the Plan, and is not aware of any uncertain tax positions that would require an adjustment to taxable income or disclosure in the financial statements as of December 31, 2024 and 2023.

The Plan is subject to routine audits by governmental agencies; however, there are no audits in progress for any tax period.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification 820 (ASC 820) *Fair Value Measurement*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of inputs other than quoted prices in an active market that are observable, and Level 3 inputs are unobservable and significant to the fair value measurements, and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

Level 1 Fair Value Measurements

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission.

These funds are required to publish their daily fair value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts

The fair value of common/collective trusts (stable return fund) is based on accumulated units of investments in separate investment accounts held by the Plan at year-end.

The Plan Sponsor is responsible for the determination of fair value. Accordingly, the Plan Sponsor performs periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the Plan Sponsor has not historically adjusted the prices obtained from the pricing services. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of difference methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 9. Administration of Plan Assets

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan. All administrative expenses are paid by the Company or the Plan.

Note 10. Exempt Party-In-Interest Transactions

Certain transactions that are considered exempt party-in-interest transactions relate to normal management and administrative services, and the payment of expenses related thereto. Certain Plan investments are managed by Reliance Trust Company, the trustee of the Plan and a party-in-interest to the Plan. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Note 11. Subsequent Events

The Plan has evaluated events through October 8, 2025, the date that the financial statements were available to be issued and determined that no event occurred subsequent to December 31, 2024 that would require recognition or disclosure in these financial statements.
