To the Administrator and Participants of the
Summit Advisor Services LLC Employee 401(K) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Summit Advisor Services LLC Employee 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF THE PLAN

The following brief description of the Summit Advisor Services LLC Employee 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a participant directed defined contribution plan which was originally established on June 10, 1989. The Plan is sponsored by Summit Financial, LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

ADP Retirement Services (“ADP”) is the Plan Administrator (“Plan Administrator”) and record-keeper.

The investment assets of the Plan are held and invested by Reliance Trust Company (“RTC” or “Trustee”) who serves as the trustee of the Plan (See Note 3).

Eligibility – Any employee of the Company is eligible to participate in the Plan after they have completed three consecutive months of service, and have also achieved the age of 21. An eligible employee becomes a participant effective immediately after satisfying the eligibility requirements.

Contributions – Each year, participants may contribute up to ninety percent of pre-tax annual compensation, as defined in the Plan. From time to time the pretax contributions of certain employees, designated as highly compensated employees under Internal Revenue Code (“IRC”) rules, may be limited so that the Plan may satisfy various nondiscrimination tests required under applicable Federal regulations. Also, in accordance with Internal Revenue Service (“IRS”) guidelines, participants could not make contributions exceeding \$23,000 during 2024. Certain eligible participants (age 50 and over) are permitted to contribute an additional \$7,500 as catch-up contributions, resulting in a total pre-tax contribution of \$30,500 for 2024.

The Plan permits Company matching contributions in accordance with the terms of the Plan agreement. For the year ended December 31, 2024, Company’s matching contributions totaled \$445,600.

The Company may make an employer discretionary profit-sharing contribution in an amount determined by the board of directors. Profit-sharing contributions shall be allocated to each eligible participant pursuant to the Plan agreement. There was no profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts – A separate account is maintained for each participant. Each participant’s account is credited with his or her contribution; any Company contributions, an allocation of Plan earnings or losses and charged with an allocation of any administrative expenses paid by the Plan. Allocations of earnings or losses are based upon the investment performance of the individual funds in which each participant’s account balance is invested. Allocations of expenses are based upon account balances, as defined in the Plan agreement. Participants may change their investment elections at any time through the Plan’s record-keeper. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments – Participants may direct the investment of their contributions and the Company’s matching contributions into one or more formal investment options offered by the Plan, including various mutual funds.

Rollovers – Rollover contributions are permitted into the Plan in accordance with IRS regulations and Plan provisions.

Vesting – Vesting in employer matching and profit-sharing contributions and related earnings or losses are based on years of continuous service as follows:

Less than 2 years of service	--%

After 5 years of service	80%
After 6 years of service	100%

A participant will be 100% vested in the Company's contributions if he or she attains age 65, incurs a total and permanent disability or dies while employed by the Company.

Notes Receivable from Participants – Participants may borrow from their individual account balances in accordance with the Plan's provisions. The maximum amount of any loan is the lesser of (a) \$50,000 or (b) one-half the value of the participant's vested account but not less than \$1,000. Loans are collateralized by the participant's vested account. All loans bear an interest rate as determined by the Plan Administrator and must be repaid in five years unless used for the purchase of the participant's principal residence (for which the administrator may permit a longer repayment term). Notes receivable outstanding have interest rates ranging from 4.25% to 9.50% and have maturity dates through July 2030. Upon termination of employment, the participant may either repay any outstanding balance in full or incur a tax liability on the unpaid balance. Principal and interest is paid ratably through bimonthly payroll deductions.

Benefit Payments – Under the Plan, normal retirement age is 65. On termination of service due to death, disability or retirement, a participant shall be considered 100% vested and may receive a lump-sum amount equal to the value of the participant's vested account balance, partial withdrawal, or substantially equal installments. If the balance of the vested benefit exceeds \$5,000, the participant must consent to the distribution before it is made. If the balance of the vested benefit does not exceed \$5,000, the lump sum distribution will be made as soon as practicable following the event. Prior to age 65, in-service withdrawals from the Plan are allowed for unusual hardship or upon attaining the age of 59 1/2. In the event a participant's employment is terminated, the participant's accumulated vested benefits will be distributed to the participant in accordance with the provisions of the Plan.

Forfeited Accounts – Forfeited balances of participants' non-vested accounts are used to reduce administrative expenses of the Plan or to reduce future employer contributions. For the year ended December 31, 2024, \$40,001 in forfeitures were utilized to reduce employer contributions. At December 31, 2024 and 2023, unallocated forfeitures totaled \$10 and \$595, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates – The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for description of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan document.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Expenses attributable to the administration or operation of the Plan are allocated pro rata on the basis of participant account balances to the account balances of all participants. Investment related expenses are included in the net appreciation of fair value of investments.

Benefit Payments – Benefits to participants are recorded when paid.

3. INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by RTC, except for comparing such information certified by the Trustee with information included in the Plan's financial statements and supplemental schedule of Form 5500, Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 — Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchanges Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. FEDERAL INCOME TAX STATUS

The Plan adopted a prototype non-standardized 401(k) profit-sharing plan, which received a favorable opinion letter from the IRS on October 6, 2020, which states that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

ADP is the record-keeper for the Plan. The Plan incurred administrative expenses with ADP amounting to \$3,322 for the year ended December 31, 2024. Loans to participants are secured by the balances in the respective participant accounts. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

7. PLAN TERMINATION

Although the Company has not expressed any intention to do so, the Company reserves the rights under the Plan to modify, suspend, amend or terminate the Plan in whole or in part at any time subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the employer contribution accounts of all participants become fully vested.

8. RISK AND UNCERTAINTIES

The Plan invests in various investment securities, including mutual funds. Investment securities are exposed to various risks, such as interest rate, market and credit risks that may be impacted by external financial, business and other factors including economic downturns, natural disasters, geopolitical conflicts or pandemic illness. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the values of investment securities will occur in the near term and, that such changes could materially affect amounts reported in the statement of net assets available for benefits. Additionally, the investments the Plan invests in may change their distribution or dividend policies, which could have an effect on the value of the investment securities.

The Plan's exposure to a concentration of credit risk is limited by the opportunity to diversify investments across multiple participant-directed fund elections including active and passively managed funds covering multiple asset classes. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

9. SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Setting Every Community Up for Retirement Enhancement ("SECURE") Act 2.0. The SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Since the SECURE Act 2.0 provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required. The Plan Administrator did not adopt any of the optional provisions for 2024 and accordingly, there was no material impact on the Plan's 2024 financial statements.

10. SUBSEQUENT EVENTS

The Company has evaluated subsequent events through October 8, 2025, the date which the financial statements were available to be issued. Based upon that evaluation, the Company has determined that no subsequent events have occurred which would require disclosure in or adjustment to the financial statements.

11. RECONCILIATION TO FORM 5500

No material differences exist between the Form 5500 and the financial statements.
