## INDEPENDENT AUDITORS' REPORT

### To the Plan Administrator of the YAM Management 401(k) Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of YAM Management 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of YAM Management 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ### NOTE 1 – DESCRIPTION OF PLAN

The following description of the YAM Management 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan was established on October 1, 2013 and restated on June 23, 2022. The Plan is a defined contribution plan covering all eligible employees of YAM Management, LLC and various affiliates (collectively the “Employer”). The Plan is a contributory plan under sections 401(a) and 401(k) of the Internal Revenue Code (“IRC”) and subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2023, the plan was amended to increase the annual automatic deferral escalation limit from 10% to 15%.

#### Eligibility

All eligible employees may participate in the Plan after completing two months of service and upon attaining the age of 18. Individuals considered to be independent contractors who are later determined by the Internal Revenue Service (“IRS”) to be employees, shall continue to be excluded following the reclassification date.

#### Contributions

The participants are automatically enrolled to defer 5% of their compensation once they become eligible to participate in the Plan with scheduled 1% annual increases up to a maximum 15%. Subsequently, they can make an election to defer up to 90% of their compensation up to the maximum deferral limit per Section 402(g)(1) of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make “catch-up” contributions. The Employer may make discretionary matching contributions equal to a percentage of the participant’s deferral contributions. 401(k) elective deferrals over the percentage chosen by the Employer are not matched. During the year ended December 31, 2024, the Employer made matching contributions equal to 50% of the first 5% of deferred compensation calculated based on deferrals for the payroll period and subject to an annual compensation limit.

#### Rollovers

Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions, rollovers and Employer matching contribution and allocations of Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### NOTE 1 – DESCRIPTION OF PLAN (continued)

##### Investment Options

Participants direct the investment of employee and Employer contributions into various investment options offered by the Plan and held by Reliance Trust Company (the “Trustee”). Participants may change their investments options daily.

##### Vesting

Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Vesting in the Employer matching contribution portion of their accounts is based on years of service. A participant with less than one year of service has 0% vesting and becomes 100% vested once they are credited with one year or more of service.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at rates equal to the prime rate as published in the Wall Street Journal on the 14<sup>th</sup> day of each month plus 1%. Loans are generally payable in installments over periods of up to five years. Principal and interest payments are paid through payroll deductions and are allocated to the participant’s account. A participant may only have one loan outstanding at the time and apply for only one loan in a 12-month period.

##### Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant or participant’s beneficiary is entitled to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. If the participant’s vested account balance is between \$1,000 and \$5,000 the Plan automatically rolls the vested account balance to an Individual Retirement Account (“IRA”) in a direct rollover, if the participant is under 65 years of age, and did not elect any other form of distribution. In addition, participants may receive distributions upon attaining age 59 ½ or for financial hardship if certain criteria are met.

#### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Forfeited Accounts

Forfeitures attributable to excess matching contributions may be used to pay reasonable Plan expenses or to fund Employer contributions. For the year ended December 31, 2024, the forfeiture account was used to reduce Employer contributions by \$72,263. Outstanding forfeitures available at December 31, 2024 and 2023 were not significant.

##### Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, participants will become 100% vested with respect to Employer contributions.

##### Plan Administration

The Employer is the Plan sponsor and the Plan administrator and responsible for carrying out the duties imposed under ERISA.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

Basis of Presentation

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on terms of the Plan agreement. No allowance has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Employer pays a portion of the administrative expenses of the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

Financial Instruments: Credit Losses

As of January 1, 2023, the Plan adopted Accounting Standards Codification (“ASC”) Topic 326, *Financial Instruments: Credit Losses*, using a modified-retrospective approach. The standard replaces the previous incurred loss model and requires entities to record an estimate of expected losses on financial assets for the remaining estimated life of the asset. This estimate must include consideration of historical experience, current and reasonable and supportable forecasts. The standard applies to the Plan’s employee and Employer contributions receivable, if any. The implementation of the standard did not have a material impact to the Plan’s financial statements.

There was no allowance for credit losses as of December 31, 2024.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (“FASB”) ASC 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the report date.

### NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the Trustee, as complete and accurate, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental schedule.

### NOTE 5 – TAX STATUS

The Employer adopted a non-standardized pre-approved profit sharing plan ("pre-approved plan"), which received a favorable opinion letter from the IRS dated October 6, 2020, which stated the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's advisors believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Administration errors, if any, that are insignificant or operational in nature, are handled by the Plan administrator in accordance with applicable IRS correction policies. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **NOTE 5 – TAX STATUS (continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Trustee is considered a party-in-interest with respect to the Plan. All investments are held with the Trustee. Notes receivable from participants and the related interest income are also considered party-in-interest transactions.

#### **NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **NOTE 8 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.
