### Note 1: Description of Plan

The following description of the Alma Lasers Inc. 401(k) Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan, as amended and restated effective January 1, 2022, is a defined contribution plan for eligible employees of Alma Lasers, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility

Eligible employees include all employees of the Company over the age of 21, who are not union employees, nonresident aliens, or residents of Puerto Rico, and not Code §410(b)(6)(C) employees, as defined. Employees are eligible to participate in the Plan the first day of the month following the completion of the eligibility requirements.

#### Contributions

Each year, participants may contribute from 1% to 85% of their eligible compensation, as defined by the Plan, on either a pretax deferral basis or on an after tax (Roth) deferral basis, not to exceed the maximum amount allowed by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan provides for the Company to make safe harbor matching contributions equal to 100% of the participant's deferrals up to 4% of a participant's eligible compensation. Company safe harbor contributions were \$938,986, net of \$17 in forfeitures, for the year ended December 31, 2024.

In addition, the Plan provides for the Company to make a discretionary profit-sharing contribution to be allocated to participant accounts based on the ratio of the participant's compensation to total compensation for all eligible participants. The Company did not make any discretionary profit-sharing contributions for the year ended December 31, 2024.

Participants direct the investment of the contributions to their account into various investment options offered by the Plan.

### **Note 1: Description of Plan** (Continued)

#### **Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's voluntary salary deferrals and rollover contributions, the Company's safe harbor matching contributions, and an allocation of (a) the Company's discretionary profit sharing contribution, if any, and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their voluntary contributions and Company safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions, if any, plus actual earnings thereon, is based on years of continuous service. Participants vest at a rate of 20% per year beginning with their second year of service and become fully vested after six years of service. Participants are immediately fully vested upon normal retirement age, death or permanent disability.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. A participant may have only one note outstanding at any given time. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably primarily through payroll deductions over a term of one to five years, unless the borrowings are used to acquire a principal residence, at which time the note can be repaid over a reasonable period of time not to exceed thirty years. Interest rates on notes receivable from participants outstanding at December 31, 2024 ranged from 5.25% to 10.50%.

#### **Forfeitures**

Forfeitures of nonvested accounts amounted to \$0 and \$10 at December 31, 2024 and 2023, respectively. Forfeitures may be used to reduce future Company contributions or to pay Plan expenses in accordance with the Plan document. During 2024, forfeitures of \$17 were used to reduce Company contributions.

### **Note 1: Description of Plan** (Continued)

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, or for other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum, substantially equal installments, or partial withdrawals provided the minimum withdrawal is \$500. In addition, hardship distributions out of the participant's vested account balance are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. At December 31, 2024 and 2023, there were no amounts owed to former participants whose employment had been terminated and who requested payout of their account balances.

#### **SECURE 2.0 Act**

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for Plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Plan management has evaluated those provisions and determined there is no material impact on the Plan for the years ended December 31, 2024 and 2023. Plan management will determine which optional provisions, if any to elect in the future.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for disclosure of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefit payments are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included as a reduction in net appreciation in fair value of investments.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of terms of the Plan document.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the ADP Retirement Trust Services, LLC replaced Reliance Trust Company, as Plan Trustee. Additionally, the Plan was amended to allow a participant to have up to two notes receivable outstanding at any given time.

### **Note 3: Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted market prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 4: Information Prepared and Certified by Trustee

Fees incurred and paid by the Plan for administrative expenses aggregated \$33,301 for the year ended December 31, 2024. In addition, certain administrative functions are performed by employees of the Company, for which no compensation is received from the Plan for their services.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 7: Tax Status

The Company has adopted a Prototype Non-standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan (Prototype Plan) sponsored by ADP, LLC. The Prototype Plan obtained its latest determination letter on October 6, 2020, in which the IRS stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC) and has no income subject to unrelated business income tax. The Plan has not requested its own IRS determination letter. The Plan has been amended since receiving the determination letter; however, the Plan administrator believes the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### Note 8: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary contributions.
