For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of the Plan

The following description of the K&M Casinos Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement and amendments for a more complete description of the plan provisions.

General

The Plan was established on January 1, 2015 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Internal Revenue Code. It is a defined contribution plan and voluntary contribution plan for the benefit of all employees of K&M Casinos Inc. (the Company).

Plan Administration

The Plan is administered by K&M Casinos Inc. The current trustee and custodian for the Plan is Reliance Trust Company and ADP Retirement Services as third-party administrator to process and maintain the records of participant data.

Participants Eligibility

All employees of the Company are eligible to participate in the Plan upon employment except union, non-resident aliens and leased employees. The Plan provides eligible employees who are at least 21 years of age and have completed one year of eligibility service. A year of eligibility service is accomplished after completing 1,000 hours of service during first 12 months of employment.

Participants Contributions

Employee contributions to the Plan (voluntary contributions) are deferrals of the employee’s compensation made through a direct reduction of compensation in each payroll period. Each year, participants may contribute from 1% to 90% of their eligible earnings, as defined by the Plan, subject to limitations established by the Internal Revenue Code. For the tax year 2024, the maximum allowed deferral amount was \$23,000. Participants over the age of 50 may also contribute an additional \$7,500 to the Plan for 2024.

Employer Contributions and Vesting

The Company may decide to make non-elective contributions to the plan at its discretion and will be allocated to all eligible participants who completed at least 500 hours of service during the year. For the years 2024 and 2023, there was no non-elective contribution made by the Company.

1. Description of the Plan – (Continued)

Employer Contributions and Vesting

The Company will make a safe harbor matching contribution equal to 100% on the first 3% of participants elective deferrals and an additional 50% on the next 2% of elective deferrals of eligible earnings. Safe harbor matching contributions will be made each pay period.

Each participant's interest in voluntary contributions is vested immediately, including earnings thereon. Matching contributions are vested in accordance with the plan's vesting schedule;

Participant Accounts

Each participant's account is credited with participant's contributions, the Company's discretionary contributions, and earnings thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which participant is entitled is the benefit that can be provided from the participant's vested account.

Rollover

Employees may roll over eligible amounts from other tax-qualified employer-sponsor retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Investments Options

The Plan provides for investments to be directed by participants into a number of investment options held by the Trustee. Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options and may change their investment options at any time.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant will be paid the vested interest in his account in lump sum as soon as administratively feasible. If the vested interest is \$5,000 or less, the Plan administrator will authorize the benefit payment without the participant's consent.

Administrative Expenses

Certain administrative fees are paid by the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. However, the \$50,000 amount in the preceding sentence is reduced by the highest outstanding loan balance under the Plan during the previous one-year period. The notes are secured by the balance in the participant's account and bear interest rates that is prime rate plus 2 percentage points based upon the prime rate as reported by The Wall Street Journal. Loans must be fully repaid through payroll deductions within 5 years unless the loan is used for the purchase of primary residence which may be repaid within a period of no more than 30 years.

Forfeitures

Forfeitures are the non-vested portion of participants' account that are lost upon termination of employment. Forfeitures are first used to pay administrative expenses and any remaining balance is used to reduce employer contributions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate, amend or modify the Plan at any time by resolution of its Board of Directors or the Committee and subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The participant loans are valued at their outstanding balances, which approximates fair value.

Purchase and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investment bought or sold as well as held during the year.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative expenses

The Plan’s expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Notes Receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as liability.

Net Appreciation in Fair Value of Investments

Net appreciation in fair value of investments, as recorded in the accompanying statement of changes in net assets available for benefits, includes changes in the fair value of investments acquired, sold, or held during the year.

Risks and Uncertainties

The Plan provides for various investment options in any combination of equity, fixed income, and other investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

3. Fair Value Measurements

Fair Value Measurements provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements);

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

- Level 2 Inputs to the valuation methodology include
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 - If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common collective investment trust are funds based upon the redemption price of units held by the Plan, which is based on the current net asset value (NAV) of the common collective trust fund's underlying assets. Unit values are determined by the financial institution sponsoring such funds by dividing the net assets by its units outstanding at the valuation dates.

Cash and cash equivalents are valued based on cost, which approximates fair value in a non-inflationary economy and are protected by the FDIC.

Mutual funds and money market are categorized as Level 1 and are priced, and trades are executed at Money Market Funds the published net asset value daily, or the public offering price for accounts trading under rights of accumulation (ROA).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial Instruments could result in a different fair value measurement at the reporting date.

4. Income Tax Status

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

GAAP requires the plan administrator to evaluate uncertain tax positions taken by the Plan. The financial statements effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

5. Information Prepared and Certified by Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental Schedule of Assets (Held at End of Year), including investments held and notes receivable from participants at December 31, 2024 and 2023, interest, dividends, net appreciation/depreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the Plan Administrator and certified as complete and accurate by Reliance Trust Company, the Trustee and Custodian of the Plan.

6. Party in interest Transactions

The Plan investments are managed by Reliance Trust Company, the trustee and custodian of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provision of the Plan and are especially exempt from the prohibition of party-in-interest transactions under ERISA.

Party-in-interest transactions under ERISA also include notes receivable from participants and are exempt from the prohibited transaction rules under ERISA.

7. Excess Contributions Payable

The Plan is required to return contributions to participants in the event certain non-discrimination tests defined under the IRC are not satisfied. At December 31, 2024, there is no refundable amount by the Plan to participants for contributions made in excess of amount allowed by the Internal Revenue Service.
