Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Quality Management Resources, Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO THE FINANCIAL STATEMENTS

NOTE 1: DESCRIPTION OF PLAN

The following description of Quality Management Resources, Inc. 401(k) Profit Sharing Plan & Trust provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a) General
The Plan is a defined contribution plan covering employees, excluding collectively bargained employees, who have attained age twenty. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b) Contributions – Participants
A participant may make contributions to the Plan of up to 90% of compensation with certain IRS limitations adjusted annually for inflation. Each eligible participant will be automatically enrolled in the plan.
- c) Contributions – Employer
Employer contributions to the Plan are at the discretion of the Company's owners and are based on each eligible participant's elective deferrals. Contributions are subject to certain limitations. Eligible participants include only those employed on the last day of the plan year.
- d) Participant Accounts
Each participant's account is credited with the participant's and employer's contributions and earnings on participant account balances.
- e) Vesting
Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service as shown below:

- f) Investment Options
Upon enrollment in the Plan, a participant may direct employee and employer contributions in various investment options. Participants may change their investment options anytime using the record-keeper's website.

NOTE 1: DESCRIPTION OF PLAN *(continued)*

g) Payment of Benefits

On termination of services, a participant may elect to receive a distribution of all or any part of his or her vested account balance as soon as administratively feasible.

h) Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$834 and \$774, respectively. These accounts will be used to reduce future employer contributions and administrative expenses. In 2024 and 2023, there were no reductions to the forfeited non-vested accounts.

i) Participant Notes Receivable

The Plan allows a maximum of one loan outstanding to each participant. Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Plan administrator will establish a reasonable rate of interest, which will provide the Plan with a return comparable to the rates being charged by leading institutions in the same geographic location as the Employer. The rate will not change during the term of the loan. For home loans, the loan must be repaid within thirty years. All other loans must be repaid within five years or the loan will be considered in default. The loans are secured by the balance in the participant's account.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles, and is an acceptable method of reporting under Department of Labor regulations. The modified cash basis of accounting utilizes the cash basis of accounting while carrying investments at fair value and recording investment income (loss) on the accrual basis. Consequently, contributions are recognized when received rather than when earned, and expenses are recognized when paid rather than when the obligation is incurred.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES *(continued)*

Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

The Plan has an expense budget account. The Plan receives investment fee rebates as income and these amounts are used to pay plan expenses. The Plan received \$14,597 and \$12,169 as investment fee rebate income for the years ended December 31, 2024 and 2023, respectively. This income is presented as other income on the statements of changes in net assets available for benefits – modified cash basis. The Plan used this account to pay plan expenses for both years.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are recorded as distributions based upon the terms of the plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions

For the years ended December 31, 2024 and 2023, excess contributions totaled \$30,487 and \$31,601, respectively. These amounts have been deemed refundable to certain active participants to satisfy relevant nondiscrimination provisions of the Plan. Excess contributions are distributed to the applicable participants before March 15th annually.

Prior Year Reclassifications

Certain amounts in the prior year financial statements have been reclassified to conform with the current year presentation. Such reclassifications had no effect on net assets available for benefits.

Subsequent Events

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

NOTE 3: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 4: TAX STATUS

The prototype plan document used by the third-party administrator obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan has been amended since receiving the determination letter. However, the plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6: TRANSACTIONS WITH PARTIES-IN-INTEREST

For the years ended December 31, 2024 and 2023, the Plan held notes receivable from participants, which qualify as party-in-interest transactions.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – modified cash basis.

NOTE 8: FAIR VALUE MEASUREMENTS (UNAUDITED)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

NOTE 9: PLAN AMENDMENTS

During 2022, the SECURE 2.0 Act was passed, which expanded on provisions passed in the SECURE Act of 2019 and included new provisions that made improvements to retirement savings options. During 2023, the Plan implemented the required provisions of the SECURE 2.0 Act, which includes reducing required minimum distribution penalties and increasing the age for required minimum distributions to age 73. Formal amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable laws and IRS guidance.
