Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS**

(1) Description of Plan

The following brief description of the Ackerman McQueen, Inc. 401(K) (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete description of the Plan provisions.

General

The Plan was established effective January 1, 1997 and is a defined contribution plan covering most of the employees of Ackerman McQueen, Inc. who have attained the age of least 18. There has been a Plan amendment effective April 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended. The Board of Trustees oversees governance of the Plan. The Board along with advisors determines the appropriateness of the Plan’s investments offerings and monitors investment performance.

The Plan was amended and restated effective April 1, 2022, in accordance with the Cycle 3 Restatement, in order to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37 and other legal requirements.

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions commonly referred to as “SECURE 2.0.” These provisions build upon the reforms introduced in the SECURE Act of 2019, focusing on increasing retirement plan participation and encouraging greater retirement savings. SECURE 2.0 contains provisions with various effective dates beginning in 2023 and extending forward.

The provisions include both required and optional elements. The Plan administrator has adopted the required provisions and continues to evaluate optional provisions for future adoption.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

(1) Description of Plan (continued)

Contributions

Participants may contribute a portion of their eligible compensation as defined by the Plan, subject to limitations imposed by the Internal Revenue Code ("IRC"). Participants could contribute up to \$23,000 in 2024, as either pre-tax and/or Roth 401(k) contributions. Participants aged 50 or older during the plan year are eligible to make additional catch-up contributions of up to \$7,500 in both 2024, for a total possible contribution of \$30,500 in 2024.

The Plan also includes an automatic enrollment feature for employees hired on or after January 1, 2008. Upon meeting eligibility requirements, unless otherwise directed by the participant, the Plan sponsor automatically enrolls the participant at a deferral rate of 3% of the participant's eligible compensation. Contributions are invested in a designated balanced fund unless the participant makes an alternative investment election.

The Company's Board of Directors may approve discretionary matching contributions to the 401(k) Plan at its discretion. For the year ended December 31, 2024, the Company approved discretionary matching contributions totaling \$38,745, which were paid in 2025 using non-vested forfeited accounts.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution (if any), allocations of the Company's discretionary non-elective contributions (if any) and plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant's earnings or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a commercially reasonable rate as determined by the Plan Administrator. Participant loans are transactions with the plan sponsor and parties-in-interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Principal and interest are paid ratably through monthly payroll deductions.

Investment Options

The participant contributions and the company matching contributions are allocated to the various investment options offered by the plan as the participant directs.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A year of service for purposes of vesting is a consecutive 12-month period ending on the last day of each Plan Year during which the employee has 1,000 or more hours of service. Vesting is based on years of credited services as set forth in the following table:

Forfeitures

Participants leaving the Plan forfeit their non-vested portions of employer discretionary matching and discretionary non-elective contributions. Non-vested amounts are forfeited on the earlier of: (1) distribution of the participant's entire vested account balance, or (2) when the participant incurs six consecutive one-year breaks in service.

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$44,859 and \$18,768, respectively. The Plan permits these forfeitures to be used to pay Plan expenses or to offset future employer discretionary matching contributions.

During the year ended December 31, 2024, the Company used \$38,745 of forfeited non-vested accounts to fund discretionary matching contributions that were paid in 2025.

Payment of Benefits

On termination of service for reasons other than death, disability or retirement, a participant or their designated beneficiary (if applicable) may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or annual installments as defined in the Plan agreement. If a participant's balance is less than \$1,000, the participant's account will be automatically distributed. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. If the account balance exceeds \$5,000, excluding amounts attributed to rollovers, the participant's account will not be automatically distributed. However, the participant may elect to receive the benefit. The distribution will then be made to the participant within a reasonable time after termination of employment and consent to the distribution. Certain early distributions made upon early termination of employment may be subject to a penalty.

Upon retirement at normal retirement age of 59 ½, the participant is entitled to receive his or her entire account balance. In addition, a participant who retires due to disability will also, be entitled to 100% of their account balance. If a person attains age 59 ½ while still employed by the Company, he or she may elect to withdraw all or a portion of his or her vested balance.

Death Benefits

The designated beneficiary is entitled to 100% of the participant's account balance if the participant was employed at the time of death. If the participant was not employed at the time of death, the designated beneficiary is entitled to a death benefit distribution equal to the participant's vested account balance.

Hardship Withdrawals

Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purposes. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½.

(2) Summary of Significant Accounting Policies

Cash and Cash Equivalents

The Plan considers all highly liquid investments with an original maturity of three months or less to be cash equivalents.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Note Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits paid to participants are recorded upon distribution.

Corrective Distributions

Corrective distributions are distributed before March 15 of the following year and recorded upon distribution.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Additionally, the Plan Sponsor has absorbed part of the administrative expenses incurred by the Plan. The administrative expenses paid by the plan sponsor are not included in the financial statements.

(3) Information Certified by the Plan Trustee

The Plan Administrator has elected the method of compliance permitted by the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, no independent auditing procedures were performed with respect to the information certified as complete and accurate by Reliance Trust Company.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

(4) Fair Value Measurements

The fair value measurement accounting literature establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the FASB ASC 820 are described below:

- Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2- Inputs to valuation methodology include:
- quoted prices for similar assets and liabilities in active markets;
 - quoted prices for identical or similar assets in inactive markets;
 - inputs other than quoted prices that are observable for the assets and liabilities;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the valuation methodologies at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily asset value (NAV) and to transact that price. The mutual funds held by the Plan are deemed actively traded.

(5) Tax Status

The Plan is based on a prototype document sponsored by McAfee & Taft Inc., which received an opinion letter from the Internal Revenue Service ("IRS") on October 6, 2020. This letter stated that the prototype document, as then designed, met the applicable requirements of the Internal Revenue Code ("IRC"). While the Plan itself has not obtained a separate determination letter from the IRS, the Plan Administrator believes the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan is considered to be tax-exempt, and no provision for income taxes has been included in the financial statements.

The Plan has been amended since the issuance of the opinion letter. The Plan Administrator has concluded that the amendments made do not affect the Plan's tax-exempt status and continues to believe that the Plan is being operated in compliance with the applicable IRC requirements.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate uncertain tax positions taken by the Plan. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions that require recognition in the financial statements. The Plan is subject to routine audits by taxing authorities, including the IRS. However, there are currently no audits for any tax periods in progress.

(6) Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments are managed by Reliance Trust Company, which is the trustee as defined by the Plan. These transactions qualify as party-in-interest transactions under the Employee Retirement Income Security Act of 1974 (“ERISA”), as Reliance Trust Company provides trustee and investment management services to the Plan. Fees incurred by the Plan for investment management services are included as a reduction of the return earned on each fund and are not separately billed. These fees are paid through revenue-sharing arrangements rather than direct payments from the Plan.

Additionally, certain administrative expenses of the Plan are paid by the Plan Sponsor, Ackerman McQueen Inc., which qualifies as a related party to the Plan under ERISA. The Plan Sponsor also provides certain administrative services, such as payroll and human resources functions, for the benefit of the Plan. These administrative expenses paid by the Plan Sponsor are not included in the Plan’s financial statements.

As permitted by the Plan, participants may take out loans from their individual accounts. These loans are considered party-in-interest transactions since they are made between the participants and the Plan. Loans are secured by the participants’ account balances and bear interest at rates set by the Plan Administrator, which are considered commercially reasonable.

All transactions involving related parties and parties-in-interest are executed in compliance with ERISA regulations, which require that such transactions be conducted at fair market value and that the Plan does not incur losses due to these transactions.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

(8) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(9) Subsequent Events

The Plan sponsor has evaluated subsequent events through October 10, 2025 the date which the financial statements were available to be issued.
