Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

(1) Description of Plan

The following description of the Creative Sign Designs Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering all eligible employees of Creative Sign Designs, LLC (the "Company" or "Sponsor") for the benefit of its employees who have completed six months of service. Entry date into the plan is on the first day of the month coinciding with or next following the date the employee satisfies the eligibility requirement. The Plan was amended January 2021 to allow for employer matching contributions. The Plan was adopted with an effective date of January 1, 1995 and is sponsored by Creative Sign Designs (Company). The Plan entered into an agreement with Automatic Data Processing ("ADP") to act as recordkeeper of the Plan. ADP entered into a trustee agreement with a third-party trustee, Reliance Trust Company ("RTC"), to hold the investments and execute investment transactions. The Company has adopted the ADP Defined Contribution Plan Non-Standardized 401(k) Profit Sharing Plan Adoption Agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). On July 1, 2023, the Plan added the option for Roth deferrals.

(b) Contributions

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan, subject to a maximum of \$23,000 in 2024 (\$30,500 including catch-up contributions for participants who attain age 50 by the end of the Plan year). Participants may also rollover amounts from other qualified defined benefit or contribution plans even if they have not yet met the service requirement. Participants direct the investment of their contributions into various investments offered by the Plan. Participants may modify their elected contribution anytime through the ADP portal. All eligible employees are automatically enrolled in the Plan unless they elect not to participate. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation, as defined, with a 1% increase on each succeeding anniversary up to a maximum of 10%.

During 2021, the Plan was amended to include employer matching contributions. The Plan provides for the Company to make discretionary contributions in an amount equal to a matching percentage of a participant's eligible contributions for the Plan year at the option of the Company up to a maximum amount. A participant must complete 1,000 hours of service and be employed at the end of the Plan year to be eligible for matching contributions. However, these conditions are waived in the event of death, permanent disability or normal retirement of the participant. For 2024 and 2023, the Company match was \$28,852 and \$22,678, respectively.

(c) Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings, and charged with an allocation of any administrative expenses. The plan allows participants to direct their contributions to any investment options available to the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

(d) Vesting

Participants are immediately vested in their contributions plus earnings, if any, thereon. Vesting in the Company's matching contribution portion of their account plus actual earnings, if any, thereon is based on continuous years of service. A participant vests in the matching contribution at a rate of 20% for the second year of service, 40% for the third year of service, 60% for the fourth year of service, 80% for the fifth year of service and 100% vested as of the sixth year of service. The Plan provides for 100% vesting of participant balances upon normal retirement, death, permanent disability or plan termination in accordance with Plan provisions.

(e) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1%. Principal and interest are paid ratably through payroll deductions up to a five year period. However, if the loan is for the purchase of the participant's principal residence, the Plan administrator may permit a longer loan period. Participants may only have one loan outstanding at a time. The note receivable balances were \$12,609 and \$23,668 at December 31, 2024 and 2023, respectively.

Effective March 27, 2020, the Coronavirus Aid, Relief, and Economic Security ("CARES") Act was signed into law, which provided several relief provisions to tax-qualified retirement plans and their participants. The Plan operationally amended the Plan to implement the relief provision under the CARES Act which allowed a special notes receivable provision to increase the available loan amount to the lesser of \$100,000 or 100% of the participant's vested account balance. In addition, the provision extended the period for loan repayments up to one year.

(f) Benefits paid to participants

On termination of service due to death, disability or retirement, a participant shall be 100% vested in their accounts under the Plan. Normal retirement age under the plan is 65. The Plan provides for benefit distributions by lump-sum payment. The Plan also allows for in-service withdrawals for those 59 ½ or older. The Plan provides for hardship distributions in accordance with the Plan agreement. At December 31, 2024 and 2023, there were no distribution payments that were processed and approved for payments by the Plan, but not yet paid to participants.

The Plan operationally amended the Plan to implement the relief provision under the CARES Act which allowed for special coronavirus-related distributions up to \$100,000. In June 2020, the Internal Revenue Service issued Notice 2020-50, which expanded eligibility for special coronavirus-related distributions under the CARES Act and allowed for the repayment of these distributions provided the repayment occurs within three years of receipt of distribution.

(g) Hardship Withdrawals

The Plan allows participants to withdraw a portion of their account balance in the event of immediate and heavy need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions. As a result of the Bipartisan Budget Act of 2018 and effective January 1, 2019, the requirement to exhaust loan distributions prior to receiving a hardship distribution was removed from the Plan. Additionally, participants are no longer suspended from making contributions to the Plan or from receiving employer contributions as a result of taking a hardship distribution.

(h) Forfeitures

Non-vested Company contributions that are forfeited are retained in the Plan and reduce Company contributions. As of December 31, 2024, the Plan had total forfeitures of \$968 available to reduce future Company contributions. As of December 31, 2023, the Plan had forfeitures of \$4,632 which was used in the prior year to reduce the total Company contributions.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates.

(c) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The Shares of registered investment companies are valued at quoted market prices. Changes in the fair value of investments in registered investment companies and gains or losses on disposal of these investments are reported in the statement of changes in net assets available for benefits as net realized and unrealized appreciation in investments.

Purchases and sales of securities are recorded on trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

(d) Valuation of Notes Receivable from Participants

Notes receivable from participants represent participant loans and are valued at the unpaid principal balance plus any accrued and unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

(e) Contributions

Employee contributions are recorded when eligible compensation is paid. Employer contributions are recorded when authorized.

(f) Benefits paid to Participants

Benefits are recorded when paid.

(g) Administrative Expenses

Administrative expenses of the Plan are paid by the Sponsor, the Plan and/or unallocated Plan forfeitures.

(3) Fair Value Measurements

Accounting Standards Codification Topic 820 (ASC 820), *Fair Value Measurements and Disclosures*, establishes the fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of quoted prices in active markets of similar assets, quoted prices in inactive markets of identical assets, inputs other than quoted prices that are observable, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were no investments with Level 2 or 3 inputs that were held by the Plan during the years ended December 31, 2024 and 2023.

The Plan's independent auditors did not perform audit procedures with respect to this information, except for comparing such information to the related information included in these financial statements and supplemental schedule.

(5) Party-in-Interest Transactions

Certain Plan investments are managed by the trust of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additionally, the notes receivable from participant employees of the Company are considered exempt party-in-interest transactions.

(6) Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(7) Income Tax Status

The Plan has adopted the ADP prototype plan, which received its latest opinion letter from the Internal Revenue Service dated October 6, 2020, stating that the ADP prototype plan was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan accounts for uncertain tax positions, if any, in accordance with FASB Accounting Standards Codification 740. In accordance with these professional standards, the Company recognizes tax positions only to the extent management believes it is "more likely than not" that its tax positions will be sustained upon IRS examination. The Plan Administrator believes it has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements for the year ended December 31, 2024 and 2023.

The Plan Administrator believes that its income tax filing positions will be sustained upon examination and does not anticipate any adjustments that would result in a material adverse effect on the Plans Statements of Net Assets Available for Benefits or Statement of Changes in Net Assets Available for Benefits. Accordingly, the Plan has not recorded any accruals for interest and penalties for uncertain income tax positions at December 31, 2024 and 2023.

The Company's income tax returns are subject to examination by taxing authorities for a period of three years from the date they are filed. The Sponsor believes it is no longer subject to income tax examination for years prior to 2021.

(8) Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for Plan benefits.

(9) Subsequent Events

Management has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued. As of January 1, 2025, the trustee of the plan was changed from Reliance Trust Company to ADP Retirement Trust Services LLC.
