Buddeez, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Buddeez, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits (modified cash basis) for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023 stating that the certified investment information, as described in the Information Certified by the Plan Trustee footnote to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting. The modified cash basis of accounting is a comprehensive basis of accounting other than generally accepted accounting principles.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for Financial Statements

NOTE 1 – DESCRIPTION OF PLAN

The following description of Buddeez, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution 401(k) plan covering all full-time employees sponsored by Buddeez, Inc. (the Company) who are at least 21 years of age, completed nine consecutive months of service, and are not members of a collective bargaining unit. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants are permitted to contribute either pre-tax or after-tax (Roth) deferrals through payroll deductions subject to certain maximum limitations imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to the maximum limit imposed by the IRC. All employee contributions are immediately 100% vested plus actual earnings thereon. The Plan provides for rollover contributions to the Plan, which is always 100% vested and non-forfeitable. The Company elected to make a discretionary matching contribution based on a percentage to be determined on a uniform basis among the Plan participants. The maximum amount of the discretionary matching contribution on behalf of participants not to exceed \$1,800 for 2024.

The Plan provides for the Company to make profit-sharing contributions at the discretion of the Board of Directors. If the Company decides to make a profit-sharing contribution, all full-time employees who have completed 1,000 hours of service during the Plan year and are still employed at the end of the year will receive a portion of this contribution. The contribution is allocated to the participant accounts based on the employee's compensation as a percentage of all participant's compensation. There were no profit-sharing contributions for 2024.

Participants Accounts:

Individual accounts are maintained for each Plan Participant. Each participant's account is credited with the participant's contribution, applicable elective contributions, allocations of applicable profit-sharing contributions and Plan investment earnings and charged with withdrawals and an allocation of Plan investment losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at the current prime rate plus 1% at the time of the application. Principal and interest are paid ratably through payroll deductions.

Investment Options:

Participants direct the investment of their contributions into various investment options offered by the Plan through Reliance Trust Company (Plan Trustee). Participants may change their investment options at any time throughout the year via internet or direct phone access via the recordkeeping system.

Payment of Benefits:

Distributions are made to participants upon retirement, termination of employment, or total and permanent disability. In the case of death, distributions are made to the participant's beneficiary.

Forfeited Accounts

Forfeited amounts are allowed by the Plan to be used to reduce employer contributions and pay administrative expenses for the Plan. At December 31, 2024, forfeited non-vested accounts totaled \$11,981 of which \$5,994 was used to reduce employer contributions. At December 31, 2023, forfeited non-vested accounts totaled \$10,194 of which \$5,099 was used to reduce employer contributions.

Plan Termination:

Although it has not expressed any interest to do so, the Company has the right under the Plan to terminate the Plan at any time. In the event of termination, the account of each participant shall be fully vested and non-forfeitable as of the effective date of complete termination of the Plan and each participant's contribution account shall be distributed to the participant.

Plan Amendments:

There were no amendments to the Plan during 2024 or 2023.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The accompanying financial statements of the Plan have been prepared on the modified cash basis of accounting. The modified cash basis of accounting is a comprehensive basis of accounting other than generally accepted accounting principles (GAAP). This basis of accounting differs from GAAP in that, contributions are recorded when received and expenses when paid instead of when they are receivable or payable, respectively. This creates a timing difference in the valuation of benefits payable to participants between the time the contributions are withheld from the employee's paychecks until the time they are deposited into the Plan.

Investment Valuation and Income Recognition:

Assets of the Plan at December 31, 2024 are maintained in Registered Investment Companies (mutual funds) with Reliance Trust Company. The Plan's investments are carried at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices that represent the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payments of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

Certain expenses incurred in the administration of the Plan are paid directly by the Company. The Plan incurred \$4,073 and \$4,784 of administrative expenses for the years ended December 31, 2024 and 2023, respectively. Refer to the Party-In-Interest Transactions footnote below for further information.

Estimates:

The preparation of financial statements in conformity with the modified cash basis of accounting requires the trustees to make estimates and assumptions that affect certain reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenue and expense during the reporting period. Accordingly, actual results may differ from those estimates.

NOTE 3 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated July 16, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, is exempt from Federal income taxes.

Accounting principles generally accepted in the United States of America and the modified cash basis of accounting require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan Administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2022.

NOTE 4 – PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company maintains the investments and executes investment transactions and allocations. Reliance Trust Company receives fees for these services. There are no transactions with Reliance Trust Company that qualify as party-in-interest transactions.

ADP handles all administrative and recordkeeping duties of the Plan. ADP receives fees for these services. There are no transactions with ADP that qualify as party-in-interest transactions.

As disclosed in the Summary of Significant Accounting Policies footnote, *Administrative Expenses* subsection above, certain expenses incurred in the administration of the Plan are paid directly by the Company. These transactions qualify as party-in-interest transactions as defined by ERISA.

NOTE 5 – FAIR VALUE MEASUREMENTS

Included in the financial statements are certain financial instruments carried at fair value. The fair value of an asset is the amount at which the asset could be bought or sold in a current transaction between willing parties, that is, other than in a forced liquidation sale. The fair value of a liability is the amount at which that liability could be incurred or settled in a current transaction between willing parties, that is, other than in a forced or liquidation sale. Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC 820), *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

NOTE 5 – FAIR VALUE MEASUREMENTS (CONT.)

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets accessible at the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and other inputs that are observable or can be corroborated by market data for the term of the instrument. Such inputs include market rates and volatilities, spreads, and yield curves. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Certain inputs are unobservable (supported by little or no market activity) and significant to the fair value measurement. Unobservable inputs reflect the Plan's best estimate of what hypothetical market participants would use to determine a transaction price for the asset or liability at the reporting date.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund to reflect the current market price of the fund's securities. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common / Collective Trusts: Valued at the respective net asset values (NAV) as reported by such trusts / funds as a practical expedient. The value of each unit is determined by subtracting total liabilities from the total value of the assets, including accrued income, and dividing the amount remaining by the number of units outstanding on the valuation date. There are no restrictions as to the redemption of these investments nor does the Plan have any contractual obligations to further invest in any of these funds. The valuation of these investments are no longer categorized within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- Assets held for investment purposes as shown in the accompanying supplemental Schedule of Assets (Held at End of Year) (Modified Cash Basis) as of December 31, 2024.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment funds. Investment funds are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment funds, it is at least reasonably possible that changes in the values of investment funds will occur in the near term that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 8 – SUBSEQUENT EVENTS

The Company has evaluated subsequent events for potential recognition and disclosure through October 13, 2025, the date the financial statements were issued. No significant events necessitating recognition or disclosure were noted.
