Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Green Planet 21, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). NOTE A – DESCRIPTION OF PLAN

Green Planet 21, Inc. 401(k) Plan (the "Plan") is a defined contribution plan established on January 1, 1994, based on the prototype defined contribution retirement plan of ADP Retirement Services ("ADP"). Green Planet 21, Inc. (the "Company") is the Plan sponsor and administrator. The Plan trustee is Reliance Trust Company (the "Trustee"). ADP provides recordkeeping and administrative services for the Plan. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA), as amended.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Eligibility

The Plan is a defined contribution plan designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of termination, disability, financial hardship, or death. The Plan covers all employees of the Company who meet certain eligibility requirements. Employees who have completed three consecutive months of service and are age twenty-one years or older are eligible to participate in the Plan. The Plan has an automatic deferral provision, in which eligible employees are automatically enrolled in the Plan at 3 percent of compensation unless they specifically elect not to participate in the Plan. Automatically enrolled participants' contributions are invested in a designated balanced fund until changed by the participant. Participants may change their deferral contributions at any time.

Participant Contributions

Under the Plan, participants may make two kinds of elective deferrals: pre-tax elective deferrals or Roth elective deferrals. As such, participants may contribute any combination of pre-taxed and Roth elective deferrals ranging from 1% to 75% of their eligible compensation, not to exceed the maximum allowable amounts under the Internal Revenue Code. Participants who are at least age 50 may make additional "catch-up" contributions as defined under the Internal Revenue Code.

Employer Contributions

The Plan does not provide employer matching contributions. However, the Company may make a discretionary profit sharing contribution at the option of the Board of Directors. For the years ended December 31, 2024 and 2023, there were no profit sharing contributions made to the Plan.

Rollover Contributions

The Plan accepts rollover contributions from retirement funds held by participants outside of this Plan, subject to Plan provisions.

Investment Options

The Plan provides for participant-directed investment programs; whereby, the Plan determines which investment options are available, and the participants may choose among the available options. Participants may have their accounts invested in any, or a combination of, registered investment companies accounts. Participants may change their investment options at any time by reallocating contributions among different investment alternatives. Participants may also transfer contributions into and out of investments provided under the Plan, subject to possible restrictions.

Participant Accounts

Each participant's account is self-directed and credited with the participant's pre-tax or after-tax contributions (including elective deferrals, catch up contributions, after-tax contributions, and/or rollover contributions); the Company's contributions; and share of any investment earnings. Participant accounts are reduced by any withdrawals or distributions, investment losses, decreases in values of investments, and share of fees and expenses, as applicable. Allocations are based on participant earnings or account balances, as defined by the Plan provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Benefits may be paid from participant accounts at age 59 1/2, or upon disability, termination of employment, death, or upon the Plan's termination. Participants who are age 72 and over are required to make minimum distributions by the Internal Revenue Service (“IRS”). If a participant’s account is valued at \$5,000 or less upon termination of employment, the Company may liquidate the value of the account and distribute the funds to the former participant. The taxable portion of a withdrawal is subject to federal and state income taxes, and an additional tax if the participant has not reached retirement age, unless the amount is rolled over into another eligible plan or an Individual Retirement Account. Eligible participants may request an in-service hardship distribution of elective deferrals and any vested employer contributions, subject to the Plan's provisions.

Notes Receivable from Participants

The Plan allows active participants to borrow from their vested account balances. The minimum loan amount is \$500. Participant loans are limited to the lesser of 50% of the vested account balance or \$50,000 less the highest outstanding loan balance in the prior twelve month period. Participants are permitted to have only one outstanding loan at any time; and the loan must be repaid within a five year period, unless the loan is for the acquisition of a primary residence. All loans shall be considered investments of the trust, and shall be evidenced by a promissory note signed by the participant.

Loans are secured by the balance in the participant's account, and bear interest at a rate commensurate with local prevailing rates. The interest rate shall remain fixed throughout the duration of the loan. Principal and interest payments are made through payroll deductions.

Vesting

Participants are immediately vested in their contributions plus actual earnings on elective deferral contributions. All employee contributions are 100% vested upon attaining normal retirement age, death or disability.

Forfeited Accounts

Forfeitures attributable to profit sharing contributions, not used to pay administrative expenses, will be reallocated to participants in the current or next succeeding Plan year. For the years ended December 31, 2024 and 2023, there were no forfeited non-vested account balances available to be used to pay administrative expenses.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and in the disclosures of contingent assets and liabilities. Accordingly, actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments when available. See Note D for a discussion of the fair value measurement. Interest is recorded as earned and dividend income is accrued as of the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded when the related expenses are incurred.

Administrative Expenses

Administrative costs, except for certain investment fees and loans fees that are paid out of the related participant accounts, are absorbed by the Plan Sponsor and have not been included in the accompanying financial statements.

Excess Contributions Payable

Excess deferred contributions made by Plan participants during the year are returned to the participants during the first quarter of the following year. Excess contributions payable totaled \$1,845 and \$18,791, as of December 31, 2024 and 2023, respectively.

NOTE C – INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the alternative method of compliance permitted by ERISA 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, as permitted under such election, information certified by Reliance Trust Company (the “Trustee” of the Plan), as of and for the years ended December 31, 2024 and 2023, was not audited, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

Certain information related to investments from participants disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by the Trustee.

NOTE D – FAIR VALUE MEASUREMENT

FASB Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements), and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under Topic 820 are described as follows:

- Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

- Level 2* Inputs to the valuation methodology include a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices that are observable for the asset or liability; and d) inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value of mutual funds is determined by using the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – INCOME TAX STATUS

The IRS has determined that as of March 31, 2008, the ADP Retirement Services Proto-Type Standardized Profit Sharing Plan (“ADP Proto-Type Plan”) was designed in accordance with applicable sections of the Internal Revenue Code. The ADP Proto-Type Plan was adopted by the Company on September 27, 2010. The plan administrator is not aware of any course of action or series of events that have occurred that might affect the Plan’s tax-exempt status, and therefore, believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. There were no uncertain tax positions identified by the Plan.

The Plan's Form 5500 is subject to examination by the IRS for a period of three years from the date it was filed, except under certain circumstances. The Plan’s Form 5500 for the years 2021 through 2023, are open for a tax examination by the IRS, although no request has been made as of the date of these financial statements.

NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company, the trustee of the Plan, receives a percentage of the total investments for managing the Plan's assets, which qualifies Reliance Trust Company as a party-in-interest to the Plan. In addition, ADP receives payment from the Plan for providing administrative and bookkeeping services. For the years ended December 31, 2024 and 2023, fees paid by the Plan for investment management and administrative services totaled \$23,271 and \$17,805, respectively.

NOTE G – PRIORITIES UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to amend the Plan, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances as of the date of termination.

NOTE H – RISKS AND UNCERTAINTIES

The Plan provides for investments in different investment securities that are exposed to various risks such as interest rate, credit risks, and overall market volatility. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

NOTE I – SUBSEQUENT EVENTS

The Company has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued. There were no additional events or transactions that were discovered during the evaluation that required further recognition or disclosure.
