Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

DECEMBER 31, 2024 AND 2023

NOTE A: DESCRIPTION OF THE PLAN

The following description of the Elizabeth Wende Breast Care, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Elizabeth Wende Breast Care, LLC (the “Company”). Employees must be age twenty-one or older for participation in the employee elective deferral contributions of the Plan. Employees that have completed one year of service, while working at least 1,000 hours, are eligible for the employer non-elective contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Upon meeting the Plan participation requirements, the employee will be deemed to have entered into the Plan authorizing the Employer to withhold 3% of the employee’s compensation as an elective deferral, unless the employee indicates no deferrals or a different percentage up to 90% of eligible compensation. The Plan agreement provides that participants shall be permitted to make contributions to not exceed the ceiling imposed by the Internal Revenue Service. If a participant is age 50 or over, the ceiling increases. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Employer will make a safe harbor contribution equal to 3% of each eligible participant’s compensation. The Employer may, at its discretion, also make additional non-elective contributions to the Plan on behalf of the participants.

Participant accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and plan earnings, and charged with an allocation of any administrative expenses paid by the Plan. Allocations of plan earnings and administration expenses are based on participant account balances and allocations of the Company’s contributions are based on participant’s compensation, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are fully and immediately vested in their contributions, as well as Company safe harbor contributions, plus actual earnings thereon upon entering the Plan.

Effective January 1, 2020, the Plan was amended where vesting for Company non-elective contributions is to be based on a participant’s years of service. Participants will not be vested until their third year of service, where they will then be fully vested. This amendment only applies to newly hired employees as of January 1, 2020 or later.

Notes receivables from participants

Participants may borrow from their accounts a minimum of \$1,000, up to 50% of their vested account balance, not to exceed \$50,000. Loan terms range from 1 – 5 years, with varying interest rates from 4.25% to 9.50%. If the purpose of the loan is to acquire a principal residence, repayment may be made over a reasonable period of time that may exceed five years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the prime rate of interest charged by the Wall Street Journal as of the date of the loan, plus one percent. Principal and interest is paid ratably through weekly payroll deductions.

Payments of benefits

On termination of service, benefits may be paid in a lump-sum amount, a distribution in the form of an annuity, or a combination of both. The Plan allows participants to receive benefits in case of hardship. Participants may withdraw any part of their vested account after reaching the age of 59 ½. If a participant's balance is less than \$1,000, the Plan Sponsor may distribute the vested balance as a lump sum to the participant or roll the balance to an Automatic Rollover IRA. If a participant's balance exceeds \$1,000 but less than \$7,000, the Plan Sponsor may roll the vested balance into an Automatic Rollover IRA. Other withdrawals may be subject to restrictions as defined in the Plan.

Forfeited accounts

Contributions that are forfeited because of a termination of employment prior to becoming fully vested can be used to reduce any employer contribution or administrative expenses on an annual basis. Forfeitures available to reduce future administrative expenses or employer contributions totaled \$10,478 and \$2,573 at December 31, 2024 and 2023, respectively.

Forfeited contributions are included in the pooled money market until allocated to participants. Employer contributions were reduced by \$0 during the years ended December 31, 2024 and 2023, from forfeited non-vested accounts. The Plan was not reimbursed for any administrative expenses from the forfeitures account for either of the years ended December 31, 2024 and 2023.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment value of income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant ceases to make loan repayments and the Plan Administrator considers the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits

Benefit payments are recorded when paid.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through September 17, 2025, which is the date the financial statements are available to be issued. No subsequent events requiring disclosure were noted.

NOTE D: FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America (“GAAP”) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE D: FAIR VALUE MEASUREMENTS, Cont'd

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price.

Common Investment Trust: Valued at the net asset value reported by the fund as a practical expedient. There are no unfunded commitments and investments can be redeemed on a daily basis without restriction and are not subject to redemption notification provisions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to amounts presented in the statements of net assets available for benefits.

NOTE E: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts and their accounts will be paid to them as provided for in the plan document.

NOTE F: TAX STATUS

The Plan uses a non-standardized pre-approved profit sharing plan sponsored by ADP, LLC. ADP, LLC received an opinion letter from the IRS dated October 6, 2020, which states that the non-standardized profit sharing plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The plan document has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G: RISKS AND UNCERTAINTIES

The Plan invests in various securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

NOTE H: TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan invests in investments which are managed by an affiliate of Reliance Trust Company. During 2024 and 2023, Reliance Trust Company acted as a trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

As described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are parties-in-interest transactions under ERISA.
