Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

2024 Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule of Assets (Held at Year End) for the year ending December 31, 2024 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Auditor's Report on the 2023 Financial Statements

The financial statements of Diabetic Care RX LLC dba Patient Care America 401K Profit Sharing as of December 31, 2023, were audited by predecessor auditors. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 8, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirement of ERISA Section 103(a)(3)(C).

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Diabetic Care RX LLC dba Patient Care America 401K Profit Sharing (the “Plan”) provides only general information. The Plan is sponsored by Diabetic Care RX LLC dba Patient Care America (the Company). Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Company’s corporate offices are located in Pompano Beach, Florida.

General - The Plan was effective in 2013, and is a defined contribution plan available to all employees of the Diabetic Care RX LLC dba Patient Care America (“the Company”) who are age twenty-one or older and have completed two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

The purpose of the Plan is to encourage employees of the Company to save and invest, systematically, a portion of their current compensation so that they and their families may have a source of additional income upon their retirement, or in the event of death.

Contributions – Participants may contribute a percentage of their pretax compensation, as defined in the Plan document, as an elective deferral contribution, subject to limitations. Additionally, participants may contribute a percentage of their after-tax compensation and designate it as a Roth elective deferral contribution. Eligible participants may make a rollover contribution to the Plan. Upon a participant being eligible to participate in the Plan, the participant is automatically enrolled with an automatic deferral of 6% unless the participant opts out.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the year may make catch-up contributions in accordance with, and subject to, the limitations imposed by the IRC.

The Company will match 100% on the first 2% of participant’s contributions, plus 50% of each participant’s contributions between 3% and 6%. Finally, the Company may elect to make either a matching contribution at year end (not related to the Qualified Automatic Contribution Arrangement) or make a nonelective contribution to the Plan, both of which are not required.

Employer matching contributions for the year ended December 31, 2024 amounted to \$472,121.

Participant Accounts – Each participant’s account is credited with the participant’s contributions and the Company’s matching contribution, as well as allocations of the Company’s profit sharing contribution, if any, and the Plan earnings. All contributions are allocated at the direction of the participant among selected investment funds. Each fund’s investment income or loss, less any investment management fee, is allocated to participants’ accounts based on their proportionate interest in the fund. The value of participant accounts will fluctuate with the market value of the securities in which the accounts are invested. Transaction fees charged for participant distributions are allocated directly to that participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Alternatives – Plan participants may direct their entire account balances in partial percentage increments to any of the various investment options offered by the Plan. Employer contributions are also invested based upon participant allocation elections. Participants may change their investment options on a daily basis.

Vesting – Participants are vested immediately in their contributions and the Company’s safe harbor matching contribution plus actual earnings thereon. Vesting in the Company’s non elective contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service. In the event of disability, early retirement or death, or Plan termination, the participant will become fully vested.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Upon a new loan, the \$50,000 in the preceding sentence is reduced by the highest outstanding loan balance under the Plan during the previous one-year period. Loans must be repaid within 5 years or up to 30 years for loans used to purchase a primary residence. The loans are secured by the balance in the participant's account and bear interest at the rate in effect in the month the loan is effective. The rate is the prime rate as published by The Wall Street Journal on the 14th day of each month, plus 2%. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits – Upon termination of service due to death, disability, or retirement, a participant with a vested balance that exceeds \$5,000 may elect to receive an amount equal to the value of the participant's vested interest in their account, in either a lump-sum amount, or in installments if the participant's vested account exceeds \$5,000. If the vested balance is under \$5,000, the Company can cash out the participant's entire vested account balance in the Plan. For termination of service due to other reasons, a participant may receive the value of his or her vested account as a lump-sum distribution. In addition, Hardship distributions are allowed under the Plan.

Forfeitures – Forfeited nonvested accounts are used to reduce administrative expenses or the employer contributions in the subsequent year. At December 31, 2024 and 2023, forfeited accounts totaled \$27 and \$26, respectively. During 2024, the forfeited funds were not utilized.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Contributions

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan's administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and change therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value or contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement for the investment in the guaranteed interest account because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation of fair value of investments includes the Plan's gains and losses on investments sold, as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a deemed distribution payment is recorded. If the participant resumes payment under the Plan in a later year, the loan is re-instated with an offset to deemed distributions for the amount previously deemed a distribution.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation/(depreciation) of the fair value of investments.

NOTE 4 – INVESTMENTS AT CONTRACT VALUE

Investments at contract value consist of the Stable Value Fund – I1, an investment option, which is a guaranteed interest account that offers a guaranteed minimum interest rate and a return on principal. Participant account balances are credited daily with interest and participants have daily liquidity at full book value (principal and interest) for all participant initiated events. Interest rates averaged approximately 3.88% and 3.35% for 2024 and 2023, respectively. At December 31, 2024 and 2023 the balance in the Stable Value Fund Account was \$183,914 and \$128,454, respectively.

NOTE 5 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Also known as registered investment companies, which are valued at quoted market prices on the last business day of the Plan year.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 – EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Party in interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee organization, or relatives of such persons.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Certain Plan investments are mutual funds and collective investment trust funds issued and managed by Reliance Trust Company and ADP Retirement Services. Reliance Trust Company has been designated as the Custodian and ADP Retirement Services provides administration and recordkeeping services to the Plan. These specific investments issued or managed by Reliance Trust Company and ADP Retirement Services qualify as party-in-interest transactions. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. There have been no known prohibited transactions with parties-in-interest.

The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA. Fees paid by the Plan to the custodians for the daily operational services of the Plan was \$23,874 for the year ended December 31, 2024.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8 – TAX STATUS

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated 10/6/2020, that the Plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 8 – TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 11 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued, and determined that there were no subsequent events or transactions that required recognition or disclosure in the financial statements, except as disclosed below.

The Plan was amended effective January 1, 2025 to change the custodian of the Plan from Reliance Trust Company to ADP Retirement Trust Services, LLC. In addition, an amendment was made to the safe harbor provision wherein a "true-up" contribution will not be required.
