Independent Auditors' Report

To the Harpak-ULMA Packaging, LLC

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Harpak-ULMA Packaging, LLC (a 401(k) plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 

Notes to Financial Statements

December 31, 2024

Note 1 – Description of Plan

The following description of the Harpak-ULMA Packaging, LLC (a 401(k) plan, the “Plan”) is provided for general information only. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan's provisions.

General – The Plan was established on July 1, 1994 and is a defined contribution plan with a salary reduction feature under Internal Revenue Code Section 401(a). The plan administrator/sponsor is Harpak-ULMA Packaging, LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Harpak-ULMA Packaging, LLC Retirement Plan Committee (the “Committee”) oversees governance of the Plan as well as determining the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility – All employees of the Company 18 years of age or older and who have completed two months of service are eligible to participate in the Plan.

Participant Contributions – Each year participants may contribute up to 90% of gross compensation on a pre-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to contribute catch-up contributions. Such contributions are not subject to federal income taxes until withdrawn from the Plan in accordance with Section 401(a) of the Internal Revenue Code (“IRC”). In addition, participants, at their option may contribute up to 90% of gross compensation on an after-tax basis (“Roth” contributions). All contributions are subject certain IRS statutory limits.

Participants may also contribute amounts representing distributions from other qualified pension plans (rollover contributions).

The Plan includes an automatic enrollment feature whereby the Company automatically withholds 6% of the participant's eligible compensation on a pre-tax basis, unless the participant notifies the Company and affirmatively elects not to participate. If a participant fails to choose an investment option, such funds are automatically invested in the Plan's default investment option until the participant selects a different investment option available under the plan. The Plan's designated default investment option is the target date fund with the target date closest to the participant's 65th birthday.

Company Contributions – The Company is required to a make safe harbor matching contributions of 100% of the participant's deferrals not to exceed 1% of eligible compensation plus 50% of participant's deferrals that fall between 1% and 6% of eligible compensation. The Company contributed \$552,435 for the year ended December 31, 2024.

The Company may make discretionary matching contributions not to exceed 4% of participant's eligible compensation. During 2024, the Company elected not to make discretionary matching contributions.

The Company may also make a discretionary profit-sharing contribution to eligible participants. During 2024, the Company elected not to make a discretionary profit-sharing contribution.

Vesting – Participants are fully vested in their contributions, including rollover contributions, plus actual earnings. Company contributions and actual earnings vest according to the following schedule:

If a participant's employment terminates due to death, disability or retirement, the participant's employer contribution account becomes 100% vested.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution, plan earnings (losses) (based on participant's investment election and account balance) and charged with an allocation of any administrative expenses paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options – All assets of the Plan are participant directed. Participants have the option of directing the investment of their contributions, as well as any Company contributions, into various mutual funds and a common/collective trust offered by the Plan. The Committee determines the Plan's valuation policies.

Payment of Benefits – Plan benefits are available at normal retirement age (age 65), deferred retirement, disability retirement, death, or termination of employment. Participants may elect to receive the vested portion of their account as a lump-sum payment.

In-Service Withdrawals – The Plan allows for annual in-service withdrawals from the vested portion of a participant's account upon the participant's attainment of age 59 ½.

Hardship withdrawals are permitted if the withdrawal is due to immediate financial need, as defined by the Plan. The amount of the hardship withdrawal is subjected to certain limitations as specified in the Plan and the IRC.

Notes Receivable from Participants – Participants may borrow an amount up to 50% of their vested account balance. The maximum loan amount is \$50,000, reduced by the highest outstanding loan balance in the preceding twelve-month period. Each borrowing is evidenced by a note bearing interest at a prevailing rate as determined by the plan administrator ranging from 4.25% to 9.50%. The note must be repaid over a period not to exceed five years, except that loans used to obtain a principal residence may be for a longer term. Principal and interest payments are credited to the borrowing participant's account. Principal and interest are paid in level amortization payments through payroll deductions. The notes are secured by the vested balance in the participant's account. Loans will become due and payable in full upon the participant's death, retirement or termination of employment with the Company.

Forfeited Accounts – Forfeited balances of terminated participants' non-vested accounts are used to reduce future employer contributions and plan administrative expenses. During the year ended December 31, 2024, \$11,297 of forfeited participant accounts were used to reduce the Company's matching contributions (\$4,537 used during the year ended December 31, 2023). At December 31, 2024 there were \$10 of non-vested accounts. There were no forfeited non-vested accounts at December 31, 2023.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared using the accrual method of accounting, except that benefit payments are recorded upon distribution.

Fair Value Measurements – The Plan follows the provisions of the Financial Accounting Standard Board's (FASB) Accounting Standards Codification (ASC) Topic 820, "Fair Value Measurements and Disclosures" (ASC Topic 820), for assets and liabilities that are measured and recorded at fair value on a recurring basis, and to determine fair value disclosures. This standard defines fair value, establishes a framework for measuring fair value, and requires disclosures about fair value measurements. Investments measured using the net asset value ("NAV") practical expedient are exempt from categorization within the fair value hierarchy (see Note 4).

Accounting Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. If a participant does not make loan repayments for a period of 90 days and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Therefore, no allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Investment Valuation and Income Recognition – The Plan's investments are recorded at fair value. The Committee determines the Plan's valuation policies (see Note 4).

Net investment appreciation and depreciation reflected in the statement of changes in net assets available for benefits include realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year (see Note 3).

Purchases and sales of securities are recorded on a trade-date basis, interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date.

Payment of Benefits – Benefit payments are recorded upon distribution to participants.

Plan Expenses – Certain expenses of maintaining the Plan are paid by the plan sponsor and therefore are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses, while expenses for items such as recordkeeping fees are allocated to participant accounts. Investment related fees are included in the net appreciation/depreciation of the fair value of investments.

Evaluation of Subsequent Events – Management has evaluated subsequent events involving the Plan for potential recognition or disclosure in the accompanying financial statements. Subsequent events are events or transactions that occurred after December 31, 2024 up through October 3, 2025, the date the accompanying financial statements were available to be issued.

Note 3 - Certified Investment Information

Information related to investments and notes receivable disclosed in the accompanying financial statements and ERISA – required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as

Note 4 – Fair Value Measurements

FASB ASC 820, “Fair Value Measurement” provides a framework for measuring fair value. The framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels and are described as follows:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 inputs consist of observable inputs other than quoted prices for identical assets (i.e., Level 1 inputs).

Level 3 inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments. When available the Plan measures fair using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments when Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

There are no Plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Shares of Registered Investment Companies (Mutual Funds) –The fair value of the mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective Trusts – Valued using the NAV provided by the fund managers. The NAV is based on the underlying net assets owned by the fund, divided by the number of shares outstanding. The NAV’s unit price is quoted on private markets that are not active. However, the NAV is based on the fair value of the underlying securities within the funds, which are traded on active markets, and valued at the closing price reported on the active market on which those individual securities are traded. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The significant investment strategies of the fund are described in the financial statements provided by the fund. Investments in these funds can generally be redeemed daily.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a complete or partial plan termination, participants will become 100% vested in their accounts and participants' accounts will be distributed to participants in accordance with the Plan's provision.

Note 6 - Income Tax Status

The Plan Sponsor on April 28, 2022, adopted a pre-approve plan document, the ADP, Inc. Volume Submitter Defined Contribution Plan, with a cash or deferred arrangement. The pre-approved plan document has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Note 7 – Party-In-Interest Transactions

The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts, and these transactions are party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 8 – Investment Risks and Uncertainties

The Plan provides for investment options in mutual funds and a common collective trust, which are exposed to various risks, such as interest rate, credit risk and market risk. Due to the level of risk associated with these investment securities, and the level of uncertainty related to changes in the value of these investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
