NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN:

The following description of the Fleetmaster/ Englander 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Fleetmaster Express, Inc. (the “Plan Sponsor”) and Englander Transportation, Inc., R&L Drayage, LLC, and Transport Partners, Inc. (the “Participating Employers”). Fleetmaster Express, Inc., Englander Transportation, Inc., R&L Drayage, LLC, and Transport Partners, Inc. (collectively, the “Employers”) are under common control. Employees are eligible to participate in the Plan after three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor’s Board of Directors oversees governance of the Plan. The Plan’s Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investments’ performance and reports to the Plan Sponsor’s Board of Directors.

Contributions

Participants will be automatically enrolled when they become eligible at a participant contribution of 1% of eligible compensation in the Plan’s default fund, unless the participant opts out of the Plan or chooses to contribute a different percentage of eligible compensation. Participants may elect to contribute up to 90% of eligible compensation as defined by the Plan agreement up to the statutory maximum amount of \$23,000 (\$30,500 if participant is at least age 50 by the end of the Plan year) for the year ended 2024 and \$22,500 (\$30,000 if participant is at least age 50 by the end of the Plan year) for the year ended 2023, and may make rollover contributions of their distributions from other qualified plans. The Plan Sponsor determines the formula for matching contributions annually; however, it has not changed in several years. The Employer’s matching contribution in the first year of employment is 25% of the participant’s deferral contribution, limited to 4% of eligible compensation. Starting in the second year of employment, the Employers’ matching contribution is 50% of the participant’s deferral contribution, limited to 6% of eligible compensation.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of the employers’ matching contributions and Plan earnings (losses). Earnings are allocated, by investment fund, based on the ratio of a participant’s account invested in a particular fund to all participants’ investments in that fund. The employers’ contributions are allocated based upon participants’ deferrals to the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

FLEETMASTER/ ENGLANDER 401(k) PLAN

NOTES TO FINANCIAL STATEMENTS - (Continued)

1. DESCRIPTION OF PLAN - (Continued):

Vesting

Participants are immediately 100% vested in their own deferral contributions and rollover contributions and any earnings thereon. Each participant's employers' matching contributions become fully vested upon normal retirement, disability, death or according to the Plan specifications for years of service (i.e. upon completion of three years of service).

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are treated as a transfer between the investment funds and loan funds to participants. Loan terms range from one to five years. A loan is secured by the balance in the participant's account and bears interest at a rate commensurate with market rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. In 2024, loans entered into were at rates of 9.50%. In 2023, loans entered into were at rates between 8.75% and 9.50%.

Forfeitures

Forfeitures may be used to pay employers' matching contributions or administrative expenses of the Plan. Forfeited nonvested accounts totaled \$3,267 and \$2,290 as of December 31, 2024 and 2023, respectively. Forfeitures incurred during the years ended December 31, 2024 and 2023 totaled \$34,843 and \$27,259 respectively. Forfeitures totaling \$33,866 and \$26,160 were used to pay employers' matching contributions for the years ended December 31, 2024 and 2023, respectively.

Investment Options

A participant may direct participant contributions in any combination of various investment options.

Benefit Payments

Benefit payments can be made due to retirement, death, disability, termination of employment, or attainment of age 59 ½ and are subject to the applicable provisions of the Plan agreement. Up to 100% of the participant's vested account balance can be paid in a lump-sum distribution or direct rollover to another qualified plan. Additionally, upon proving of "financial hardship", a participant may withdraw part or all of their vested account balance.

Administrative Expenses

Administrative expenses are made up of participant loan and withdrawal fees and are charged directly to the participant's account generating the fees. Substantially all other Plan administrative expenses are paid by the Plan Sponsor, as provided in the Plan agreement.

NOTES TO FINANCIAL STATEMENTS - (Continued)

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The following accounting principles, which conform to accounting principles generally accepted in the United States of America (“GAAP”), have been used consistently in the preparation of the Plan’s financial statements.

Basis of Accounting

The Plan’s financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisor and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred.

Benefit Payments

Benefits are recorded when paid.

NOTES TO FINANCIAL STATEMENTS - (Continued)

3. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three levels as described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the net asset value ("NAV") of shares held by the Plan at year end. NAV is calculated using observable quoted market prices.

Common collective trust fund - The common collective trust fund is valued at the NAV of the units held by the Plan. The NAV is based upon the value of the underlying investments, which are traded on an active market. As such, the common collective trust is deemed to have a readily determinable fair value. Participant transactions (purchases and sales) may occur daily and there is no redemption notice requirement. There are no unfunded commitments related to the common collective trust fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS:

Certain administrative functions are performed by officers or employees of the Plan Sponsor. These employees may also be Plan participants. No such officer or employee receives compensation from the Plan.

Reliance Trust Company is the trustee and ADP Retirement Services is the recordkeeper of the Plan; therefore, they qualify as parties-in-interest. Administrative expenses paid by the Plan for administrative services amounted to \$14,661 and \$11,796 for the years ended December 31, 2024 and 2023, respectively.

5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. INCOME TAX STATUS:

The Plan has adopted a prototype plan provided by ADP. The Internal Revenue Service ("IRS") has determined and informed ADP by a letter dated October 6, 2020, that the Plan and the related trust were designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Plan management is required by GAAP to evaluate the tax positions taken by the Plan and recognize a tax liability for any uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. Plan management did not identify any uncertain tax positions as of December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
