Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of LTS Group, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE A – DESCRIPTION OF THE PLAN

The following description of LTS Group, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, adoption agreement and amendments for a more complete description of the Plan's provisions.

General: The Plan, a defined contribution plan qualified under Section 401(k) and related provisions of the Internal Revenue Code, was established on February 1, 2019. The Plan was designed to provide participants with a means to defer a portion of their compensation for retirement funds and to provide benefits in the event of disability, death, or financial hardship. The Plan's 401(k) Plan Administrative Committee determines the appropriateness of the Plan's Investment offerings, and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Effective March 1, 2023, all employees who are 21 years of age or older are eligible to participate in the Plan after the completion of 3 consecutive months of employment. Prior to March 1, 2023, all employees who were 21 years of age or older were eligible to participate in the Plan after the completion of 12 consecutive months of employment and by completion of 1,000 hours of service. The entry date is the first day of each calendar month coinciding with or the following date after becoming eligible. Effective March 1, 2023, excluded employees include leased employees, interns, and certain part-time, temporary and seasonal employees.

Contributions: Participants may elect to contribute up to 90% of their annual compensation on a pre-tax or Roth post-tax basis up to a maximum of \$23,000 for 2024 and \$22,500 for 2023. Pre-tax contributions to a qualified plan are tax deferred and therefore, are not included in a participant's compensation for federal income tax purposes until distributed to the participant. Roth contributions are made post-tax but Roth distributions are tax-free. The maximum contribution is normally adjusted annually by an inflation index. Eligible participants aged 50 or older are permitted to make catch-up contributions. The maximum catch-up contributions were \$7,500 in 2024 and 2023.

Participants are allowed to rollover contributions from other qualified employer sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's directives.

Participants can make an In-Plan Roth Transfer, which allows a participant to transfer amounts from the vested portion of a pre-tax account to a Roth account. If a participant elects to make such a transfer, the amount transferred is included in income in the year the election is made. There were no In-Plan Roth Transfers in the Plan in 2024.

The Company may make discretionary matching contributions equal to a uniform percentage of the participants' salary deferrals. The discretionary employer matching contributions equal 100% of the employee salary deferrals, but not to exceed 4% of employee compensation for 2024.

Contributions (continued): The Plan also allows for discretionary profit-sharing contributions by the Company. The Company contributed employer matching contributions of \$305,142 to the Plan in 2024. No discretionary profit-sharing contributions were made in 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions and the employer's contribution, an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on the ratio of the participant's balance to all participants' account balances. Each participant directs how contributions made to the Plan are to be invested among the investment options available under the Plan.

Notes Receivable from Participants: The Plan allows participants to borrow an amount not to exceed the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The minimum loan amount is \$500. The loans are secured by the participant's vested balance and only one loan is permissible at a time. The term of the loan shall not exceed five years except in the case of a loan for purchasing the principal residence of the participant, in which case the loan may not exceed ten years. The loans bear interest at a rate of one percentage point above the prime rate as published in the Wall Street Journal, and interest remains fixed for the duration of the loan. The Plan had seven and six notes receivable from participant outstanding on December 31, 2024 and 2023, respectively, bearing interest ranging from 4.25%-9.50%.

Principal and interest are paid ratably through direct payroll deductions. Loans are considered in default if any scheduled repayment remains unpaid as of the last business day of the calendar quarter following the calendar quarter in which a loan is initially considered past due. In the event of default, death, disability or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. During the year ended December 31, 2024, no loans were deemed to be in default and there were no deemed distributions. One loan totaling \$7,977 was deemed to be in default during the year ended December 31, 2023.

In addition, notes receivable from participants are party-in-interest transactions.

Vesting: The value of each participant's account is fully vested and non-forfeitable at all times for participant contributions, rollover contributions and the interest and earnings on those funds. Each participant's non-forfeitable interest in the employer matching contributions and employer profit sharing contributions becomes fully vested at a rate of 25% per year and is fully vested after four years of service. Participants become fully vested in employer contributions upon attainment of age 65, the normal retirement age or upon death or total disability.

Distributions to Participants: Distributions from the Plan are available upon any of the following situations: termination of employment at the Company, retirement, total disability, death, employee's reaching age 59-1/2 or qualified "financial hardship." The Plan allows for mandatory distributions into individual retirement plan accounts designated by the Plan administrator for terminated participants with account balances below \$5,000 without consent of the participants.

Forfeitures: Forfeitures are created when participants terminate employment before they become fully vested. Forfeitures can be applied to pay administrative expenses payable under the Plan or to reduce employer contributions to the Plan. The unapplied forfeited non-vested accounts totaled \$7,197 and \$4,729 at December 31, 2024 and 2023, respectively. Forfeitures applied to reduce employer contributions were \$10,901 for the year ended December 31, 2024.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the modified cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under this method, investments are recorded at fair value, contributions are recorded when received, benefits and expenses are recorded when paid, and interest income and fees related to notes receivable from participants are recorded when received and paid.

Use of Estimates: The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Mutual funds are stated at fair value and the interest in common trusts are stated at net asset value per share. For more information on valuation methods and inputs, please refer to Note E - Fair Value Measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded when received. Net appreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan's investments are held in a trust administered by Reliance Trust Company as of December 31, 2024 and 2023.

Contributions: Contributions from Plan participants are recorded in the year in which the contributions are deposited in the Plan. Discretionary matching and profit-sharing contributions are recognized when the related funds are received by the Plan. All participant and employer contributions are participant directed.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make repayments and the Plan Administrator deems the notes receivable from participants to be in default, the notes receivable from participants' balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain administrative expenses are paid by the Plan, including loan setup and maintenance fees, which are deducted from participant accounts, if applicable. In addition, certain administrative expenses were applied to participants' investment returns, decreasing the net appreciation in value of investments for participants.

Subsequent Events: Accounting Standards Codification (ASC) 855-10 *Subsequent Events* requires additional disclosure for events or transactions that occur after the statement of net assets available for benefits date. The Plan had no significant subsequent events as of October 7, 2025, which is the date the financial statements were available to be issued.

NOTE C – INCOME TAX STATUS

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan sponsor believes that the Plan is designed, and is currently being operating, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE D – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their employer contributions.

NOTE E – FAIR VALUE MEASUREMENTS

ASC 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820-10 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds and money market funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E – FAIR VALUE MEASUREMENTS (CONTINUED)

Stable Value Collective Trust Fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily, the investor advisor reserves the right to require 10 days' notification of such transactions. Were the Plan to initiate a full withdrawal of the collective trust, the investment adviser reserves the right to require 24 months' notification to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
