NOTES TO FINANCIAL STATEMENTS

Years Ended December 31, 2024 and 2023

1 DESCRIPTION OF PLAN

The following description of the Anamet Electrical, Inc. (Employer) Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL -- The Plan is a defined contribution plan covering substantially all employees age 18 or older with ninety days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS -- Participants may elect to contribute, on a pre-tax or post-tax basis, up to the I.R.C. 402(g) limit (\$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively) of covered compensation. Participants age 50 or over may elect to make a catch-up contribution, on a pre-tax or post-tax basis, up to the I.R.C. 414(v) limit (\$7,500 for the years ended December 31, 2024 and 2023) of covered compensation. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions made on a pre-tax or post-tax basis are subject to certain maximum limitations as defined by the IRS.

Participants may elect to have all or any portion of his or her deferral contributions and catch-up contributions treated as designated Roth contributions. For the calendar year, the maximum amount of elective contributions that a participant can designate as Roth contributions equals the maximum amount of deferral contributions and catch-up contributions according to the I.R.C. limits above, reduced by the aggregate amount of the participant's deferral contributions and catch-up contributions for the calendar year that the participant does not designate as Roth contributions.

The Employer may make matching contributions to participants during the Plan year, and the Plan Administrator determines the dates the matching contribution is allocated. For the years ended December 31, 2024 and 2023, the Employer contributed an amount equal to 50% of participant contributions up to a maximum of 4% of compensation. Each year, the Employer may also, contribute an additional discretionary amount. The Employer did not make a discretionary contribution for the years ended December 31, 2024 and 2023.

PARTICIPANT ACCOUNTS -- Each participant's account is credited with the participant's contribution, the Employer's matching contribution, and an allocation of the discretionary profit-sharing contribution and fund earnings. Allocations are based upon covered compensation or account balances as defined in the Plan agreement.

Participants may transfer amounts between funds at any time during the year. The trustee reinvests the amounts to reflect these changes. At the end of the year, the investments are presented net of any transfers in process as directed by the participants.

VESTING -- All participant contributions and income thereon are fully vested at all times. Vesting of amounts related to Employer contributions is based on years of service. A participant is 20% vested after one year, 40% vested after two years, 60% vested after three years, 80% vested after four years, and 100% vested after completion of five years of service. Employer contributions and income thereon vest immediately in the case of death, permanent disability, normal retirement, attainment of age 65, or upon termination of the Plan.

1 DESCRIPTION OF PLAN (continued)

NOTES RECEIVABLE FROM PARTICIPANTS -- Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested plan account balance. The loans are secured by the balance in the participant's account and bear an interest rate of 4.25%-9.5%, which is a reasonable rate of interest based on the prevailing interest rates charged by persons in the business of lending money for loans under similar circumstances, as determined by the Plan administrator. Principal and interest is paid through payroll deductions. A loan set up fee of \$125 is charged to participants requesting loans. Participants are allowed one outstanding loan at a time.

PAYMENT OF BENEFITS -- Upon termination or retirement, a participant's account can be distributed in the form of a lump-sum payment or may be deferred until April 1 of the calendar year next following the later of the calendar year in which the participant attains age 70 1/2 or the calendar year in which the participant retires. An eligible rollover distribution is also permitted. If the value of a participant's account is less than \$5,000, a lump sum distribution will be made without regard to the consent of the participant as soon as administratively feasible.

FORFEITURES -- Forfeitures may be used to first pay the reasonable expenses of administering the Plan and then to reduce the Employer's contributions. Forfeitures amounted to \$30,185 and \$2,087 for the years ended December 31, 2024 and 2023, respectively. The amount of expenses paid with forfeitures was \$0 for the years ended December 31, 2024 and 2023. The amount of forfeitures applied to reduce the contributions of the Employer was \$30,215 and \$2,089 for the years ended December 31, 2024 and 2023, respectively. The forfeiture account balance was \$11 and \$10 at December 31, 2024 and 2023, respectively.

2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF PRESENTATION -- The accompanying financial statements of the Plan have been prepared on the accrual basis and present the net assets available for plan benefits and changes in those net assets, except for benefits, which are recorded when paid.

INVESTMENT VALUATION AND INCOME RECOGNITION -- The Plan's investments are stated at fair value (except for the fully benefit-responsive common collective trust at December 31, 2024 and 2023, which is reported at contract value). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investments held by an investment company are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets of an investment company attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the underlying defined-contribution plans.

ESTIMATES -- The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

3 FAIR VALUE MEASUREMENTS

The fair value measurement accounting standard establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures the fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and Level 3 inputs are used only when Level 1 inputs are not available.

Level 1 Fair Value Measurements - The fair value of registered investment company shares is based on quoted market prices which represent the net asset value of shares held by the Plan at year-end.

4 COLLECTIVE INVESTMENT TRUST

As of May 1, 2019, the Plan entered into an Agreement of Participation with Reliance Trust Company to invest in the Reliance Trust Company Stable Value Fund Collective Investment Trust MetLife Series 25053 Class 0. The stable value fund had a balance of \$940,162 and \$826,325 at December 31, 2024 and 2023, respectively. Contributions to the Fund are held in a general trust account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract provides for a fixed interest rate for a fixed period that will apply to the entire guaranteed value. The interest rate is reset every quarter as determined by MetLife.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Fund imposes certain restrictions on the Plan, and the Fund itself may be subject to circumstances that affect its ability to transact at contract value, as described in the following paragraph. The Plan Administrator does not believe that the occurrence of any such event, which would cause the fund to transact at less than contract value, is probable.

4 COLLECTIVE INVESTMENT TRUST (CONTINUED)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) Participants make withdrawal requests with advice or direction from the plan sponsor, plan administrator, plan fiduciary or agent of any of the foregoing to do so, (2) an investment option has been established by the participating plan or the investment objective of an existing investment option of the participating plan has been modified so as to constitute or create a competing fund, (3) The plan sponsor, plan administrator, plan fiduciary, or any agent of any of the preceding, of the participating plan establishes a new eligible plan or amends an existing eligible plan and such plan covers participants in the participating plan and offers participants a competing fund, and (4) participating plan makes a withdrawal for any reason, except for a participant-directed withdrawal.

5 INFORMATION CERTIFIED BY THE TRUSTEE

The Plan has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan has obtained certifications from its trustee, Reliance Trust Company, for 2024 and 2023, that all of the information provided by Reliance Trust Company is complete and accurate. The following information is included in the accompanying financial statements and was obtained from data that has been prepared and certified to as complete and accurate by Reliance Trust Company.

6 PLAN ADMINISTRATIVE EXPENSES

Certain administrative expenses of the Plan have been paid by the Plan sponsor for the years ended December 31, 2024 and 2023, respectively. The Plan did not pay administrative expenses for participant loan processing fees, which were charged to participants' accounts.

7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested.

8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9 TAX STATUS

The Internal Revenue Service has determined and informed the Plan's recordkeeper, in a letter dated October 6, 2020, that the volume submitter profit sharing plan document provided by the recordkeeper and adopted by the Plan is qualified under appropriate sections of the Internal Revenue Code. The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10 PARTY-IN-INTEREST TRANSACTIONS

ADP Retirement Services (a division of ADP, Inc.), recordkeeper, provided investment management services to the Plan which qualifies as party-in-interest transactions. Fees paid directly to the TPA by the Plan for these investment management services were \$17,727 and \$16,860 for the years ended December 31, 2024 and 2023, respectively. The Plan also transacts with certain other parties who may perform services to the Plan. Such parties qualify as parties-in-interest.
