To the Trustee and Plan Administrator of CMC Rescue, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of CMC Rescue, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the CMC Rescue, Inc. 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1: Description of Plan

The following description of the CMC Rescue, Inc. 401(k) Plan (the “Plan”) provides only summarized information. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan’s provisions.

General

CMC Rescue, Inc. (the “Employer”, “Company”, or “Plan Sponsor”) established the Plan effective January 1, 1994. The Plan is a defined contribution plan with 401(k) provisions for eligible employees of the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan has implemented certain requirements of the Coronavirus Aid, Relief, and Economic Security Act (the “CARES Act”) and the Setting Every Community UP for Retirement Enhancement Act of 2019 (the “SECURE Act”), which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for distributions, waive required minimum distributions for 2020 that were made after April 1, 2020, and increase the age requirement for required minimum distributions. All CARES Act provisions have expired and are no longer available to use. The Plan will be amended to reflect these operational changes at a future date in accordance with IRS requirements.

The Plan was restated effective April 5, 2022, and adopted a pre-approved defined contribution plan sponsored by ADP, LLC (“ADP”). All previous amendments were incorporated with the restated Plan.

Effective August 1, 2024, the Plan was amended to change the participant entry date from the first day of the quarter following 60 days of employment to the first day of the month following 60 days of employment.

Contributions

Participants may elect to contribute 1% to 90% of compensation up to a maximum of \$23,000 for the plan year. Total contributions to a participant’s account in a given plan year may not exceed the lesser of \$69,000 (\$76,500 including catch-up contributions) or 90% of the participants compensation for the plan year.

Individuals who are at least 50 years of age are permitted to make “catch up” contributions. The maximum catch-up contribution allowed for 2024 is \$7,500. The Plan does not allow Roth deferral contributions. Contributions are excludable from the participants taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan.

Contributions - continued

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elected not to participate. Automatically enrolled participants have their deferral rate set at 3% of their eligible compensation and their contributions are invested in designated balanced funds until changed by the participant.

Auto-enrollment provisions include annual deferral increases of 1% of eligible compensation, not to exceed 6%. The increase will be applied as of the period that begins after the period in which the initial deferral amount was withheld and will occur as of the beginning of each subsequent plan year.

Participants may change the amount of compensation they defer into the Plan, or stop making deferrals altogether, at any time. Participants may also contribute amounts representing rollovers from other qualified defined benefit and contribution plans, excluding Roth direct rollovers.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers one money market fund, and forty-eight mutual funds (including target date funds). Participants may change such allocation at any time directly with ADP (the "Plan Administrator") and may transfer the value of their account among the funds.

The Plan provides for the Company to make discretionary employer matching contributions and profit sharing contributions to eligible participants, in accordance with the guidelines outlined in the Plan document. During 2024, the Company elected to match contributions up to 25% of the employee deferral, up to a maximum of 1.5% of eligible compensation. The Company made \$86,186 of matching contributions and elected out of a discretionary profit sharing contribution for the year ended December 31, 2024.

Participant Accounts

Each participants account is credited with the participant's contribution and the Company discretionary employer contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Eligibility

Employees become eligible for the Plan when they have completed two months of service and are at least 21 years old. The entry date to the Plan is the first day of the month coinciding with or next following the date of eligibility for the Plan participant.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the matching contributions, plus earnings thereon, is based on a three-year graded schedule with at least 1,000 hours of service during a vesting computation period to receive a credit for a year of service.

Participants also become fully vested in employer elective contributions if employed by the Plan Sponsor upon reaching normal retirement age, which is defined as age 65, or in the event of death or total and permanent disability.

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a single, lump-sum payment equal to the value of his or her vested account balance, substantially equal installment payments, or direct rollover distribution. Amounts contributed through salary/wage reductions can be withdrawn at any time. Upon proof, to the satisfaction of the Plan Administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties apply to withdrawals or distributions prior to age 59 ½.

Participants with vested account balances less than \$5,000 will be automatically distributed as soon as administratively feasible following termination of employment whether or not the participant has reached normal retirement age.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to the maximum of the lesser of \$50,000, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.5% (calculated at prime plus 1%), which are commensurate with local prevailing rates as determined by the Plan Administrator. Loan terms shall not exceed 5 years, except in the case of a loan for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions. There may be no more than one loan outstanding per participant at any time.

Forfeitures

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents forfeiture. Forfeitures can be utilized to pay administrative expenses or to reduce employer contributions. As of December 31, 2024, forfeited non-vested accounts totaled \$11. During the year ended December 31, 2024, \$15,174 of forfeitures was used to reduce employer contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting, which is in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results will differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

No allowance for credit losses has been recorded as of December 31, 2024. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Investment Valuation and Income Recognition

Investments held by the Plan at year-end are stated at market value based on quoted market prices. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. See Note 3 for discussion of fair value. Receivables are valued at amortized cost. The net unrealized appreciation in the market value of investments is included in investment income. The net unrealized depreciation in the market value of investments is included in deductions.

Payment of Benefits

Benefits are recorded as deductions when paid.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements.

Fees related to the administration of notes receivable from participants are charged directly to the participants account and are included in administrative expenses. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation/depreciation of fair value of investments.

Note 3: Fair Value Measurements of Investments

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement* defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

ASC 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

Level 1 - Quoted prices in active markets that are unadjusted and accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices for identical assets and liabilities in markets that are not active, quoted prices for similar assets and liabilities in active markets or financial instruments for which significant inputs are observable, either directly or indirectly; and

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Investment Information

Investments consist of mutual funds and participant loans. Investments are held by the Trustee, Reliance Trust Company.

During 2024, the Plan's investments (including investments bought, sold, and held during the year and unrealized gains and losses) increased in value as determined by quoted market prices by \$552,973.

Note 5: Termination of Plan

Although the Plan Sponsor has not expressed any intent to do so, it reserves the right to terminate the Plan at any time subject to the provisions of ERISA. Upon termination, all amounts credited to a participant's account become 100% vested.

Note 6: Certification of Investment Information by Custodian

The following is a summary of the Plan's financial information and data certified by Reliance Trust Company, the third-party Trustee of the Plan, as complete and accurate in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 7: Income Tax Status

On October 6, 2020, the Internal Revenue Service determined and informed the Plan Sponsor that the Plan and related trust, were designed in accordance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan has been amended and restated since receiving the determination letter.

The Plan Administrator and the Plan’s tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, the Plan qualifies under Section 401(k) and the related trust is tax-exempt.

The Plan is subject to routine audits by taxing authorities; however, there are currently no audits of any tax periods in progress.

Note 8: Risks and Uncertainties

The Plan invests in various investments securities. Investment securities are exposed to various risks, such as interest rate risk, credit risk, economic changes, political unrest, geopolitical instability and regulatory changes. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants’ account balances and the amounts reported in the financial statements.

Note 9: Parties-In-Interest

Officers and board members of the Plan Sponsor are participants in the Plan. The members qualify as parties-in-interest.

Certain plan investments are shares of funds managed by ADP. ADP is the recordkeeper as defined by the Plan, and therefore qualifies as a party-in-interest. ADP provides certain administrative services to the Plan and receives indirect revenue from a mutual fund service provider.

The Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest.

Fees paid during the year for legal, accounting, and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 10: Subsequent Events

Effective August 1, 2025, the Plan was amended to change the vesting schedule for Employer Nonelective contributions and Employer matching contributions from fully vested at 6 years of employment after eligible to fully vested in 3 years of employment after eligible.

The Plan has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued.
