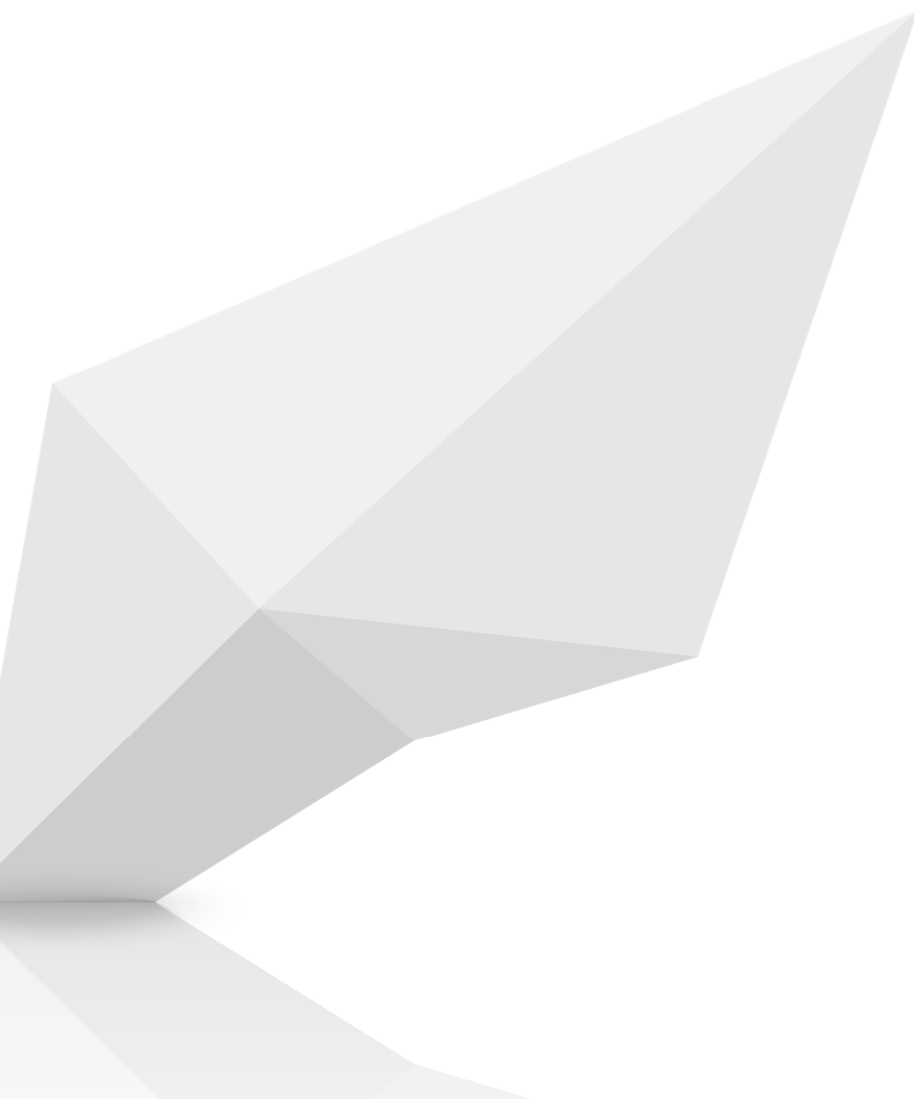

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Cirrus Design Corporation 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was adopted with an effective date of January 1, 1994.

General

The Plan is a defined contribution plan covering all employees of Cirrus Design Corporation and Subsidiaries (the "Company"). Eligible employees include all employees who are in a covered employment classification and have attained age 18. Employees who have completed three months of service as defined in the Plan are eligible to receive the Company contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In December 2022, Setting Every Community Up for Retirement Enhancement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Plan management will determine the optional provisions to elect in the future.

Contributions

Each year, participants may contribute an amount of compensation, as defined in the Plan, on a pretax or roth basis up to the maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan includes an automatic enrollment provision whereby all newly eligible employees are enrolled in the Plan at a 5% pre-tax deferral rate unless a different election is made. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes safe harbor matching contributions. The safe harbor matching contributions are 100% of the first 5% of eligible compensation that an employee contributes. The Company made safe harbor matching contributions of \$8,324,619 for the year ended December 31, 2024. Additional nonelective contributions may be made at the Company's discretion. For the Plan year ended December 31, 2024, the Company did not make any additional discretionary contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, Company safe harbor matching contributions, and allocations of (a) the Plan's nonelective contribution, and (b) Plan earnings and losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their contributions, in Company safe harbor matching contributions, and the earnings thereon. Vesting in the Company's discretionary nonelective contribution portion of their accounts plus actual earnings is determined on a graded vesting schedule based on years of service, and are credited with 20% each year. A participant is 100% vested after five years of credited service.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,356 and \$13,509, respectively. These amounts may be used to reduce Company contributions or to pay administrative expenses in accordance with the Plan document. During the year ended December 31, 2024, forfeitures of \$1,682 were used to reduce Company contributions.

Payment of Benefits

On termination of service for any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the vested portion of the participant's account does not exceed \$7,000 (\$5,000 prior to January 1, 2024), the account balance may be paid out in a lump sum, rolled into an IRA or another qualified plan, or any combination of these as requested by the participant. However, when a request is not received, accounts with balances less than \$1,000 will be automatically distributed in a lump sum. If the vested portion of the participant's account exceeds \$7,000, the distribution will be made after the participant or beneficiary gives consent. The Plan allows hardship withdrawals from elective deferral accounts, provided certain conditions are met. In-service distributions are allowed for participants upon attaining age 59 1/2.

Notes Receivable From Participants

Participants may borrow amounts from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participants' account and bear interest at rates ranging from 4.25% to 9.50% at December 31, 2024, which are commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company, unless otherwise paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in total investment income.

Subsequent Events

The Plan has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by the Custodians

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest on notes receivable from participants, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the Custodians of the Plan.

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Note 4: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self Directed Accounts - Common stocks and mutual funds: Primarily valued at the closing price reported on the active market on which the individual securities are traded.

Collective investment trusts (except MetLife Stable Value Fund): Fair value is estimated using NAV as a practical expedient. The NAV is determined using the estimated fair value of the underlying assets held by the fund less its liabilities. The NAV is not a publicly quoted price on an active market. The collective investment trusts invest in publicly quoted mutual funds, separate accounts and other collective investment trusts.

Collective investment trust – MetLife Stable Value Fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require a 60 day notification in order to ensure that securities' liquidations will be carried out in an orderly business matter.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All the Plan's Collective Trust Funds are invested in the BlackRock LifePath Index Retirement Funds. These funds seek to invest in broadly diversified global asset classes and are designed to take an appropriate level of risk to balance longevity risk and inflation risk.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 % vested in their discretionary nonelective accounts.

Note 6: Tax Status

The Company adopted a nonstandardized pre-approved plan document with an IRS opinion letter, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Party-in-Interest Transactions

Certain Plan investments are managed by Empower Trust Company, LLC and Empower Annuity Insurance Company (the Custodians). These transactions qualify as party-in-interest transactions. Fees paid to the Custodians for administration for the year ended December 31, 2024, are recorded in administrative expenses.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
