Note 1. Description of Plan

The following description of Andrus Transportation Services Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for more complete descriptions of Plan provisions.

General

The Plan is a participant-directed, defined contribution Plan covering all employees of Andrus Transportation Services Inc. (“Company”) who have completed one year of credited service and are 21 years of age or older. The Plan allows for enrollment upon attainment of the service and age requirements. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Company is the Plan’s sponsor and serves as Plan administrator.

Contributions

Participation in the Plan is voluntary. Participants may elect to contribute up to the maximum allowable under current Internal Revenue Service limits to the Plan each year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution Plans. Additional amounts may be contributed at the option of the Company’s board of directors based on the Company’s profits. All participants receive an equal share of the Company’s contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company’s contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant becomes fully vested in Company contributions after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest rates equal to the prime rate plus 2%. Principal and interest are paid ratably through regular payroll deductions over a period not to exceed five years, unless it is for the acquisition of a primary residence. For the years ended December 31, 2024 and 2023, ending loan balances were \$202,116 and \$185,564, respectively.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested account balance. If the present value of the participant's accrued benefit exceeds \$5,000 then a participant can receive their benefits in monthly, quarterly, semiannual or annual installments over a fixed reasonable period not to exceed the life expectancy of the participant or the joint life and last survivor expectancy of the participant and his beneficiary. Hardship distributions may be made from the participant's elective deferral account.

Benefits are recorded when paid. For the years ended December 31, 2024 and 2023, the Plan distributed \$1,098,422 and \$616,620 respectively to participants.

Forfeitures

Forfeitures are the non-vested portion of a participant's account that is lost upon termination of employment. Forfeitures may be used to reduce the Company's contribution. A total of \$0 and \$54,360 of forfeitures were used to reduce employer contributions for the year ended December 31, 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value (see Note 4). The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1:** Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets, or liabilities.
- Level 2:** Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3:** Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the exit price) in an orderly transaction between market participants at the measurement date.

Investments are stated at fair value. Shares of mutual funds are valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted market price in an active market and is classified within Level 1 of the valuation hierarchy. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the use of estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Plan Termination

Although it has not expressed any intent to do so, and notwithstanding any other provision of the Plan to the contrary, upon the date of either full or partial termination of the Plan, or, if applicable, upon the date of complete discontinuance of profit sharing Plan contributions to the Plan, an affected participant's right to his accrued benefit shall be 100 percent vested.

Plan Expenses

During 2024 and 2023, administrative expenses of the Plan paid through Plan assets totaled \$31,332 and \$30,841 respectively. Audit fees were absorbed by the Plan sponsor.

Subsequent Events

The Plan management and administration have reviewed the subsequent events through October 7, 2025, the date of issuance of the financial statements and noted no significant events.

Note 3. Party-in Interest Transactions

The Plan employs Automatic Data Processing, Inc. (ADP) as an investment advisor of the Plan's investments which qualifies Automatic Data Processing, Inc. (ADP) as a party-in interest. Fees paid by the Plan for the administrative services during 2024 and 2023 were \$9,321 and \$10,115.

The plan employs HintonBurdick, PLLC as independent auditors in the annual audit of the Plans financial statements which qualifies HintonBurdick, PLLC as a party-in interest. As mentioned in Note 2, plan audit fees have been absorbed by the Sponsor.
