Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Bill Gray's, Inc. 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Bill Gray's, Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules of Delinquent Participant Contributions at End of Year - December 31, 2024 and Assets Held for Investment Purposes at End of Year – December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

DECEMBER 31, 2024 AND 2023

NOTE A: DESCRIPTION OF THE PLAN

The following description of the Bill Gray's, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement, including amendments, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established for all employees of Bill Gray's, Inc. (the "Company"). Bill Gray's and Tom Wahl's are operating divisions of the Company. Hegedorn's was an operating division of the Company through December 2013, at which time it was sold to a related party. Hegedorn's employees continued to be plan participants subsequent to the sale of the division. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management of Hegedorn's determined to close the business, which ceased operations in June 2023. The total net assets available for benefits for former Hegedorn's participants is \$465,731 as of December 31, 2024. Participants are able to remain in the Plan once terminated from employment.

Participation requirements

Under the provisions of the Plan, all employees of the Company who are 21 years of age and have completed one year of service, with at least 1,000 hours of service during such period, are eligible to participate in the Plan. During 2017, an amendment was signed allowing automatic enrollment of qualified participants beginning January 1, 2018. The participant's pre-tax contribution will be equal to 2% of compensation, and that amount will increase by 1% each plan year until the amount contributed reaches 6% of compensation, unless otherwise elected by the participant.

Each year, participants may contribute up to 90%, subject to the Internal Revenue Code limitations, of their pre-tax annual compensation, as defined in the Plan. The Company makes a discretionary matching contribution equal to 50% of each participant's contribution, with the maximum annual contribution equivalent to 3% of each participant's annual salary. Participants may be permitted to deposit or "roll over" into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participant accounts

The Plan Administrator deposits contributions with the trustee, Reliance Trust Company, for the year ended December 31, 2024 and Empower Annuity Insurance Company and Prudential Bank & Trust, F.S.B. through February 1, 2023, and Reliance Trust Company for the remainder of the year ended December 31, 2023. Each participant's account is then credited based on the individual's elected deferral and fund allocation percentages. Investment income (loss) and administrative expenses of the Plan are allocated to participant accounts on a pro-rata basis. There were no amounts allocated to accounts of participants who have elected to withdraw from the Plan at December 31, 2024 and 2023 but have not yet been paid. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options

Plan participants may direct the investment of their funds into various investment funds provided by the Plan. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

Vesting

Participants are immediately vested in both participant deferral and Company matching contributions.

Payment of benefits

Funds may be withdrawn by participants under circumstances of retirement, death, disability, or termination of employment. The Plan allows participants who have attained the age of 59 ½ and are still employed by the Company to obtain distributions from their vested accounts. If the participant's vested account balance exceeds \$5,000, the participant may defer the payment of the benefits until attaining the age of 73. A participant terminating employment because of permanent disability is deemed to have retired as of their normal retirement date. In addition, hardship withdrawals are available under the Plan, subject to certain early withdrawal penalties. Other withdrawals may be subject to restrictions as defined in the Plan.

Notes receivable from participants

The Plan provides for participant loans. In general, participants may borrow up to half of their vested account balances, but not more than \$50,000 and not less than \$1,000. Other restrictions may also apply. Participant loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%, determined monthly (effective rate of 8.50% at December 31, 2024). Loans generally have terms of five years or less; however, loans for purchasing a primary residence can have a maximum term equal to 360 months. Principal and interest payments on the loans are redeposited into the participants' accounts based on their current investment allocation elections.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with U.S. GAAP.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note F for further discussion of fair value measurements. Participant loans are valued at their unpaid principal balance plus any accrued but unpaid interest.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Purchases and sales of investments are recorded on a trade date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in net appreciation in fair value of investments.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment recorded.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits. These expenses are party-in-interest transactions.

Plan termination

Although it has not expressed any intention to do so, the Company may terminate the Plan at any time by delivering to the trustee a written notice of termination, subject to the provisions of ERISA.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through August 22, 2025, which is the date the financial statements are available to be issued. No subsequent events requiring disclosure were noted.

NOTE D: TAX STATUS

The Internal Revenue Service has determined by a letter dated October 6, 2020, that the non-standardized pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE F: FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices which are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE F: FAIR VALUE MEASUREMENTS, Cont'd

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are actively traded open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to report their daily net asset value and transact at that price.

Common/collective trust: Valued at the net asset value ("NAV") of units of common/collective trust held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the contract value of the underlying investments comprising the trust less its liabilities. The common/collective trust generally permits redemptions daily. There are no unfunded commitments at December 31, 2024 or 2023. If the funds experience periods of insufficient liquidity then the common/collective trust may defer honoring any payment request until liquidity is sufficient. In the case of a plan-level liquidation, these require a twelve month advance written notice.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The common/collective trust is measured at fair value using the net asset value per share (or its equivalent) practical expedient and has not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to amounts presented in the statements of net assets available for benefits.

NOTE G: PARTY-IN-INTEREST TRANSACTIONS

Since Empower Annuity Insurance Company, Prudential Bank & Trust, F.S.B., ADP Retirement Systems, and Reliance Trust Company perform services for the plan, investments sponsored by related organizations are considered party-in-interest transactions, which are exempt from prohibited transaction rules. As described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA.

NOTE H: LATE REMITTANCES

As required by DOL Regulation 2510.3-102, the Company is required to segregate employee contributions to the Plan from its general assets as soon as practicable.

For the year ended December 31, 2021, the Company failed to remit certain employee deferrals and loan repayments to the Plan in a timely manner according to DOL regulations. During 2021, the Company made two untimely remittances to the Plan, which totaled \$24,901. The majority of these contributions were subsequently remitted to the Plan during 2022 along with lost earnings. The remaining \$232 that has not been remitted as of December 31, 2024 will be remitted during 2025, along with a Company contribution to the Plan to compensate the participants for lost earnings relating to this prohibited transaction.
