## Notes to Financial Statements

December 31, 2024 and 2023

### **1. Plan Description**

The following description of the Colt Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Colt's Manufacturing Company LLC (the Company and Plan Sponsor), a wholly-owned subsidiary of Colt CZ Group North America, who have completed at least one calendar month of continuous service, as defined by the Plan, and attained the age of 21. The Company was previously a wholly-owned subsidiary of Colt Defense LLC. Participants may contribute rollovers to the Plan from previous qualified benefit plans. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective March 1, 2024, the CZ-USA 401(k) Retirement Plan was merged into the Plan.

#### **Contributions**

Each year, participants may contribute a percentage of their annual compensation as defined in the Plan. In accordance with the Internal Revenue Code, participant contributions cannot exceed \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively, with the exception of certain allowable catch-up contributions up to \$7,500 in 2024 and 2023 for participants over the age of 50.

Effective February 1, 2009, the Plan was amended to allow for a discretionary employer matching contribution for participants (excluding Bargaining Unit employees, see below) of 50% of the participants' elective deferral up to the first 6% of eligible compensation, as defined by the Plan. Effective January 1, 2023, the Company amended the Plan to allow for Roth elective deferrals and increased the discretionary employer matching contribution to 100% of the participants' elective deferral up to the first 6% of eligible compensation, as defined by the Plan.

In connection with the renewal of the Company's collective bargaining agreement in 2012, the Company elected to freeze future benefit accruals under the Company's Bargaining Unit Employees' Pension Plan (the Pension Plan) effective December 31, 2012. In conjunction with freezing the Pension Plan, Bargaining Unit employees hired after April 1, 2012, became eligible for an employer matching contribution in the Plan in the amount of 100% of the participants' elective deferral up to the first 3% of eligible compensation, as defined by the Plan, as they were not able to become participants in the Pension Plan. All other Bargaining Unit employees became eligible for the employer match (100% of the participants' elective deferral up to the first 3% of eligible compensation) in the Plan effective January 1, 2013.

**1. Plan Description (continued)**

**Contributions (continued)**

For the year ended December 31, 2024, the Plan recorded a receivable for \$8,626 in corrective contributions and related earnings in accordance with the necessary compliance requirements to employees whose employer match amounts were not appropriately contributed. There were no corrective contributions required for the year ended December 31, 2023.

**Participant Accounts**

Each participant's account is credited with (1) the participant's contribution and allocations of (2) the Company's contributions, if any, and (3) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions and offset administrative expenses of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants who are eligible to participate in the Plan as of January 1, 2009, will be 100% vested in all Company discretionary matching contributions and earnings thereon. Participants who become eligible to participate in the Plan after January 1, 2009, vest in Company discretionary matching contributions and earnings thereon based on years of continuous service as follows:

**Forfeitures**

Upon a participant's separation from service, nonvested contributions are forfeited by the participant. Forfeitures may be used to offset employer contributions and administrative expenses.

As of December 31, 2024 and 2023, there were unallocated forfeitures of \$60,172 and \$5,962, respectively, and related earnings thereon of \$1,327 and \$174, respectively. Forfeitures totaled \$104,611 and \$19,656 for the years ended December 31, 2024 and 2023, respectively. The Company used \$50,575 and \$27,044 in forfeitures to reduce employer contributions for the years ended December 31, 2024 and 2023, respectively.

## Colt Retirement Savings Plan Notes to Financial Statements (continued)

### **1. Plan Description (continued)**

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. At December 31, 2024, the interest rates on outstanding loans ranged from 4.25% to 9.5%. Principal and interest is paid ratably through monthly payroll deductions. Interest income on participant loans was \$55,208 and \$38,000 for the years ended December 31, 2024 and 2023, respectively.

#### **Investment Options**

All investment programs are fully participant directed. Participants may direct the investment of their contributions and the Company's discretionary matching contribution, if any, into any of the Plan's available investment options.

#### **Payment of Benefits**

The normal retirement age used is age 65. On termination of service, a participant may receive a lump-sum amount equal to the vested value of his or her account, or upon death, disability or retirement, elect to receive annual installments over a period not to exceed the participant's life expectancy. In-service distributions are permitted after age 59 ½. Hardship distributions are also allowed for Plan participants.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

#### **Administrative Expenses**

Professional and administrative fees of the Plan are paid by the Plan sponsor. Investment related expenses are paid out of Plan assets and are allocated to participant accounts.

#### **Plan Transfers**

In March 2024, the Company merged the employees of the CZ-USA 401(k) Retirement Plan into the Plan. For the year ended December 31, 2024, total transfers into the Plan were \$3,959,191.

### 2. Significant Accounting Policies

#### **Basis of Presentation**

The Plan's financial statements have been prepared using the accrual basis of accounting in accordance with U.S. Generally Accepted Accounting Principles (U.S. GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan provides for various investment options in a money market fund, mutual funds, and in a stable value fund. The investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. The money market fund is recorded at fair value using quoted market prices. Shares of mutual funds are also valued at quoted market prices.

The Plan's investment in the stable value fund is measured using the Net Asset Value (NAV) per share of the investment as a practical expedient as permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement and Disclosures*.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of realized and unrealized gains (losses).

#### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Fair Value of Financial Instruments**

The Plan follows ASC 820 for all financial assets and nonfinancial assets that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements.

ASC 820 defines fair value as the price that would be received upon sale of an asset or paid upon the transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability.

The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity. In addition, the fair value of liabilities should include consideration of non-performance risk including the Plan's own credit risk.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy prioritizes the inputs into three levels based on the extent to which inputs used in measuring the fair value are observable in the market.

Each fair value measurement is reported in one of the three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety.

These levels are:

Level 1 – Inputs are based upon unadjusted quoted prices for identical instruments traded in active markets.

Level 2 – Inputs are based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. The fair values are therefore determined using model-based techniques that include option pricing models, discounted cash flow models, and similar techniques.

**5. Income Tax Status**

The Plan obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Section 3(14) of ERISA defines party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and interest, and transactions with investment funds managed and held by the trustees (if any) are considered party-in-interest transactions.

Fees paid by the Plan for investment management, recordkeeping and other operating expenses are with the trustee and considered permitted party-in-interest transactions. Investment management fees are netted against net appreciation (depreciation) in fair value of investments for the Plan.
