## INDEPENDENT AUDITORS' REPORT

To the Financial Committee

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of West Side Tractor Sales Co. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits - modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of West Side Tractor Sales Co. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of West Side Tractor Co. Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

**NOTE 1 - PLAN DESCRIPTION:**

The following brief description of West Side Tractor Sales Co. Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined-contribution plan covering employees of West Side Tractor Sales Co. and RCE Equipment Solutions, Inc. (the “Company”) that have completed three months of eligible service and are age 21 years or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute as pretax or ROTH up to 100% of compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes matching contributions of 50% of elective deferrals not exceeding 50% of the first \$1,500 of employee contributions. Participants age 50 and over are also allowed to make “catch up” contributions. Additional amounts may be contributed by the Company at the option of the Company’s Board of Directors. The Company did not make any employer match contributions to union employees for the Plan year ended December 31, 2024, as set forth in the collective bargaining agreement currently in effect, although union employees may contribute a percentage of their compensation as salary deferrals. Employees are auto enrolled into the plan on the first of the month after three months of employment. Auto enrollment begins at 3% pre-tax deferral with annual auto increases of 1%.

Participants’ Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s matching contribution and Plan earnings and charged with an allocation of any administrative expenses. Earnings are allocated by fund based on the ratio of a participant’s account invested in a particular fund to all participants’ investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. Upon death or disability, a participant’s account becomes fully vested.

**NOTE 1 - PLAN DESCRIPTION (CONT'D):**

Payment of Benefits

Upon termination of service, a participant may elect to receive their vested account in either a lump sum or annual installments beginning not earlier than age 60 over a period as defined in the Plan. Upon death or disability, a participant's benefits will be paid in either a lump sum or annual installments over a period as defined in the Plan, at the discretion of the participant, or if applicable, the beneficiary. Hardship withdrawals follow IRS safe harbor rules.

Forfeitures

Forfeitures are used to pay administrative expenses. Any remaining forfeitures are allocated in the same proportion that a participant's compensation bears to the total compensation of all participants. In 2024, \$39,039 of employer contributions were paid from forfeited non-vested accounts. At December 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$3,933 and \$450, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Interest is payable at 1% plus the federal prime rate in effect on the date of the loan. Principal and interest is repaid ratably through regular payroll deductions.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES:**

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis of accounting. Under that basis, certain revenues and the related assets are recognized when received rather than when earned and certain expenses are recognized when paid rather than when the obligation is incurred. That basis differs from generally accepted accounting principles primarily because the Plan has not recognized accrual for receivable for the employer matching contributions due as of the end of the plan year.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONT'D):**

Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of additions and deductions during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date and interest income is recorded on a cash basis. Realized gains and losses are calculated as the difference between the proceeds from sales and the related investment's fair market value at the beginning of the plan year, or acquisition cost if acquired during the year. Unrealized appreciation and depreciation is calculated as the difference between the fair value of investments at the end of the year less their fair value at the beginning of the year, or acquisition cost, if acquired during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's recordkeeping fees are paid by the Plan. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are charged directly to the participant's account. The balance of all other administrative expenses of the Plan are paid by the Company.

**NOTE 3 - FAIR VALUE MEASUREMENTS:**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan and as reported by the fund. The mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market funds held by the Plan are considered to be actively traded.

Investment measured at net asset value

The investment measured at the net asset value (NAV) represents units in the Invesco ADP Stable Asset Fund which is a stable value collective trust fund that invests in investment contracts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations would be carried out in an orderly business manner. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**NOTE 4 - INVESTMENTS:**

The December 31, 2024 and December 31, 2023 Statements of Net Assets Available for Benefits - Modified Cash Basis, the investment activities included on the Statement of Changes in Net Assets Available for Benefits - Modified Cash Basis for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Reliance Trust Company, the custodian, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total assets at \$40,389,050 at December 31, 2024 and \$33,406,708 at December 31, 2023 and related income of \$6,986,361 for the year ended December 31, 2024.

**NOTE 5 - RELATED PARTY TRANSACTIONS:**

The Plan conducts transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. These parties include investment advisory, custodian, recordkeeping, and accounting services. The Plan issues loans to participants, which are secured by the balances in the participants' accounts. In addition, the Plan also invests in shares of mutual funds that are managed by the Plan trustee. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transactions rules of ERISA.

**NOTE 6 - PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants become fully vested in their accounts.

**NOTE 7 - INCOME TAX STATUS:**

The Internal Revenue Service (IRS) has determined and informed the Company by letter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has obtained a favorable tax opinion letter from the IRS dated June 30, 2020. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

**NOTE 8 - RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the Statement of Net Assets Available for Benefits - Modified Cash Basis.
