SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We have performed audits of the accompanying financial statements of SoDel Concepts II, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE A - DESCRIPTION OF PLAN

The following description of The SoDel Concepts II, LLC 401(k) Plan provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provision.

General - The Plan is a defined contribution plan covering all employees of SoDel Concepts II, LLC (the Company) who are twenty-one or older and have been credited with 1,000 hours of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to 90% of eligible compensation, as defined in the Plan or such dollar limit established by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions and Company matching contributions into various investment options offered by the Plan. The Company makes a safe harbor match in the amount of 100% up to 3% of the participants' eligible compensation and 50% of the amount of the employee contributions that exceed 3% of eligible compensation but that do not exceed 5% of eligible compensation.

Rollover Contributions - The Plan provides for rollover contributions, which represent contributions by participants from other tax qualified retirement plans. The maximum amount of a participant's rollover contribution is not affected by the limits otherwise applicable to participants' contributions.

Participant Accounts - Each participant's account is credited with the participant's contribution, rollover contributions, the Company's safe harbor contribution and an allocation of Plan earnings and expenses. Investment earnings are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their accounts among available investment options.

Vesting - Participants are vested immediately in their contributions and the Company's safe harbor contributions plus actual earnings or losses thereon.

Notes Receivable From Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants cannot have more than one loan outstanding. The notes are secured by the balance in the participant's account and bear a fixed rate of interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates at the time the note is originated. All notes must have a definite repayment schedule, which provides for principal and interest payments to be made ratably through payroll deductions over a period not to exceed five years, except for home loans that may be repaid over a reasonable period of time that may exceed five years.

Payment Of Benefits - On termination of service due to death, disability or retirement, a participant may receive a lump sum amount equal to 100% of account values. Under specific situations of financial hardship, a participant or beneficiary may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Balances less than \$5,000 may be paid in lump-sum distributions, without requiring participant approval.

Forfeited Accounts - Forfeitures can be used to reduce future employer contributions and pay certain Plan expenses. During 2024 and 2023, the Plan sponsor utilized \$606 and \$12,934 of forfeitures during December 31, 2024 and 2023, respectively, the balance of unallocated forfeited non-vested accounts totaled approximately \$6,219 and \$5,920, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis Of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation And Income Recognition - Investments in registered investment companies are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for uncollectible participant notes has been recorded as of December 31, 2024 and 2023.

Payment Of Benefits - Benefits are recorded when paid.

Plan Expenses - Plan expenses may be paid by the employer, outside of the Plan.

Use Of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events - The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through October 13, 2025, the date the financial statements were available to be issued.

NOTE C - CERTIFIED ASSETS

Reliance Trust Company, the current trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) as of December 31, 2024, and its related investment activity reported in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan applies generally accepted accounting principles to establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

- Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 - inputs to the valuation methodology include quoted prices for identical or similar assets and liabilities in active or inactive markets; inputs that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Registered Investment Companies (Mutual Funds) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E - RELATED PARTY TRANSACTIONS

ADP Retirement Services (ADP) provides participant recordkeeping services to the Plan, which qualifies as a party-in-interest. Fees paid by the Plan for these services were \$3,080 and \$2,820 for the Plan years ended December 31, 2024 and 2023, respectively.

Certain participants of the Plan have outstanding loans with the Plan at December 31, 2024 and 2023. These loans are considered party-in-interest transactions according to Department of Labor guidelines. Total outstanding loans were \$104,514 and \$55,643 as of December 31, 2024 and 2023, respectively.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE G - TAX STATUS

The Plan has adopted a non-standardized Prototype Profit Sharing Plan with CODA which received a favorable opinion letter from the Internal Revenue Service dated October 6, 2020 in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to unrelated business income tax.

NOTE H - RISK AND UNCERTAINTIES

The Plan invests in registered investment companies. These securities are exposed to various risk such as interest rates, market and credit. Due to the level of risk associated with these securities and the level of uncertainty related to changes in the value, it is at least reasonably possible that changes in the various risk factors will occur in the near term that could materially affect the amounts reported in the accompanying financial statements.
